This center — which has been given an international remit — concentrates all of Rhodia's know-how around high-performance engineering plastics, from initial research on polymers to the design of plastic components using the most advanced virtual simulation tools.

The innovations derived from this center will find applications in a wide range of industries and markets: transport, electricity and electronics, construction and consumer goods. They will provide solutions to the technical, economic and environmental issues facing our customers, such as the reduction of CO<sub>2</sub> emissions in motor vehicles, thermal insulation in High Environmental Quality buildings, or the recycling of composite materials.
