

Consolidated revenue advances 3.2% at constant exchange rates in H1 2010, confirming revenue recovery for the period

- First-quarter trend is confirmed in Q2. Transport revenue growth accelerates; Q2 logistics revenue returns to 2009 level.
- Profitability improves; balance sheet remains healthy.
- Norbert Dentressangle continues to closely monitor its customers' growth trend.

In H1 2010, Norbert Dentressangle's consolidated revenue totalled €1.4 billion, up 3.9% on a published basis and up 3.2% at constant exchange rates. The performance marked a sequential acceleration over Q1 2010 revenue, which increased 2.3% on a published basis and grew 1.7% at constant exchange rates.

Transport revenue came to €821 million, advancing 7.3% on a published basis and increasing 6.8% at constant exchange rates in the first half, building on growth achieved in Q1 2010, when transport revenue was up 6.8% on a published basis and up 6.4% at constant exchange rates.

In H1 2010, logistics revenue amounted to €600 million, down 2.2% at constant exchange rates, compared with a decline of 3.8% in Q1 2010, but matching the revenue level attained in Q2 2009.

Lastly, the freight forwarding activity, launched at the beginning of the year, grew in accordance with expectations and generated €2 million in revenue.

Against this backdrop, Norbert Dentressangle continued to improve its profitability in the first two quarters of the year, and the group will present a healthy balance sheet for the first half of 2010.

At the same time, Norbert Dentressangle continues to closely monitor its customers' growth momentum and remains focused on reducing its cost structure.
