

## State of Virginia Regional Extension Center Selects Pulse Complete EHR

Doctors across Virginia will also be able to take advantage of Pulse’s guarantee that ensures eligible providers meet EHR certification requirements for Meaningful Use and maximize their ability to receive 2011 reimbursement funds authorized by the HITECH Act. “I am confident that our partnership with Pulse will help Virginia primary care providers make meaningful use of electronic health records to improve patient care and health quality,” said VHQC President and CEO Donald A.
