BOARD OF DIRECTORS APPOINTS A NEW DIRECTOR AND WILL RECOMMEND TO 19TH MAY SHAREHOLDERS' GENERAL MEETING THE DISTRIBUTION OF THE 2010 DIVIDEND IN CASH OR SHARES

On 17 March 2011 the Board of Directors of SUEZ ENVIRONNEMENT approved the resolutions that will be submitted to the Shareholders' General Meeting on 19 May 2011.

On the proposal of GDF SUEZ, the Board of Directors appointed Penny Chalmers, currently Head of Strategy and Communications of International Power, to replace Dirk Beeuwsaert.

This appointment will be submitted to ratification at of the next SUEZ ENVIRONNEMENT General meeting, as well as the renewal of directors' mandates for Nicolas Bazire, Valérie Bernis, Jean-Francois Cirelli, Lorenz d'Este, Gérard Lamarche and Olivier Pirotte.

The Board will also propose to the Shareholders' General meeting the option of distributing the 2010 dividend of €0.65 per share, in cash or in the form of SUEZ ENVIRONNEMENT shares.

The issue price of each new share will be 90% of the average price of SUEZ ENVIRONNEMENT shares listed on Euronext Paris over the 20 trading days immediately preceding the General meeting, less the net amount of the dividend. These shares will confer entitlement on 1 January 2011.

The dividend will be detached from the share on 24 May 2011. The period during which shareholders can opt for payment in cash or in shares will begin on that date and expire on 14 June 2011. Beyond this date or if the share-payment option is not taken, the dividend will be paid in cash. The 2010 dividend will be paid in shares or cash from 27 June 2011.
