RHODIA ANNOUNCES ITS ADDITIONAL 2010 RE-STATED QUARTERLY INFORMATION BY BUSINESS CLUSTER REFLECTIVE OF THE NEW ORGANIZATION

Paris – March 24, 2011 ----- Rhodia (NYSE Euronext Paris: RHA) today announces 2010 quarterly un-audited re-stated Net Sales, Recurring EBITDA and Operating Profit (Loss) for its five Business Clusters: Consumer Chemicals, Advanced Materials, Polyamide Materials, Acetow & Eco Services and Energy Services. Net Sales figures by Rhodia's Global Business Units are also provided for the full-year 2010.

These re-stated figures are presented for illustrative purposes only and reflect the Group's new segment reporting structure effective as from January 1st, 2011, following Rhodia's organization change. Rhodia's operational activities are now organized into eleven Global Business Units (GBUs) consolidated into five Clusters.
