Petrobras and Cybernétix do Brasil sign a Memorandum of Understanding for future technology cooperation

Petrobras and Cybernétix do Brasil, a company based in France and specializing in robotics systems and solutions for monitoring subsea pipelines, have signed a Memorandum of Understanding for cooperation on R&D projects.

The French company owns innovative technological solutions for monitoring subsea pipelines, including non-intrusive pressure and temperature sensors and equipment for monitoring the buildup of wax and inorganic salts (scale) inside the lines. The MOU is aimed at facilitating the joint development of future solutions, with information interchange on technologies and possible applications in Petrobras offshore installations.

"The opportunities for cooperation will be greatly enhanced now that Cybernétix is setting up a subsidiary here in Rio de Janeiro. Companies in the oil sector from numerous countries have been taking this kind of step and setting up research and development facilities in Brazil. Petrobras is encouraging this trend in the belief that it will strengthen our domestic technology base," said Ricardo Beltrão, general manager of Petrobras Production Engineering R&D.

The memorandum expiry date is December 31 2011, by which time Petrobras and Cybernétix will have held technical discussions to identify opportunities for jointly developing and testing solutions to help engineers and operators monitor oil and gas production, focusing on the measurement of parameters such as temperature and pressure inside subsea pipelines, and the monitoring of wax buildup and scale.
