## FFP publishes its Registration Document 2013

FFP has filed its Registration Document 2013 («*Document de référence 2013*») with the French Financial Markets Authority («*Autorité des Marchés Financiers*») on April 11<sup>th</sup> 2014.

- the details of the fees paid to the statutory auditors;
- the description of the share buyback program.

The Registration Document is available only in French. The website (French and English) is updated with the information included in the 2013 Registration Document.
