

Oxis Biotech Inc. Announces Appointment of Dr. James J Mulé to Scientific Advisory Board

The work in these areas has helped to develop new treatments for advanced cancer patients. Dr. Mulé serves on the Advisory Boards of seven NCI-designated Cancer Centers and was a member of the NCI's Board of Scientific and Clinical Counselors. He served as Chair of the Cellular, Tissue and Gene Therapy Advisory Committee of CBER, FDA, and is a Special Government Employee of the NCI and the FDA. Dr. Mulé is recognized for his research and clinical contributions to cancer immunotherapy, particularly in solid tumors.

I was lucky enough to have Dr. Mulé on my SAB when I formed Genesis BioPharma (now Lion Biotechnologies, Inc.).
