#### Geographical segment – growth

North America declined by 0.6% sequentially; and 0.5% in constant currency Europe grew by 2.1% sequentially; and 3.9% in constant currency India grew by 23.1% sequentially; and 24.3% in constant currency Rest of the world declined by 0.1% sequentially; and 0.3% in constant currency

#### Industry segment – growth

FSI grew by 2.7% sequentially; and 3.1% in constant currency

MFG declined by 3.7% sequentially; and 3.2% in constant currency

RCL declined by 0.5% sequentially; and 0.1% in constant currency
