The New Bonds will only be offered or sold to qualified investors within the meaning of Article 2(e) of Regulation (EU) 2017/1129 of the European Parliament and of the Council of 14 June 2017 (the "Prospectus Regulation"). The New Bonds may not be offered or sold or otherwise made available to retail investors (as defined below). No key information document under regulation 1286/2014 (as amended, the "PRIIPs Regulation") has been and will be prepared.

Safran successfully placed a tap issue of OCEANEs for a nominal amount of approximately €200 million

Paris, 6 October 2020

Safran (the "**Company**") announced today the successful placement of a tap issue of bonds convertible into new shares and/or exchangeable for existing shares of the Company (OCEANEs) due 15 May 2027 (the "**New Bonds**") for a nominal amount of approximately €200 million to qualified investors only within the meaning of the Prospectus Regulation (the "**Offering**").

The net proceeds of the Offering will be used for general corporate purposes.

The New Bonds are to be issued on the same terms (save for the issue price) as the approximately €800 million bonds convertible into new shares and/or exchangeable for existing shares of the Company (OCEANEs) issued by Safran on 15th May 2020 (the "**Existing Bonds**") and, as soon as the settlement date of the New Bonds, shall be fully fungible with the Existing Bonds and will form a single series with the Existing Bonds (together, the "**Bonds**").



The New Bonds shall be issued at a price of \in 118 (including accrued interest which is equal to \in 0.38918 per New Bond for the period from, and including, 15 May 2020, to, but excluding, 12 October 2020).

The New Bonds may be redeemed prior to maturity at the discretion of the Company, under certain conditions, and at the discretion of bondholders in case of Change of Control (as defined in the terms and conditions of the Bonds).

The settlement, delivery date and admission to trading on Euronext Access[™] (the non-regulated open market of Euronext Paris) of the New Bonds is expected to take place on 12 October 2020 (the "**Issue Date**").

This Offering has been managed by BNP Paribas and Crédit Agricole Corporate and Investment Bank acting as joint global coordinators and joint bookrunners (the "**Joint Global Coordinators**").

BNP Paribas will be in charge of the settlement of the Offering, BNP Paribas Securities Services will be the Centralising Agent (as defined in the terms and conditions of the Bonds) and Aether Financial Services will be the Calculation Agent (as defined in the terms and conditions of the Bonds).

Subscription by the French State

In this Offering, the French state has subscribed to 207,541 New Bonds, representing a nominal amount of approximately €22.5 million.

Conversion Right

Bondholders may exercise their conversion right (the "**Conversion Right**") at any time from the Issue Date until the 7th trading day (excluded) preceding the maturity date or the early redemption date.

The conversion ratio is set at one share per Bond subject to subsequent adjustments (as set out in the terms and conditions of the Bonds).

Upon exercise of their Conversion Right, bondholders will receive at the option of the Company new and/or existing shares of the Company. The new and/or existing shares then delivered shall carry current dividend rights.

Dilution

Considering a New Bond issue of \in 199,999,948.68 represented by 1,847,916 New Bonds of a nominal unit value of \in 108.23, on the basis of the initial conversion ratio, the maximum dilution would be of 0.43% if the Conversion Right was exercised for all New Bonds and if the Company decided to deliver solely new shares.

Lock-up

In the context of the Offering, the Company has agreed to a lock-up undertaking of 30 calendar days as of the Issue Date, subject to certain customary exceptions or waiver by the Joint Global Coordinators.



Legal Framework of the Offering and Placement

The New Bonds have been offered via an accelerated bookbuilding process to qualified investors only within the meaning of Article 2(e) of the Prospectus Regulation and as per the 19th resolution approved by the Company's extraordinary general meeting held on 23 May 2019, in France, in the European Economic Area (EEA) and outside the EEA (excluding in particular the United States of America, South Africa, Canada, Australia or Japan and any other jurisdiction where a registration process or an approval would be required by applicable laws and regulations).

Available Information

The Offering and the admission to trading on Euronext Access[™] is not subject to a prospectus approved by the French Financial Market Authority (*Autorité des marchés financiers*) (the "**AMF**"). No key information document the PRIIPs Regulation has been and will be prepared.
