He started his career at PAI Partners, before joining Goldman Sachs, in the Media & Telecom M&A teams. In 2006, he joined the Principal Investment Area team, which manages the firm's private equity investments, as well as Goldman Sachs Capital Partners.

**François Massut** joined the investment team of Peugeot Invest in 2015. He started his career in 2004 in private equity fund selection within several entities of the Caisse des Dépôts Group (CDC): Retirement Reserve Fund (FRR), CDC's equity funds and Bpifrance Investissement.
