Ordinary and Extraordinary Shareholders' Meeting of May 25, 2022,

Availability of preliminary documents for the Annual General Meeting

The Ordinary and Extraordinary Shareholders' Meeting will be held on May 25, 2022 at 2:00 p.m. (CET) at the Palais des Congrès of Issy-les-Moulineaux, 25 avenue Victor Cresson - 92130 Issy-les-Moulineaux, France.

A preliminary notice of meeting, published on March 30, 2022 in the French legal gazette (*Bulletin des annonces légales obligatoires* – BALO), (bulletin # 38, announcement # 2200644), contains the agenda of the meeting and the draft resolutions proposed to the shareholders.

The Annual General Meeting will be broadcast live on the Company's website.

Shareholders are invited to take note of the terms of participation detailed in 2022 Notice of Meeting (already available on Safran's website), which will also be detailed in the notice of meeting to be published on May 6, 2022 in the French legal gazette (*Bulletin des annonces légales obligatoires* – BALO) and on Safran's website (at https://www.safran-group.com/finance/annual-general-meeting).

Any person who can prove his or her status as a shareholder may attend the General Meeting in person, be represented or vote by post. Safran also offers its shareholders the possibility of voting by Internet, prior to the General Meeting, on the secure Votaccess voting platform, accessible *via* the website https://planetshares.bnpparibas.com. This electronic platform enables all shareholders to request an admission card, transmit voting instructions and appoint or revoke a proxy prior to the General Meeting.

Holders of registered or administered registered shares may request, until the fifth day preceding the General Meeting, from BNP Paribas Securities Services to receive documents and information referred to in Articles R.225-83 and R. 225-83 of the French Commercial Code. This request must be sent to BNP Paribas Securities Services – CTS Service Assemblées – Les Grands Moulins de Pantin – 9, rue du Débarcadère, 93761 Pantin Cedex – France, or by e-mail: paris.bp2s.gis.assemblees@bnpparibas.com.

Holders of bearer shares may obtain these documents by sending their request to BNP Paribas Securities Services, together with a share ownership certificate delivered by their authorized intermediary managing their securities account.
