AXA announces the filing of its 2023 Annual Report (Universal Registration Document) in the ESEF xHTML format (European Single Electronic Format) with the French *Autorité des marchés financiers* (AMF), on March 18, 2024.

The Annual Report includes, among other items, AXA's Annual Financial Report as well as the corporate governance report of the Board of Directors.

The Annual Report is available for consultation by the public free of charge in accordance with applicable regulations and can be found on AXA's website as of today (www.axa.com) in particular under the "Investors / Earnings and reports / Annual and Interim Reports" section (in French and in English) as well as on the AMF's website (in French and in the ESEF xHTML format only) (www.amf-france.org).

The AXA Group is a worldwide leader in insurance and asset management, with 147,000 employees serving 94 million clients in 50 countries. In 2023, IFRS17 revenues amounted to Euro 102.7 billion and IFRS17 underlying earnings to Euro 7.6 billion. AXA had Euro 946 billion in assets under management, including assets managed on behalf of third parties, as of December 31, 2023.

The AXA ordinary share is listed on compartment A of Euronext Paris under the ticker symbol CS (ISN FR 0000120628 – Bloomberg: CS FP – Reuters: AXAF.PA). AXA's American Depository Share is also quoted on the OTC QX platform under the ticker symbol AXAHY.

The AXA Group is included in the main international SRI indexes, such as Dow Jones Sustainability Index (DJSI) and FTSE4GOOD.

It is a founding member of the UN Environment Programme's Finance Initiative (UNEP FI) Principles for Sustainable Insurance and a signatory of the UN Principles for Responsible Investment.
