# Availability of the 2023 Universal Registration Document including the Annual Financial Report

Accor (Euronext Paris: AC) filed its 2023 Universal Registration Document, in ESEF (European Single Electronic Format) format, with the French Financial Markets Authority (*Autorité des marchés financiers* – AMF) on March 29, 2024.

- the report of the Board of Directors on corporate governance;
- the Statutory Auditors' reports and information related to their fees; and
- the description of the share buyback program.
