Founded in 1750, Swaine was recognised on 11 November 2025 at the Walpole British Luxury Awards, the most prestigious ceremony celebrating excellence in the British fashion and luxury industry. **This** distinction fully validates the strategic decisions made by Compagnie Chargeurs Invest when acquiring Swaine in 2021.

Committed to revitalizing this historic luxury house, Compagnie Chargeurs Invest has significantly invested in Swaine's manufacturing foundations, both through its workshop located within its London flagship store and through its factory in Leicester, while elevating the global desirability of its craftsmanship.

The Walpole "Made in the UK" Award—previously granted to Range Rover last year—stands as a definitive validation of this repositioning. This recognition also illustrates the operational excellence of Compagnie Chargeurs Invest, which supports high–value–added industrial or artisanal businesses by positioning them along increasingly elevated value chains. This top-tier distinction, rooted in quality and precision, stands as a benchmark achievement for the Group.

Now established in London with three prestigious locations and chosen by sovereigns around the world, Swaine has opened a boutique in Switzerland (Montreux Palace) and continues to multiply premium experiences (trunk shows in Monaco, Saint-Moritz, and more). The house continues its international expansion and will soon open its first U.S. boutiques in Los Angeles, in the heart of the iconic Beverly Hills district, and in Washington.

In a context marked by shifting consumer habits and expectations, Compagnie Chargeurs Invest intends to continue its long-term commitment to the sector, aiming to position Swaine among the foremost global brands of Quiet Luxury.
