

## 2CRSi Secures a €140 Million Contract<sup>1</sup>

---

**Strasbourg, France – February 17, 2026 – 2CRSi (ISIN: FR0013341781), a designer and manufacturer of high-performance and energy-efficient servers, announces the signing of a €140 million order (list price) for the supply of Artificial Intelligence servers to a Canadian client, as part of the deployment of Cloud AI capacity in the Japanese market.**

The contract covers the supply of servers dedicated to large-scale AI model training and inference. These servers will support the development of advanced generative AI models, massive data processing, and intensive computing workloads, addressing the growing needs of Japanese technology and industrial players.

Initial server shipments are scheduled for spring 2026, with a phased rollout extending through the summer.

### **2CRSi Godi 1.8E2D servers featuring NVIDIA Blackwell Ultra chips**

The deployed infrastructure will rely on 2CRSi Godi 1.8E2D servers, based on NVIDIA B300 chips, currently the most powerful graphic card unit available for AI inference.

The HGX B300 platform operates with NVIDIA Blackwell Ultra GPUs interconnected via fifth-generation NVLink and NVSwitch technology, enabling extremely high inter-GPU bandwidth and ultra-fast, direct communication between compute units.

Godi 1.8E2D servers deliver optimal performance levels for AI operations, with inference capabilities exceeding 144 petaFLOPS in FP4 density and an architecture optimized for very large-scale distributed workflows, significantly reducing traditional bottlenecks in high-performance computing.

This configuration significantly reduces training times for large-scale models while improving the overall energy efficiency of the infrastructure, thereby contributing to total cost of ownership (TCO) optimization for the operator.

## Strengthened position in the global artificial intelligence solutions market

This order confirms 2CRSi's strong momentum in the Artificial Intelligence solutions segment and reinforces its position as a key international player.

Delivery is expected before the end of the current fiscal year. As a result, exceeding the forecast of revenue above €300 million will be secured.

The 2CRSi Group continues to experience strong commercial momentum in the global AI infrastructure market, while also expanding into data storage and embedded systems markets, particularly in critical and defense environments.
