TURNOVER

In the 1st half of 2008, Coheris records a turnover of € 15.14 million going down by 5.6 % compared with 2007.

This figure is the result of the fact that significant license deals have been carried forward leading to a drop of € 1 million. Within an unfavourable economic context, these carryforwards were mainly the consequence of the events which have affected the company in June. The other software activities (professional services and maintenance) were not affected by these disruptions and reach a growth of 2.9 % over the semester.

As announced, Global Services, despite a lower result on the 1st quarter compared to last year's first quarter, returned to their 2007 level, even reaching over the 2nd quarter of 2008 a 10 % growth compared to the 2nd quarter of 2007. This good result for Global Services activities matches the objectives and comes after this activity was reorganised and revitalized in the 4th quarter of 2007.

OUTLOOKS

In the Software Publishing activities, the business portfolio remains particularly substantial despite a large part was postponed on the 2nd semester and should allow to compensate for the licenses sales delay of the 1st semester.

Besides, the transition of our business model, from a software provider/integrator to a system of indirect sales in France and abroad, already initiated with major integrators, will allow us to strongly increase the sales of licenses and maintenance which are the most lucrative.

Regarding the Global Services activity, a growth in double figures over the 2nd semester is expected considering the trend of the 2nd quarter of 2008.

Consolidated results for the 1st half of 2008 will be released on Tuesday evening, September 23rd, 2008.
