## **OL Groupe announces the recruitment of Fabio dos SANTOS BARBOSA for the Olympique Lyonnais team**

Lyon, 29<sup>th</sup> January 2007 : OL Groupe announces the transfer of the Brazilian player Fabio dos SANTOS BARBOSA, from the Brazilian club Cruzeiro Belo Horizonte, for €4.2 million. The contract with Olympique Lyonnais that will take effect from today, will have a duration of three years and a half, thus ending 30<sup>th</sup> June 2010.

This transfer follows that of the Czech player Milan Baros. It is in line with the club's consolidation strategy and is taking place prior to a range of tournaments taking place until the end of the season.

This recruitment is also in line with the club's strategy as exposed in the "document de base" registered on 9<sup>th</sup> January 2007 under n° I. 07 – 002 with the AMF.

We also remind you that a "note d'opération" received visa n° 07-028 on 25 January from the AMF.
