2006 consolidated revenues in line with expectations: €42.6M

Poissy, 6th March 2007:

Environnement SA, a major player in instrumentation for the environment, announces that its consolidated revenues for the FY to 31st December 2006 totalled €42.6M, stable (+1%) as expected compared to 2005, which was a year of very buoyant growth (+38%). This figure is in line with guidance. Exports represented 58% of revenues, whilst sales of services in France were up 75% following the implementation of "Global Service Evolutive" contracts, which are recurrent contracts relating to services and the supplying of measurements whilst retaining ownership of equipment.

FY 2005 and the first half of 2006 had indeed been marked by a sharp acceleration in sales because of the large amount of equipment installed by the Smoke Emissions division within the framework of the upgrading of French household waste incinerators to meet new higher standards. Other activities, and notably exports, then took over and enabled the Group to continue its organic growth within a highly competitive context.

The Group's total production, including lock-in production (investment in equipment for the new service activities) was €43.6M in 2006.

The Group is maintaining its results guidance as announced in October 2006, at the time of the presentation of H1 2006 results.
