1. Index Summary Description:**Index description**

The Stratégie NOBC Sélection Dynamique Index (the “**Index**”) is designed to produce a better risk-return ratio than a basket of mutual funds (the “**Underlying Basket**”).

The Index is constructed pursuant to a rebalancing process between (a) the Underlying Basket, (b) a hypothetical deposit based on the 1-Month London interbank offered rate for deposits in Euro (the “**EURIBOR Rate**”) and (c) a hypothetical borrowing based on the EURIBOR Rate used to optimize, under certain circumstances, the exposure to the Underlying Basket while keeping the risk level of the Index close to a pre-defined target level. The exposure to the Underlying Basket, through the use of the hypothetical borrowing, can reach a maximum of 200% of the level of the Index.

Certain parameters of the Index, like *inter alia* the composition of the Underlying Basket, may be reviewed periodically by an Index scientific committee, which comprises staff members of both Société Générale (the “**Index Sponsor**”), Asset Allocation Advisors and Banque Neuflyze OBC (the “**Index Scientific Committee**”). In addition, the Index Rules themselves may, by decision of the Index Scientific Committee pursuant the Index Scientific Committee Governance (as specified in the Index Rules) and subject to the approval of the Index Calculation Agent, be supplemented, amended or revised in whole or in part, which may lead to changes in the way the Index is compiled and calculated or affect the Index in another way.

The Index level is determined net of a synthetic dividend of 3% per annum.

Index strategy

The constituents of the Index are (a) the Underlying Basket, (b) a hypothetical deposit based on the 1-Month Euro Interbank Offered Rate (the “**EURIBOR Rate**”) and (d) a hypothetical borrowing based on the EURIBOR Rate. The deemed percentage exposure of the Index to the Underlying Basket (the “**Exposure**”) is determined by the Index Calculation Agent based on formulas (defined in the Index Rules) using the following input parameters:

- (i) the short-term historical volatility of the Underlying Basket;
- (ii) a target volatility of 10%; and
- (iii) the historical volatility of the Index itself;

such that, in most cases, when the short-term historical volatility of the Underlying Basket increases, the deemed exposure to the Underlying Basket decreases, and when the short-term historical volatility of the Underlying Basket decreases, the deemed exposure to the Underlying Basket increases.

The Exposure is capped at 200% of the Index Level and can be as low as 0%.

If the Exposure is less than 100%, (a) a percentage of the Index’s level is deemed invested in the Underlying Basket in an amount equal to the product of (i) the Exposure and (ii) the Index Level; and (b) the remaining percentage of the Index’s level is deemed invested in the hypothetical deposit based on the EURIBOR Rate.

If the Exposure is equal to 100%, then 100% of the Index’s level is deemed invested in the Underlying Basket and no portion of the Index’s level is deemed invested in the hypothetical deposit based on the EURIBOR Rate.

If the Exposure of the Index to the Underlying Basket is greater than 100% (subject to a maximum Exposure of 200%), then 100% of the Index’s level is deemed invested in the Underlying Basket and no portion of the Index’s level is deemed invested in the hypothetical deposit based on the EURIBOR Rate. Furthermore, (a) the Index is deemed to have invested an additional amount into the Underlying Basket equal to the product of (i) the Index Level and (ii) the difference of the Exposure and 100% (the “**Additional Exposure**”) and (b) the Index is deemed to have borrowed funds equal to the product of (i) the Index Level and (ii) the Additional Exposure at a rate based on the EURIBOR Rate. The deemed additional investment in the Underlying Basket will increase the Index’s exposure to the Underlying Basket, while the deemed borrowing will reduce the level of the Index.

The EURIBOR Rate is subject to:

- a variable funding spread applicable to the hypothetical deposit deemed to be made with Société Générale (the “**Funding Spread**”). This Funding Spread is consistent with the funding spread that Société Générale would apply over the EURIBOR Rate for a 1-Month unsecured deposit made with Société Générale. The initial Funding Spread is equal to 0.80%; and
- a variable financing spread applicable to the hypothetical borrowing deemed to be granted by Société Générale (the “**Financing Spread**”). The Financing Spread is consistent with the financing spread that Société Générale would apply over the EURIBOR Rate for a 1-Month unsecured borrowing facility granted by Société Générale. The initial Financing Spread is equal to 0.95%.
