Under these Notes, the Noteholders will not receive any coupons during the term of the Notes. At maturity, the Noteholders will receive at least 100% of the Specified Denomination (the « Minimum Redemption Amount »). The actual redemption date of these Notes is directly related to the performance of the Underlying(s): the better the performance, the sooner the redemption date and conversely, the worse the performance and the later the redemption date. The return depends upon the fact that the performance of the Underlying(s) reaches or does not reach a threshold. Accordingly, a small downward or upward movement of the Underlying(s) close to the threshold may result in a significantly larger increase or decrease of the return of the Notes. The return under these Notes is totally linked to the performance of the Underlying(s): the higher the performance, the higher the return. Some of the performances used to calculate the return of the Notes are capped at a pre-determined level, i.e. the Noteholders may not benefit from any future performance, if any, above that level.
