for the issue of obligations de financement de l'habitat

Under the Euro Medium Term Note Programme (the *Programme*) described in this base prospectus (the *Base Prospectus*), Société Générale SFH (the *Issuer*), subject to compliance with all relevant laws, regulations and directives, may from time to time issue *obligations de financement de l'habitat* within the meaning of article L. 515-36, I of the *Code monétaire et financier* (the *French Monetary and Financial Code*), benefiting from the statutory *privilège* (priority right of payment) created by article L. 515-19 of the French Monetary and Financial Code (the *Privilège*), as more fully described herein (the *Notes*). No credit linked Notes will be issued under the Programme.

An application has been made to the *Autorité des marchés financiers* (the *AMF*) in France for approval of this Base Prospectus in its capacity as the competent authority pursuant to article 212-2 of its *Règlement Général* (the *AMF General Regulations*), which implements Directive 2003/71/EC of 4 November 2003 on the prospectus to be published when securities are offered to the public or admitted to trading, as amended pursuant to Directive 2010/73/EC of 24 November 2010 (the *Prospectus Directive*).

An application may be made to Euronext Paris within a period of twelve (12) months after the date of this Base Prospectus in order for Notes issued under the Programme to be listed and admitted to trading on Euronext Paris. Euronext Paris is a regulated market for the purposes of Directive 2004/39/EC of 21 April 2004 on markets in financial instruments (a *Regulated Market*). Notes issued under the Programme may also be unlisted or listed and admitted to trading on any other market, including any other Regulated Market in any Member State of the European Economic Area. The relevant final terms (a form of which is contained herein) in respect of the issue of any Notes (the *Final Terms*) will specify whether or not such Notes will be listed and admitted to trading on any market and, if so, the relevant market.

Notes may be issued either in dematerialised form (*Dematerialised Notes*) or in materialised form (*Materialised Notes*) as more fully described herein.

Dematerialised Notes will at all times be in book-entry form in compliance with articles L. 211-3 *et seq.* of the French Monetary and Financial Code. No physical documents of title will be issued in respect of the Dematerialised Notes. Dematerialised Notes may, at the option of the Issuer, be (i) in bearer form (*au porteur*) inscribed as from the issue date in the books of Euroclear France (acting as the central depository) which shall credit the accounts of the Account Holders (as defined in the section entitled "Terms and Conditions of the Notes - Form, Denomination, Title and Redenomination") including Euroclear Bank S.A./N.V. (*Euroclear*) and the depository bank for Clearstream Banking, *société anonyme* (*Clearstream, Luxembourg*), or (ii) in registered form (*au nominatif*) and, in such latter case, at the option of the relevant Noteholder (as defined in the section entitled "Terms and Conditions of the Notes - Form, Denomination, Title and Redenomination"), in either fully registered form (*au nominatif pur*), in which case they will be either inscribed in an account maintained by the Issuer or by a registration agent (appointed in the relevant Final Terms) for the Issuer, or in administered registered form (*au nominatif administré*), in which case they will be inscribed in the accounts of the Account Holders designated by the relevant Noteholder.

Materialised Notes will be in bearer materialised form only and may only be issued outside France. A temporary global certificate in bearer form without interest coupons attached (a *Temporary Global Certificate*) will initially be issued in relation to the Materialised Notes. Such Temporary Global Certificate will subsequently be exchanged for definitive Materialised Notes with, where applicable, coupons for interest or talons attached, on or after a date expected to be on or about the fortieth (40th) day after the issue date of the Notes (subject to postponement as described in the section entitled "Temporary Global Certificate in respect of Materialised Notes") upon certification as to non-U.S. beneficial ownership as more fully described herein. Temporary Global Certificates will (a) in the case of a Tranche (as more fully described herein) intended to be cleared through Euroclear and/or Clearstream, Luxembourg, be deposited on the issue date with a common depository for Euroclear and Clearstream, Luxembourg, and (b) in the case of a Tranche intended to be cleared through a clearing system other than or in addition to Euroclear and/or Clearstream, Luxembourg or delivered outside a clearing system, be deposited as agreed between the Issuer and the relevant Dealer(s) (as defined below).

Notes issued under the Programme are expected to be rated AAA by Fitch France S.A. (*Fitch Ratings*) and Aaa by Moody's Investors Service Limited (*Moody's* and, together with Fitch Ratings, the *Rating Agencies* and each a *Rating Agency*). The rating of the Notes will be specified in the relevant Final Terms. A rating is not a recommendation to buy, sell or hold securities and may be subject to suspension, change or withdrawal at any time by the assigning Rating Agency without notice. A rating by Fitch Ratings addresses the likelihood of full and timely receipt by any of the relevant Noteholders of interest on the Notes and the likelihood of receipt by any

relevant Noteholder of the principal of the Notes by the relevant Maturity Date specified in the relevant Final Terms and a rating by Moody's addresses the expected loss posed to investors.

A rating must be issued by a credit rating agency established in the European Community and registered under Regulation 1060/2009/EC of the European Parliament and the Council of 16 September 2009 on credit rating agencies (the **CRA Regulation**), unless the rating is provided by a credit rating agency that operated in the European Community before 7 June 2010 and which has submitted an application for registration in accordance with the CRA Regulation and such application for registration has not been refused. Each of Fitch Ratings and Moody's is established in the European Community and has applied for registration under CRA Regulation, although notification of the corresponding registration decision has not yet been provided.

This Base Prospectus (together with all supplements thereto from time to time), constitutes a base prospectus for the purposes of article 5.4 of the Prospectus Directive and contains all relevant information concerning the Issuer which is necessary to enable investors to make an informed assessment of the assets and liabilities, financial position, profit and losses and prospects of the Issuer, as well as the base terms and conditions of the Notes to be issued under the Programme. The terms and conditions applicable to each Tranche (as more fully described herein) not contained herein (including, without limitation, the aggregate nominal amount, issue price, redemption price thereof, and interest, if any, payable thereunder) will be determined by the Issuer and the relevant Dealer(s) at the time of the issue on the basis of the then prevailing market conditions and will be set out in the relevant Final Terms.

This Base Prospectus should be read and construed in conjunction with any supplement that may be published from time to time and, in relation to any Tranche of Notes, should be read and construed in conjunction with the relevant Final Terms.

This Base Prospectus (together with all supplements thereto from time to time) may only be used for the purposes for which it has been published.

No person is, or has been, authorised to give any information or to make any representation, other than those contained or incorporated by reference in this Base Prospectus, in connection with the issue or sale of the Notes and, if given or made, such information or representation must not be relied upon as having been authorised by the Issuer, the Arranger or any of the Dealers (as defined in the section entitled “General description of the Programme”). Notes are being offered and sold outside the United States of America to non-U.S. persons in reliance on Regulation S.

For a description of these and certain other restrictions on offers, sales and transfers of the Notes and on the distribution of this Base Prospectus, see the section entitled “Subscription and Sale”.

This Base Prospectus does not constitute an offer of, or an invitation by or on behalf of the Issuer, the Arranger or the Dealer(s) to subscribe for, or purchase, any of the Notes below.

The Arranger and the Dealer(s) have not separately verified the information contained or incorporated by reference in this Base Prospectus. Neither the Arranger nor any of the Dealers makes any representation, express or implied, or accepts any responsibility, with respect to the accuracy or completeness of any of the information contained or incorporated by reference in this Base Prospectus. Neither this Base Prospectus nor any other information supplied in connection with the Programme (including any information incorporated by reference therein) is intended to provide the basis of any credit or other evaluation and should not be considered as a recommendation by any of the Issuer, the Arranger or the Dealer(s) that any recipient of this Base Prospectus or other information supplied in connection with the Programme (including any information incorporated by reference therein) should purchase the Notes. Each prospective investor in the Notes should determine for itself the relevance of the information contained in this Base Prospectus and its purchase of the Notes should be based upon such investigation as it deems necessary. However, there is no assurance that the Stabilising Manager(s) (or persons acting on behalf of a Stabilising Manager(s)) will undertake any stabilisation action. Any stabilisation action may begin on or after the date on which adequate public disclosure of the final terms of the offer of the relevant Tranche is made and, if begun, may be ended at any time, but it must end no later than the earlier of thirty (30) days after the issue date of the relevant Tranche and sixty (60) days after the date of the allotment of the relevant Tranche. Any stabilisation action or over-allotment shall be conducted in accordance with all applicable laws and rules.

None of the Dealers or the Issuer makes any representation to any prospective investor in the Notes regarding the legality of its investment under any applicable laws. Any prospective investor in the Notes should be able to bear the economic risk of an investment in the Notes for an indefinite period of time.

GENERAL DESCRIPTION OF THE PROGRAMME

This general description must be read as an introduction to this Base Prospectus and does not purport to be complete and should be read in conjunction with, and is qualified in its entirety by reference to, the more detailed information which appears elsewhere in this Base Prospectus. Any decision to invest in any Note should be based on a consideration by the investor of this Base Prospectus as a whole and the corresponding Final Terms.

In addition, as the nominal amount of the Notes is equal to €100,000, the following section is not, and is not to be regarded as, a summary within the meaning of article 212-8 of the AMF General Regulations.

Capitalised terms used in this general description shall have the same meanings as those ascribed to them in the section entitled “Terms and Conditions of the Notes”.

I. THE PARTIES UNDER THE PROGRAMME

Issuer: Société Générale SFH, a *société anonyme* incorporated under French law duly licensed in France as a *société financière - société de financement de l’habitat* (see the section entitled “Description of the Issuer”).

Arranger: Société Générale.

Dealers: Société Générale has been appointed by the Issuer as dealer in respect of the whole Programme.

The Issuer may, from time to time, appoint additional dealers either in respect of one (1) or more Tranches or in respect of the whole Programme. References in this Base Prospectus to **Permanent Dealers** are to Société Générale and to such additional persons that are appointed as dealers in respect of the whole Programme (and whose appointment has not been terminated) and references to **Dealers** are to the Permanent Dealers and all persons appointed as a dealer in respect of one or more Tranches.

The Issuer may also terminate the appointment of any Dealer from time to time.

Fiscal Agent and Principal Paying Agent: Société Générale.

Paying Agents: Société Générale (as Paris Paying Agent) and Société Générale Bank & Trust (as Luxembourg Paying Agent).

Calculation Agent: Société Générale, unless the Final Terms provide otherwise.

Servicer: Société Générale.

Services Provider: Société Générale.

FCT: FCT Red & Black – Guaranteed Home Loans (the **FCT**), a French securitisation fund (*fonds commun de titrisation*) governed by the provisions of articles L. 214-5, L. 214-42-1 to L. 214-48-I, L. 214-49-4 to L. 214-49-13, L. 231-7, R. 214-92, R. 214-93, D. 214-94, R. 214-95 to R. 214-101, D. 214-102 to D. 214-104 and R. 214-105 of the French Monetary and Financial Code and its regulations (*règlement*) (the **FCT Regulations**) entered into on 21 January 2009 between Paris Titrisation as

management company (the **FCT Management Company**) and Société Générale as custodian (the **FCT Custodian**) (see the section entitled “Description of the FCT and the FCT Programme” and the section entitled “General information relating to the Issuer” of the FCT Base Prospectus).

Statutory auditors: Ernst & Young Audit and Deloitte & Associés (see the sections entitled “Statutory auditors of the Issuer” and “Description of the Issuer – Control of the Issuer”).

Specific controller: Cailliau Dedouit et Associés (see the section entitled “Description of the Issuer – Control of the Issuer”).

Rating Agencies: Fitch Ratings and Moody's as credit rating agencies authorised to provide a rating document in respect of *sociétés de financement de l'habitat*. Each of Fitch Ratings and Moody's is established in the European Community and has applied for registration under CRA Regulation, although notification of the corresponding registration decision has not yet been provided.

II. THE PROGRAMME DOCUMENTS

Programme Documents: The documents entered into for the purpose of the Programme (the **Programme Documents**):

- (a) the Management and Servicing Agreement;
- (b) the Outsourcing and Assistance Agreement;
- (d) the Master Subscription Agreement;
- (e) the Programme Guarantee;
- (f) the Dealer Agreement;
- (g) the Paying Agency Agreement;
- (h) the Swap Agreement; and
- (i) any other document or agreement entered into pursuant to any of the documents listed in paragraphs (a) to (h) above.

Set out below is a description of the main Programme Documents.

Management and Servicing Agreement: The Issuer and the Servicer entered into the management and servicing agreement entitled “*convention-cadre de gestion et de recouvrement de créances*” (the **Management and Servicing Agreement**) pursuant to which the Servicer shall carry out, in accordance with article L. 515-22 of the French Monetary and Financial Code, the administration and recovery of the assets and liabilities of the Issuer.

The Issuer and the Servicer executed a separate letter in relation to the Management and Servicing Agreement pursuant to which the Servicer has undertaken to transfer the bank accounts of the Issuer to a bank which complies with the Rating Condition (as defined below), in the case Société Générale, as account holder as at the Date of this Prospectus, ceases to comply with such condition.

Outsourcing and The Issuer and the Services Provider entered into an outsourcing and assistance agreement entitled “*convention d'externalisation et*

Assistance Agreement: *d'assistance*” (the ***Outsourcing and Assistance Agreement***) pursuant to which the Services Provider shall fulfil regulatory obligations of permanent supervision, periodic supervision and compliance supervision on behalf of the Issuer and shall provide the Issuer with certain services required by the operations of the Issuer, in particular for financial and legal purposes.

The Issuer and the Services Provider may enter into separate and specific agreements to agree on the terms and conditions of certain specific tasks under the Outsourcing and Assistance Agreement. Accordingly, the Issuer and Société Générale entered into a periodic supervision agreement entitled “*convention de délégation des tâches d'exécution du contrôle périodique*”, pursuant to which Société Générale and the Issuer have set out the specific terms and conditions for the services to be provided by Société Générale to Société Générale SFH in relation to its periodic supervision.

Master Subscription Agreement: The Issuer and the FCT (represented by Paris Titrisation as FCT Management Company and Société Générale as FCT Custodian) entered into a master subscription agreement (the ***Master Subscription Agreement***), pursuant to which the Issuer may subscribe the notes issued from time to time by the FCT (the ***FCT Notes***), subject to and in accordance with the terms set out therein.

Programme Guarantee: The Issuer benefits from a guarantee from Société Générale, pursuant to a guarantee agreement entered into between the Issuer and Société Générale as guarantor (the ***Guarantor***) in relation to the Programme (the ***Programme Guarantee***).

The Programme Guarantee is granted for a maximum amount equal to a fixed percentage of the Programme Limit, such percentage being equal to fifteen (15) % as at the date of this Base Prospectus (the ***Guarantee Limit***).

Pursuant to the Programme Guarantee, the Guarantor has undertaken to cash collateralize its obligations up to the amount of the Guarantee Limit in the event that it ceases to have the minimum ratings which comply with the Rating Agencies’ public methodologies and criteria which are commensurate to the then current ratings of the Notes (the ***Rating Condition***).

Swap Agreement: The Issuer entered into an FBF Master Agreement, as published by the *Fédération bancaire française*, and the relevant schedules (the ***Swap Agreement***) with Société Générale acting as swap counterparty (the ***Swap Counterparty***) in order to hedge the interest rate risk on the Notes.

III. THE ASSETS OF THE ISSUER

Pursuant to its by-laws (*statuts*) and article L. 515-34 of the French Monetary and Financial Code, the assets of the Issuer may include:

- (a) loans guaranteed by the collateralisation (*remise*), the assignment or the pledge of home loans receivables (*créances de prêts à l'habitat*) (as defined in paragraph (d) below) granted by Société Générale or by any other company controlled by Société Générale within the meaning of article L. 233-3 of the *Code de commerce* (the ***French Commercial Code***) and licensed as a credit institution, benefiting from the provisions of articles L. 211-36 to L. 211-40 or articles L. 313-23 to L. 313-35 of the French Monetary and Financial

Code, regardless of the nature of such receivables, professional or otherwise;

- (b) units or notes issued by French securitisation vehicles (*organismes de titrisation*), or by any similar foreign entities in accordance with the provisions of article L. 515-16 of the French Monetary and Financial Code and which assets consist of, except for sums temporarily available and pending allocation, guarantees, security interest or other privileges benefiting to those notes or units, as well as securities kept by these securitisation vehicles or similar entities as reserve or guarantee in accordance with the applicable legislation, at least 90% of home loans receivables (*créances de prêts à l'habitat*) (as defined in paragraph (d) below) granted by Société Générale or by any other company controlled by Société Générale within the meaning of article L. 233-3 of the French Commercial Code and licensed as a credit institution and under the conditions set out in such article;
- (c) promissory notes (*billets à ordre*) issued by any credit institution pursuant to and in accordance with the provisions of articles L. 313-43 to L. 313-48 of the French Monetary and Financial Code and which, as an exception to article L. 313-42 of the said code, are issued in order to refinance home loans receivables (*créances de prêts à l'habitat*) (as defined in paragraph (d) below) granted by Société Générale or by any other company controlled by Société Générale within the meaning of article L. 233-3 of the French Commercial Code and licensed as a credit institution;
- (d) grant loans which:
 - (i) aim at financing, in whole or in part, residential real property located in France or another European Union Member State or an European Economic Area Member State or a State benefiting from the highest level of credit assessment (*meilleur échelon de qualité de crédit*) assigned by an external rating agency recognised by the *Autorité de contrôle prudentiel* pursuant to article L. 511-44 of the French Monetary and Financial Code; and
 - (ii) are guaranteed by a first-ranking mortgage or a charge over real property which provides a guarantee at least equal thereto or a guarantee (*cautionnement*) granted by a credit institution or an insurance company.

At the date of this Base Prospectus, it is contemplated that the assets of the Issuer will mainly be constituted of FCT Notes subscribed by the Issuer pursuant to the Master Subscription Agreement.

1 All payments of principal, interest and other income by or on behalf of the Issuer in respect of the Notes shall be made free and clear of, and without withholding or deduction for, any taxes, duties, assessments or governmental charges of whatever nature imposed, levied, collected, withheld or assessed by or within France or any authority therein or thereof having the power to tax, unless such withholding or deduction is required by law.

2. Notes issued on or after 1 March 2010 fall under the new French withholding tax regime pursuant to the French *loi de finances rectificative pour 2009* no. 3 (n°2009-1674 dated 30 December 2009), applicable as from 1 March 2010 (the **Amended Finance Act for 2009**). Payments of interest and other income made by the Issuer on such Notes will not be subject to the withholding tax set out under article 125 A III of the *Code général des impôts* (the **French General Tax Code**) unless such payments are made outside France in a non-cooperative State or territory (*Etat ou territoire non coopératif*) within the meaning of article 238-0 A of the French Tax Code (a **Non-Cooperative State**). If such payments under the Notes are made in a Non-Cooperative State, a 50% withholding tax will be applicable (subject to certain exceptions described below and the more favourable provisions of any applicable double tax treaty) by virtue of article 125 A III of the French General Tax Code.

Furthermore, interest and other income on such Notes will no longer be deductible from the Issuer's taxable income, as from the fiscal years starting on or after 1 January 2011, if they are paid or accrued to persons domiciled or established in a Non-Cooperative State or paid in such a Non-Cooperative State. Under certain conditions, any such non-deductible interest and other income may be recharacterised as constructive dividends pursuant to article 109 of the French General Tax Code, in which case such non-deductible interest and other income may be subject to the withholding tax set out under article 119 *bis* of the French General Tax Code, at a rate of 25% or 50%.

Notwithstanding the foregoing, the Amended Finance Act for 2009 provides that neither the 50% withholding tax nor the non-deductibility rule referred to above will apply in respect of a particular issue of Notes, if

the Issuer can prove that the principal purpose and effect of such issue of Notes was not that of allowing the payments of interest or other income to be made in a Non-Cooperative State (the **Exception**). Pursuant to the ruling (*rescrit*) no. 2010/11 (FP and FE) of the French tax authorities dated 22 February 2010, an issue of Notes will benefit from the Exception without the Issuer having to provide any proof of the purpose and effect of such issue of Notes, if such Notes are:

- (a) offered by means of a public offer within the meaning of article L. 411-1 of the French Monetary and Financial Code or pursuant to an equivalent offer in a state other than a Non-Cooperative State. For this purpose, an equivalent offer means any offer requiring the registration or submission of an offer document with a foreign securities market authority; or
- (b) admitted to trading on a regulated market or on a French or foreign multilateral securities trading system, provided that such market or system is not located in a Non-Cooperative State and that the operation of such market is carried out by a market operator or an investment services provider, or by such other similar foreign entity, provided further that such market operator, investment services provider or entity is not located in a Non-Cooperative State; or
- (c) admitted, at the time of their issue, to the clearing operations of a central depository or of a securities clearing and delivery and payments systems operator within the meaning of article L. 561-2 of the French Monetary and Financial Code or of one or more similar foreign depositories or operators, provided that such depository or operator is not located in a Non-Cooperative State.

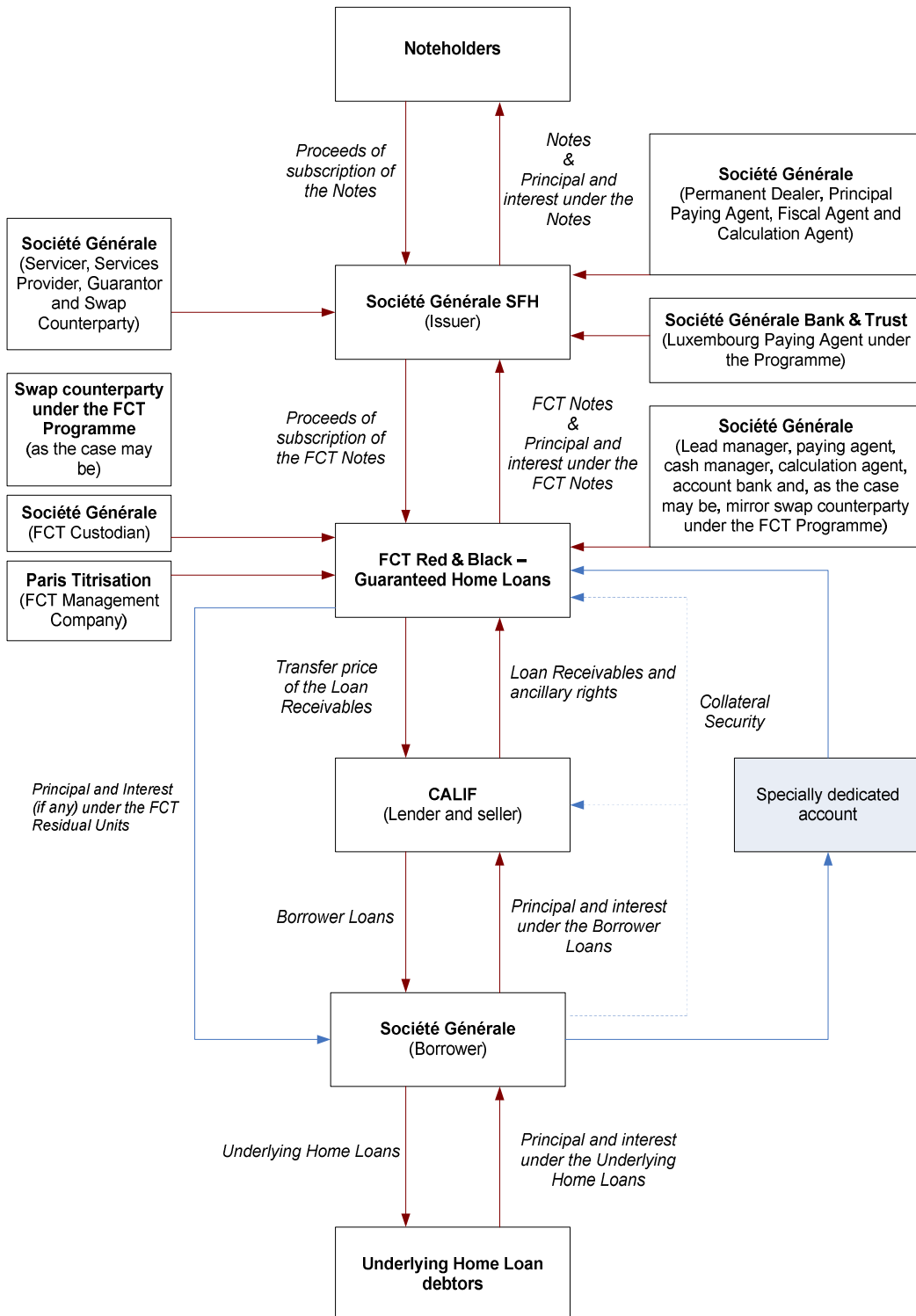



RISK FACTORS

The Issuer believes that the factors described below represent the principal risks inherent in investing in the Notes issued under the Programme. However, the Issuer does not represent that the statements below regarding the risks of holding any Notes are exhaustive. Investors must be aware that the list of factors set out below is not intended to be exhaustive and that other risks and uncertainties which, on the date of this Base Prospectus, are not known of by the Issuer, or are considered not to be relevant, may have a significant impact on the Issuer, its activities, its financial condition and the Notes. Prospective investors should also read the detailed information set out elsewhere in this Base Prospectus and form their own opinion about risk factors prior to making any investment decision. Investors should in particular conduct their own analysis and evaluation of the risks relating to the Issuer, its financial condition and the Notes.

The Issuer considers that the Notes shall only be purchased by investors which are (or are advised by) financial institutions or other professional investors who have sufficient knowledge and experience to appropriately evaluate the risks associated with the Notes.

Words and expressions defined elsewhere in this Base Prospectus shall have the same meanings when used below.

I. RISK FACTORS RELATING TO THE ISSUER

Sole liability of the Issuer under the Notes

The Issuer is the only entity which has obligations to pay principal and interest in respect of the Notes. The Notes will not be obligations or responsibilities of any other entity, including (but not limited to) Société Générale (in any capacity but in particular in its capacity as Arranger, Calculation Agent, Permanent Dealer, Fiscal Agent, Paying Agent and Principal Paying Agent) or any company within the Société Générale group, or the shareholders or directors or agents of any company in the same group of companies as any of them.

Reliance of the Issuer on third parties

The Issuer has entered into agreements with a number of third parties, which have agreed to perform services for the Issuer. The ability of the Issuer to make payments under the Notes may be affected by the due performance of the other third parties involved in the Programme in relation to their payment and other obligations thereunder, including the performance by the Servicer, the Services Provider, the Calculation Agent, the Fiscal Agent, the Paying Agent or the Principal Paying Agent of their respective obligations.

Credit risk on bank counterparties

For the Issuer, bank counterparty risk is that of counterparties in relation to hedging operations in respect of which it has entered into ISDA or FBF (*Fédération bancaire française*) master agreements that meet rating agency standards for *sociétés de financement de l'habitat*, managing the assets and liabilities of the Issuer and providing certain outsourcing and assistance services to the Issuer to fulfil its regulatory obligations.

The agreements to be entered into between the Issuer and the above counterparties will comply with the specific legal requirements applicable to *sociétés de financement de l'habitat* and with the Rating Agencies' public methodologies and criteria which are commensurate to the then current rating of the Notes.

Conflicts of interests in respect of Société Générale

With respect to the Notes, conflicts of interest may arise as a result of various factors involving in particular Société Générale, its affiliates and the other parties named herein. For example, such potential conflicts may arise because Société Générale acts in several capacities under the Programme

Documents and the FCT Programme Documents (see the section entitled “Relationship between Société Générale SFH and Société Générale and the section entitled “Description of the relevant entities” of the FCT Base Prospectus).

Even if their respective rights and obligations under the Programme Documents and the FCT Programme Documents are not conflicting and are independent from one another, in performing any such obligations in these different capacities under the Programme Documents and the FCT Programme Documents, Société Générale and/or such affiliates may be in a situation of conflict of interests. Société Générale and/or such affiliates will only have the duties and responsibilities expressly agreed to by such entity in the relevant capacity and will not, by virtue of its or any of its affiliates acting in any other capacity, be deemed to have other duties or responsibilities or be deemed to hold a duty of care other than as expressly provided in respect of each such capacity.

Also during the course of their business activities, the parties to the Programme and the FCT Programme and/or any of their respective affiliates may operate, service, acquire or sell properties, or finance loans secured by properties, which are in the same markets as the Underlying Home Loans.

II. RISK FACTORS RELATING TO THE ASSETS OF THE ISSUER

A. Credit risk on the assets of the Issuer generally

The Issuer’s sole business activity is to refinance home loans (*prêts à l’habitat*) and to hold securities under the terms and conditions set out in the French Monetary and Financial Code, including FCT Notes backed by such home loans (see the section entitled “Description of the FCT and the FCT Programme” and the sections entitled “General information relating to the Issuer” of the FCT Base Prospectus and “Origination of the Home Loans” of the FCT Base Prospectus). Therefore, the Issuer is exposed, directly or indirectly, to the credit risk of such home loans and securities and, in particular, to the credit risk of the FCT Notes.

However, in order to mitigate such credit risk, the assets of the Issuer will be selected so as to comply with certain legal eligibility criteria contained in the legal framework relating to *sociétés de financement de l’habitat* described hereinafter.

Legal eligibility criteria

The assets of the Issuer must comply with the legal eligibility criteria provided for in article L. 515-35 of the French Monetary and Financial Code. For further descriptions, see the section entitled “Summary of the legislation and regulations relating to *sociétés de financement de l’habitat*”.

The vast majority of these assets comes from the commercial financing activities of Société Générale group entities. When new assets are transferred or allocated to the Issuer's balance sheet, eligibility is verified at two levels (a reputable law firm and a specific controller of the Issuer who reports to the *Autorité de contrôle prudentiel* (See the section entitled “Summary of the legislation and regulations relating to *sociétés de financement de l’habitat*”)) for both French and non-French assets.

In addition, according to articles L. 515-17, R. 515-7 and R. 515-16 of the French Monetary and Financial Code, the Issuer may also hold securities, instruments and deposits which are sufficiently secure and liquid, as replacement assets (*valeurs de remplacement*) defined as exposures on credit institutions or investment firms benefiting from the highest level of credit assessment (*meilleur échelon de qualité de crédit*) assigned by an external rating agency recognised by the *Autorité de contrôle prudentiel* pursuant to article L. 511-44 of the French Monetary and Financial Code or guaranteed by credit institutions or investment firms benefiting of the same level of credit assessment (*échelon de qualité de crédit*), as well as debt securities issued or fully guaranteed by public sector entities as referred to in paragraphs 1 to 5 of article L. 515-15 of the French Monetary and Financial Code.

The total amount of such replacement assets shall not exceed fifteen per cent. (15%) of the nominal amount of the *obligations de financement de l’habitat* and other resources benefiting from the *Privilège*

as described in the section entitled “Summary of the legislation and regulations relating to *sociétés de financement de l’habitat – Privilège* and non-privileged debts”.

Finally, the Issuer may acquire and own any movable or immovable property which is necessary for the accomplishment of its corporate purpose or which it derives from the recovery of the receivables it holds.

Cover ratio between assets and privileged debts

According to article R. 515-7-2 of the French Monetary and Financial Code, *sociétés de financement de l’habitat* must at all times maintain a ratio of at least 102 per cent. of their assets to the total amount of their liabilities which have the benefit of the *Privilège*, provided, however, that all assets that have been transferred to a *société de financement de l’habitat* following the enforcement of the guarantee securing the loans granted by *société de financement de l’habitat* (as the case may be) shall be included among the assets shown on the balance sheet of the *société de financement de l’habitat* instead of its receivables.

Calculation of this cover ratio is set out in the Regulation n°99-10 of 9 July 1999 of the *Comité de la réglementation bancaire et financière* relating to the *sociétés de crédit foncier* and to the *sociétés de financement de l’habitat* as amended on 26 June 2001, 15 July 2002, 7 May 2007 and 23 February 2011 (the **CRBF Regulation**), pursuant to which the ratio's denominator (article 8 of the CRBF Regulation) is comprised of *obligations de financement de l’habitat* and other resources benefiting from the *Privilège*, and the ratio's numerator (article 9 of the CRBF Regulation) is made up of all the assets weighted to reflect their category.

Pursuant to article R. 515-7-2 of the French Monetary and Financial Code, the Issuer must be in constant compliance with the conditions of the above cover ratio. The specific controller (as described in the section entitled “Summary of the legislation and regulations relating to *sociétés de financement de l’habitat*”) has access to information that allows confirmation of each issue’s compliance with the cover ratio. This cover ratio is published twice a year and checked on a quarterly basis by the specific controller.

Credit risk on assets is overseen by the Risk Direction department, which analyses risks (and consolidates analyses by foreign subsidiaries) applying group-wide methods. This unit produces an internal rating and sets a commitment ceiling.

B. Risks related to the FCT and the FCT Notes

The risks related to the FCT and the FCT Notes (including the risks arising in relation to the sole liability of the FCT under the FCT Notes, the reliance of the FCT on third parties, the possibility to modify, alter or amend the FCT Programme Documents without the FCT Noteholders’ prior consent, the substitution risk of certain parties involved in the FCT Programme under certain circumstances, the conflicts of interest which may arise between the parties involved in the FCT Programme, and, in particular, in relation to Société Générale, the limited resources which are available to the FCT, the absence of recourse of the FCT Noteholders against the FCT, the fact that the FCT can invest its funds in certain authorised investments and the circumstances in which the FCT can be early terminated, as well as the risks arising in relation to the Borrower, the Collateral Security, the Home Loans and the related Home Loan guarantees, the hedging strategy of the FCT and, generally, the FCT Notes and the market in relation to the FCT Notes) are described in the section entitled “Risks factors” of the FCT Base Prospectus.

III. RISK FACTORS RELATING TO THE OPERATIONS OF THE ISSUER

Market risks

Market risk might come from a foreign exchange risk. The Société Générale group's management policy is to take no foreign exchange risks. Assets and liabilities originally in foreign currencies are swapped against Euros when they are acquired.

Interest and currency risks

The FCT Notes bear interest at a floating rate plus a margin, whereas the interest of the Notes can be based on an index different from the index on which the floating rate of the FCT Notes is based. In order to hedge the Issuer against this interest rate risk, the Issuer entered into the Swap Agreement with Société Générale (see the section entitled "Description of the Issuer – Hedging arrangements").

There can be no assurance, however, that hedging arrangements will adequately address unforeseen interest rate hedging risks.

The replacement assets, like all the Issuer's assets, are managed so as not to incur any interest rate or currency risks.

Liquidity risk

The Issuer benefits from the ALM management tools provided to it by the laws and regulations applicable to *sociétés de financement de l'habitat* in order to fund temporary liquidity needs. According to article L. 515-36 of the French Monetary and Financial Code, the Issuer may at any time sell or liquidate assets or raise new short-term or medium-term funds in order to comply with its payment obligations pursuant to the Notes and other resources, whether or not they benefit from the *Privilège*.

Other resources which do benefit from the *Privilège* may be raised pursuant to an agreement or a document designed to inform the public (within the meaning of article L. 412-1 of the French Monetary and Financial Code) or any equivalent document required for the admission to trading on foreign regulated markets which mentions the *Privilège*.

Other resources which do not benefit from the *Privilège* may include:

- (a) loans or resources raised pursuant to an agreement or a document designed to inform the public (within the meaning of article L. 412-1 of the French Monetary and Financial Code) or any equivalent document required for the admission to trading on foreign regulated markets that does not mention the *Privilège*;
- (b) promissory notes (*billets à ordre*) issued pursuant to and in accordance with the provisions of articles L. 313-43 to L. 313-48 of the French Monetary and Financial Code which, as an exception to article L. 313-42 of the said code, are issued in order to refinance home loans receivables (*créances de prêts à l'habitat*); and
- (c) temporary transfers of its securities as provided for in articles L. 211-22 to L. 211-34 of the French Monetary and Financial Code, pledge of a securities account as defined in article L. 211-20 of the French Monetary and Financial Code and transfer of all or part of its receivables in accordance with articles L. 211-36 to L. 211-40 or in accordance with articles L. 313-23 *et seq.* of the French Monetary and Financial Code, regardless of their nature, professional or otherwise. The receivables and securities so refinanced are not taken into account for the purpose of determining the cover ratio of the resources benefiting from the *Privilège*.

These mechanisms make it possible for the Issuer to temporarily use its assets as eligible collateral with the European Central Bank in accordance with the rules of the Eurosystem.

In addition, in order to avoid any liquidity gap during specific periods before the payment dates of any principal amount of its debt, the Issuer ensures that it has sufficient funds to meet its commitments.

Compliance with liquidity constraints can be achieved as follows:

- (i) by way of standby lines (or equivalent) with counterparties that have the minimum ratings which comply with the Rating Agencies' public methodologies and criteria which are commensurate to the then current ratings of the Notes; and
- (ii) by way of replacement securities and securities issued by public entities, both deemed liquid.

In this regard, it should be noted that the Issuer benefits from the Guarantee granted by Société Générale which allows it to cover its needs in cash for the payment of all amounts due in principal and interest in respect of any outstanding Series of Notes over roll-over periods of 365 days.

Operating risks involving information systems

The security of the Société Générale group's information systems is managed within Société Générale. A security policy has been defined, including directives and operating procedures broken down by risk sector: physical security, security of system access control, security of data bases and applications, and security of continued operations.

IV. RISK FACTORS RELATING TO THE NOTES

A. General risks related to the Notes

Set out below is a brief description of certain risks relating to the Notes generally:

Independent review and advice

Each prospective investor in the Notes must determine, based on its own independent review and such professional advice as it deems appropriate under the circumstances, that its acquisition of the Notes is fully consistent with its financial needs, objectives and condition, complies and is fully consistent with all investment policies, guidelines and restrictions applicable to it and is a fit, proper and suitable investment for it, notwithstanding the clear and substantial risks inherent in investing in or holding the Notes.

A prospective investor may not rely on the Issuer or the Dealer(s) or any of their respective affiliates in connection with its determination as to the legality of its acquisition of the Notes or as to the other matters referred to above.

Assessment of investment suitability

Each potential investor in the Notes must determine the suitability of that investment in light of its own circumstances. In particular, each potential investor should:

- (a) have sufficient knowledge and experience to make a meaningful evaluation of the Notes, the merits and risks of investing in the relevant Notes and the information contained or incorporated by reference in this Base Prospectus or any applicable supplement to this Base Prospectus and the relevant Final Terms;
- (b) have access to, and knowledge of, appropriate analytical tools to evaluate, in the context of its particular financial situation, an investment in the relevant Notes and the impact the relevant Notes will have on its overall investment portfolio;
- (c) have sufficient financial resources and liquidity to bear all of the risks of an investment in the Notes, including Notes with principal or interest payable in one or more currencies, or where the currency for principal or interest payments is different from the potential investor's currency;

- (d) understand thoroughly the terms of the relevant Notes and be familiar with the behaviour of any relevant indices and financial markets; and
- (e) be able to evaluate (either alone or with the help of a financial adviser) possible scenarios for economic, interest rate and other factors that may affect its investment and its ability to bear the applicable risks.

Some Notes are complex financial instruments. Sophisticated institutional investors generally do not purchase complex financial instruments as stand-alone investments. They purchase complex financial instruments as a way to reduce risk or enhance yield with an understood, measured and appropriate addition of risk to their overall portfolios. A potential investor should not invest in Notes which are complex financial instruments unless it has the expertise (either alone or with a financial adviser) to evaluate how the Notes will perform under changing conditions, the resulting effects on the value of the Notes and the impact this investment will have on the potential investor's overall investment portfolio. Some Notes which are complex financial instruments may be redeemable at an amount below par in which case investors may lose the value of part or their entire investment.

Potential Conflicts of Interest

The Issuer, the Dealers or their respective affiliates may from time to time advise the issuers or obligors in respect of reference assets regarding transactions to be entered into by them, or engage in transactions involving reference assets for their proprietary accounts and for other accounts under their management. Any such transaction may have a positive or negative effect on the value of such reference assets and therefore on the value of any Notes to which they relate. Accordingly, certain conflicts of interest may arise both among the Issuer, the Dealers or their affiliates and between the interests of the Issuer, the Dealers or their affiliates and the interests of holders of Notes.

Potential conflicts of interest may also arise between the Calculation Agent, if any, for a Tranche and the Noteholders, including with respect to certain discretionary determinations and judgements that such Calculation Agent may make, pursuant to the Terms and Conditions, that may influence the amount receivable upon redemption of the Notes.

Legality of Purchase

Neither the Issuer, the Dealer(s) nor any of their respective affiliates has or assumes responsibility for the lawfulness of the acquisition of the Notes by a prospective investor in the Notes, whether under the laws of the jurisdiction of its incorporation or the jurisdiction in which it operates (if different), or for compliance by that prospective investor with any law, regulation or regulatory policy applicable to it.

Modification

Except as otherwise provided by the relevant Final Terms, holders of Notes will, in respect of all Tranches in any Series, be grouped automatically, for the defence of their common interests, in a Masse, as defined in Condition 10, following which a General Meeting can then be held. The Terms and Conditions permit, in certain cases, defined majorities to bind all Noteholders including Noteholders who did not attend and vote at the relevant General Meeting and Noteholders who voted in a manner contrary to the majority. The General Meeting may deliberate on any proposal relating to the modification of the Conditions, including any proposal, whether for arbitration or settlement, relating to rights in controversy or which were the subject of judicial decisions, as more fully described in Condition 10.

Taxation

Potential purchasers and sellers of the Notes should be aware that they may be required to pay taxes or other documentary charges or duties in accordance with the laws and practices of the country to where the Notes are transferred or other jurisdictions. In some jurisdictions, no official statements of the tax authorities or court decisions may be available for innovative financial notes, such as the current Notes. Potential investors are advised not to rely upon the tax summary contained in this Base Prospectus and/or in the Final Terms but rather to ask for their own tax adviser's advice on their individual taxation with respect to the acquisition, sale and redemption of the Notes. Only these advisors are in a position to duly consider the specific situation of the potential investor. This investment consideration has to be read in connection with the taxation sections of this Base Prospectus and the additional tax sections, if any, contained in the relevant Final Terms.

EU Savings Directive

On 3 June 2003, the European Union adopted Directive 2003/48/EC regarding the taxation of savings income in the form of interest payments (the ***Savings Directive***). The Savings Directive requires Member States as from 1 July 2005 to provide to the tax authorities of other Member States details of payments of interest and other similar income within the meaning of the Savings Directive made by a paying agent within its jurisdiction to (or under certain circumstances for the benefit of) an individual resident in another Member State, except that Luxembourg and Austria will instead impose a withholding system for a transitional period unless the beneficiary of interest payment elects for the exchange of information.

If a payment were to be made or collected through a Member State which has opted for a withholding system and an amount in respect of tax were to be withheld from that payment, neither the Issuer nor any Paying Agent nor any other person would be obliged to pay additional amounts with respect to any Note as a result of the imposition of such withholding tax. If a withholding tax is imposed on payment made by a Paying Agent, the Issuer will be required to maintain a Paying Agent in a Member State that will not be obliged to withhold or deduct tax pursuant to the Savings Directive.

On 15 September 2008 the European Commission issued a report to the Council of the European Union on the operation of the Savings Directive, which included the Commission's advice on the need for changes to the Savings Directive. On 13 November 2008 the European Commission published a detailed proposal for amendments to the Savings Directive, which included a number of suggested changes. The European Parliament approved an amended version of this proposal on 24 April 2009. If any of those proposed changes are made in relation to the Savings Directive they may amend or broaden the scope of the requirements described above.

Change of law

The Terms and Conditions of the Notes are based on French law in force as at the date of this Base Prospectus. No assurance can be given as to the impact of any possible judicial decision or change to French law or administrative practice after the date of this Base Prospectus.

French Insolvency Law

Except as otherwise provided by the relevant Final Terms, the Noteholders, in respect of all Tranches in any Series, will be grouped automatically for the defence of their common interests in a Masse, as defined in Condition 10. However, under French insolvency law as amended by ordinance no. 2008-1345 dated 18 December 2008 which came into force on 15 February 2009, related order no. 2009-160 dated 12 February 2009 and law no. 2010-1249 dated 22 October 2010, holders of debt securities are automatically grouped into a single assembly of holders (the ***Assembly***) if a safeguard procedure (*procédure de sauvegarde*) or a judicial reorganisation procedure (*procédure de redressement judiciaire*) is opened in France with respect to the Issuer.

The Assembly comprises holders of all debt securities issued by the Issuer (including the Notes), whether or not under a debt issuance programme (such as a Euro Medium Term Note programme) and regardless of their governing law.

The Assembly will deliberate on the proposed safeguard plan (*projet de plan de sauvegarde*) or judicial reorganisation plan (*projet de plan de redressement*) applicable to the Issuer and may further agree to:

- increase the liabilities (charges) of holders of debt securities (including the Noteholders) by rescheduling payments which are due and/or partially or totally writing-off debts;
- establish an unequal treatment between holders of debt securities (including the Noteholders) as appropriate under the circumstances; and/or
- decide to convert debt securities (including the Notes) into securities that give or may give a right to share capital.

Decisions of the Assembly will be taken by a two-third (2/3) majority (calculated as a proportion of the amount of debt securities held by the holders who have cast a vote at such Assembly). No quorum is required to hold the Assembly.

For the avoidance of doubt, the provisions relating to the Representation of the Noteholders described in the Terms and Conditions of the Notes as set out in this Base Prospectus and if applicable, the relevant Final Terms, will not be applicable with respect to the Assembly to the extent they conflict with compulsory insolvency law provisions that apply in these circumstances.

No legal and tax advice

Each prospective investor should consult its own advisers as to legal, tax and related aspects investment in the Notes. A Noteholder's effective yield on the Notes may be diminished by the tax on that Noteholder of its investment in the Notes.

A Noteholder's actual yield on the Notes may be reduced from the stated yield by transaction costs.

Withholding Taxes - No gross-up obligation

If French law or Luxembourg law should require that any payments in respect of any Notes be subject to deduction or withholding in respect of any taxes or duties whatsoever, the Issuer will not pay any additional amounts. Therefore, the corresponding risk shall be borne by the Noteholders or, if applicable, the Receiptholders and the Couponholders.

Implementation of Basel II Risk-Weighted Asset Framework

In June 1999, the Basel Committee on Banking Supervision (the ***Basel Committee***) issued proposals for the reform of the 1988 Basel Capital Accord and proposed a new capital adequacy framework which would place enhanced emphasis on risk sensitivity and market discipline. On 26 June 2004, the Basel Committee published a new Capital Accord under the title "Basel II International Convergence of Capital Measurement and Capital Standards: a Revised Framework" (***Basel II***), an updated version of which was published in November 2005. Basel II has been implemented into the EU legislation through the directives no. 2006/48 of the European Parliament and of the Council relating to the taking up and pursuit of the business of credit institutions and no. 2006/49 on the capital adequacy of investment firms and credit institutions both dated 14 June 2006 as recently amended by the Directives 2009/27/EC, 2009/83/EC and 2009/111/EC (the ***Capital Requirements Directives***). In France, the provisions of the Capital Requirements Directives providing for a new solvency ratio have been implemented in particular through the *arrêté* dated 20 February 2007 relating to the capital requirements applicable to the credit institutions and the investment firms (as amended) and the *ordonnance* no. 2007-571 dated 19 April 2007 relating to the credit institutions, the investment firms and *sociétés de crédit foncier*. Please note also that the *arrêté* dated 25 August 2010 transposing the

Capital Requirements Directives, which has entered into effect on 31 December 2010, has amended the French prudential control requirements applicable to credit institutions and investment firms.

This implementation has brought about many substantial changes to the current system of capital requirements, prudential oversight and risk-management systems. The implementation of Basel II could affect the risk weighting of the Notes in respect of certain investors if those investors are subject to the new guidelines resulting from the implementation of the Capital Requirements Directives. Accordingly, recipients of this Base Prospectus should consult their own advisers as to the consequences and effects the implementation of the Capital Requirements Directives could have on them.

Forecasts and estimates

Estimates of the weighted average lives of the Notes contained in this Base Prospectus, together with any other projections, forecasts and estimates in this Base Prospectus are forward-looking statements. Such projections are speculative in nature and it can be expected that some or all of the assumptions underlying the projections will not prove to be wholly correct or will vary from actual results. Consequently, the actual results might differ from the projections and such differences might be significant.

Ratings of the Notes

The ratings assigned to the Notes by the Rating Agencies are based, among other things, on the credit quality of the assets refinanced (in the case at hand, the FCT Notes, at inception) and the other relevant structural and credit enhancement features provided for under the Programme Documents and the FCT Programme Documents, including, among other things, the short-term and/or long-term IDR (with respect to Fitch Ratings) or the short-term and/or long-term unsecured, unguaranteed and unsubordinated debt ratings (with respect to Moody's) of the parties to the Programme Documents and the FCT Programme Documents, and reflect only the views of the Rating Agencies. The ratings address the likelihood of full and timely receipt by any of the relevant Noteholders of interest on the Notes and the likelihood of receipt by any relevant Noteholder of principal of the Notes by the relevant Maturity Date. There is no assurance that any such ratings will continue for any period of time or that they will not be reviewed, revised, suspended or withdrawn entirely by the Rating Agencies as a result of changes in or unavailability of information or if, in the judgement of the Rating Agencies, circumstances so warrant. A qualification, downgrade or withdrawal of any of the ratings mentioned above may impact upon both the value of the Notes or their marketability in secondary market transactions.

The Rating Agencies will be notified of the exercise of certain discretions exercised by or on behalf of the Issuer under the Programme Documents. However, the Rating Agencies are under no obligation to revert to the Issuer (or any of its agents) regarding the impact of the exercise of such discretion on the ratings of the Notes and any decision as to whether or not to confirm, downgrade, withdraw or qualify the ratings of all classes or any class of Notes based on such notification may be made at the sole discretion of the Rating Agencies at any time, including after the relevant action has been taken.

Where, after the date of this Base Prospectus, a particular matter such as that referred to in the preceding paragraph or any other matter involves the Rating Agencies being requested to confirm to the Issuer (and to each Representative) (whether by email, letter or otherwise) (for so long as the Notes) are rated by the Rating Agencies) that such specified matter will not result in the reduction or withdrawal or other adverse action with respect to the then-current rating assigned to the Notes by the Rating Agencies (a ***Rating Confirmation***), the Rating Agencies, at their sole discretion, may or may not give such affirmation. It should be noted that, depending on the timing of delivery of the request and any information needed to be provided as part of any such request, it may be the case that the Rating Agencies cannot provide the relevant affirmation in the time available or at all and it will not be held responsible for the consequences thereof. Any affirmation received from the Rating Agencies, if given, will be given on the basis of the facts and circumstances prevailing at the relevant time and in the context of cumulative changes to the transaction of which the Notes form part since the date of this Base Prospectus. Furthermore, in the event that a Rating Agency gives a Rating Confirmation, this will

be on the basis of full and timely receipt by the relevant Noteholders of interest on the Notes and the likelihood of receipt of principal of the Notes by the relevant Maturity Date. There is no assurance that after any such affirmation, the then current ratings of the Notes will continue for any period of time or that they will not be reviewed, revised, suspended or withdrawn entirely by such Rating Agency for any of the reasons specified above in relation to the original ratings of the Notes. As such an affirmation of the ratings of the Notes by the Rating Agencies is not a representation or warranty that, as a result of a particular matter, the interest and principal due under the Notes will be paid or repaid in full and when due. Agencies other than the Rating Agencies could seek to rate the Notes and if such unsolicited ratings are lower than the comparable ratings assigned to the Notes by the Rating Agencies, those unsolicited ratings could have an adverse effect on the value and the marketability of the Notes. For the avoidance of doubt and unless the context otherwise requires, any references to *ratings* or *rating* in this Base Prospectus are to ratings assigned by the Rating Agencies only.

B. Risks related to the structure of a particular issue of Notes

A wide range of Notes may be issued under the Programme. A number of these Notes may have features which contain particular risks for potential investors. Set out below is a description of the most common such features:

Notes subject to optional redemption by the Issuer

An optional redemption feature of the Notes is likely to limit their market value. During any period when the Issuer may elect to redeem the Notes, the market value of such Notes generally will not rise substantially above the price at which they can be redeemed. This may also be true prior to any redemption period.

The Issuer may be expected to redeem the Notes when its cost of borrowing is lower than the interest rate on the Notes. At those times, an investor would not generally be able to reinvest the redemption proceeds at an effective interest rate as high as the interest rate on the Notes being redeemed, and may only be able to do so at a significantly lower rate. Potential investors should consider reinvestment risk in light of other investments available at that time.

Early Redemption

The Issuer may be expected to redeem Notes when its cost of borrowing is lower than the interest rate on the Notes. At those times, an investor generally would not be able to reinvest the redemption proceeds at an effective interest rate as high as the interest rate on the Notes being redeemed and may only be able to do so at a significantly lower rate. Potential investors should consider reinvestment risk in light of other investments available at that time.

Fixed Rate Notes

Investment in Notes which bear interest at a fixed rate involves the risk that subsequent changes in market interest rates may adversely affect the value of the relevant Tranche of Notes.

Floating Rate Notes

The interest rate of Notes which bear interest at a floating rate is comprised of (i) a reference rate, and (ii) a margin to be added or subtracted, as the case may be, from such base rate. Typically, the relevant margin will not change throughout the life of the Notes but there will be a periodic adjustment (as specified in the relevant Final Terms) of the reference rate (e.g., every three (3) months or six (6) months) which itself will change in accordance with general market conditions. Accordingly, the market value of Floating Rate Notes may be volatile if changes, particularly short term changes, to market interest rates evidenced by the relevant reference rate can only be reflected in the interest rate of these Notes upon the next periodic adjustment of the relevant reference rate.

Index Linked Notes and Dual Currency Notes

The Issuer may issue Notes with principal or interest determined by reference to an index or formula, to changes in the prices of securities or commodities, to movements in currency exchange rates or other factors (each, a **Relevant Factor**). In addition, the Issuer may issue Notes with principal or interest payable in one or more currencies which may be different from the currency in which the Notes are denominated. Potential investors should be aware that:

- (a) the market price of such Notes may be volatile;
- (b) they may receive no interest;
- (c) payment of principal or interest may occur at a different time or in a different currency than expected;
- (d) the amount of principal payable at redemption may be less than the nominal amount of such Notes or even zero;
- (e) a Relevant Factor may be subject to significant fluctuations that may not correlate with changes in interest rates, currencies or other indices;
- (f) if a Relevant Factor is applied to the Notes in conjunction with a multiplier greater than one, or contains some other leverage factor, the effect of any changes in the Relevant Factor on principal or interest payable is likely to be magnified; and
- (g) the timing of changes in a Relevant Factor may affect the actual yield to investors, even if the average level is consistent with their expectations. In general, the earlier the change in the Relevant Factor, the greater the effect on yield.

None of the Issuer, the Dealers or any of their respective affiliates makes any representation as to an index. Any such person may have acquired, or during the term of the Notes may acquire, non-public information with respect to an index that is or may be material in the context of Index Linked Notes. The issue of Index Linked Notes will not create any obligation on the part of any such persons to disclose to the Noteholders or any other party such information (whether or not confidential).

The decision to purchase Index Linked Notes involves complex financial appreciations and risks as the index evolution cannot be foreseen with certainty. The yield of Index Linked Notes may be lower than the yield of non Index Linked Notes. The Issuer makes no representation as to the tax treatment of such Notes or as to the lawfulness of the purchase of such Notes in any jurisdiction.

Partly-Paid Notes

The Issuer may issue Notes where the issue price is payable in more than one instalment. Failure to pay any subsequent instalment could result in an investor losing some or all of his investment.

Variable rate Notes with a multiplier or other leverage factor

Notes with variable interest rates can be volatile investments. If they are structured to include multipliers or other leverage factors, or caps or floors, or any combination of those features or other similar related features, their market values may be even more volatile than those for securities that do not include those features.

Inverse Floating Rate Notes

Inverse Floating Rate Notes have an interest rate equal to a fixed rate minus a rate based upon a reference rate. The market values of such Notes are typically more volatile than the market values of other conventional floating rate debt securities based on the same reference rate (and with otherwise comparable terms). Inverse Floating Rate Notes are more volatile because an increase in the reference rate not only decreases the interest rate of the Notes, but may also reflect an increase in prevailing interest rates, which can/would further adversely affect the market value of these Notes.

Fixed to Floating Rate Notes

Fixed to Floating Rate Notes may bear interest at a rate that will automatically, or that the Issuer may elect to, convert from a fixed rate to a floating rate, or from a floating rate to a fixed rate. The conversion (whether automatic or optional) will affect the secondary market and the market value of such Notes since it may lead to a lower overall cost of borrowing. If a fixed rate is converted to a floating rate, the spread on the Fixed to Floating Rate Notes may be less favourable than then prevailing spreads on comparable Floating Rate Notes tied to the same reference rate. In addition, the new floating rate may at any time be lower than the rates on other Notes. If a floating rate is converted to a fixed rate, the fixed rate may be lower than then prevailing rates on its Notes.

Notes issued at a substantial discount or premium

The market values of securities issued at a substantial discount or premium from their principal amount tend to fluctuate more in relation to general changes in interest rates than do prices for conventional interest-bearing securities. Generally, the longer the remaining term of the securities, the greater the price volatility as compared to conventional interest-bearing securities with comparable maturities.

Zero Coupon Notes

Changes in market interest rates have a substantially stronger impact on the prices of Zero Coupon Notes than on the prices of ordinary Notes because the discounted issue prices are substantially below par. If market interest rates increase, Zero Coupon Notes can suffer higher price losses than other Notes having the same maturity and credit rating. Due to their leverage effect, Zero Coupon Notes are a type of investment associated with a particularly high price risk.

Structured Notes

An investment in Notes, in respect of which the premium and/or the interest on or principal of is determined by reference to one or more values of currencies, commodities, interest rates or other indices or formulae, either directly or inversely, may entail significant risks not associated with similar investments in a conventional debt security, including the risk that the resulting interest rate will be less than that payable on a conventional debt security at the same time and/or that an investor may lose the value of its entire investment, or part of it, as the case may be. Neither the current nor the historical value of the relevant currencies, commodities, interest rates or other indices or formulae should be taken as an indication of the future performance of such currencies, commodities, interest rates or other indices or formulae during the term of any Note.

C. Risk factors relating to Index Linked Notes

Where payments (whether in respect of principal and/or interest and whether at maturity or otherwise) on Index Linked Notes are calculated by reference to an index or a basket of indices, or a share or a basket of shares, the creditworthiness of any reference entity or reference obligation or a basket of reference entities or reference obligations, a commodity or a basket of commodities (each, a ***Reference Asset***), the return of the Notes is based on changes in the value of the Reference Asset, which fluctuates. Changes in the value of the Reference Asset cannot be predicted. Although historical data with respect to the Reference Asset is available, the historical performance of the Reference Asset should not be taken as an indication of future performance.

Investors' yield may be lower than the yield on a standard debt security of comparable maturity

Unlike conventional fixed rate or floating rate debt securities, Index Linked Notes whose payments (whether in respect of principal and/or interest and whether at maturity or otherwise) are calculated by reference to an index, may not provide investors with periodic payments of interest. Further, with respect to the Final or Early Redemption Amount, the effective yield to maturity of the Notes may be less than that which would be payable on a conventional fixed rate or floating rate debt security. The return of only the Final or Early Redemption Amount of each Note at maturity may not compensate the holder for any opportunity cost implied by inflation and other factors relating to the value of money over time.

Adjustment or substitution - Early redemption of the Notes

The Issuer reserves the right to proceed to adjustments or substitutions, or even proceed to the early redemption of the Notes, in particular upon the occurrence of events affecting the underlying instrument(s). The early redemption of the Notes may result in the total or partial loss of the amount invested.

D. Risks related to the market generally

Set out below is a brief description of the principal market risks, including liquidity risk, exchange rate risk, interest rate risk and credit risk:

Market value of the Notes

The market value of the Notes will be affected by the creditworthiness of the Issuer and a number of additional factors, including the value of the reference assets or an index, including, but not limited to, the volatility of the reference assets or an index, or the dividend on the securities listed on the index, market interest and yield rates and the time remaining to the maturity date.

The value of the Notes, the reference assets or the index depends on a number of interrelated factors, including economic, financial and political events in France or elsewhere, including factors affecting capital markets generally and the stock exchanges on which the Notes, the reference assets, the securities listed on the index, or the index are traded. The price at which a Noteholder will be able to sell the Notes prior to maturity may be at a discount, which could be substantial, from the issue price or the purchase price paid by such purchaser. The historical market prices of the reference assets or an index should not be taken as an indication of the reference assets' or an index's future performance during the term of any Note.

The secondary market generally

Notes may have no established trading market when issued, and one may never develop. If a market does develop, it may not be liquid. Therefore, investors may not be able to sell their Notes easily or at prices that will provide them with a yield comparable to similar investments that have a developed secondary market. This is particularly the case for Notes that are especially sensitive to interest rate, currency or market risks, that are designed for specific investment objectives or strategies or that have been structured to meet the investment requirements of limited categories of investors. These types of Notes generally would have a more limited secondary market and more price volatility than conventional debt securities. Illiquidity may have an adverse effect on the market value of Notes.

In addition, Noteholders should be aware of the prevailing and widely reported global credit market conditions (which continue at the date of this Base Prospectus), whereby there is a general lack of liquidity in the secondary market for instruments similar to certain of the Notes which may be issued hereunder. Such lack of liquidity may result in investors suffering losses on the Notes in secondary resales even if there is no decline in the performance of the Notes. The Issuer cannot predict whether

these circumstances will change and whether, if and when they do change, there will be a more liquid market for the Notes and instruments similar to the Notes at that time.

Although applications have been made for the Notes issued under the Programme to be listed and admitted to trading on Euronext Paris, there is no assurance that such application will be accepted, that any particular Tranche of Notes will be so admitted or that an active trading market will develop.

Exchange rate risks and exchange controls

The Issuer will pay principal and interest on the Notes in the Specified Currency. This presents certain risks relating to currency conversions if an investor's financial activities are denominated principally in a currency or currency unit (the ***Investor's Currency***) other than the Specified Currency. These include the risk that exchange rates may change significantly (including changes due to devaluation of the Specified Currency or revaluation of the Investor's Currency) and the risk that authorities with jurisdiction over the Investor's Currency may impose or modify exchange controls. An appreciation in the value of the Investor's Currency relative to the Specified Currency would decrease (1) the Investor's Currency-equivalent yield on the Notes, (2) the Investor's Currency-equivalent value of the principal payable on the Notes, and (3) the Investor's Currency-equivalent market value of the Notes.

Government and monetary authorities may impose (as some have done in the past) exchange controls that could adversely affect an applicable exchange rate. As a result, investors may receive less interest or principal than expected, or no interest or principal.

Legal investment considerations may restrict certain investments

The investment activities of certain investors can be subject to legal investment laws and regulations and/or review or regulation by certain authorities. Each potential investor should consult its legal advisers to determine whether and to what extent (1) Notes are legal investments for it, (2) Notes can be used as collateral for various types of borrowing, and (3) other restrictions that could apply to its purchase or pledge of any Notes. Financial institutions should consult their legal advisors or the appropriate regulators to determine the appropriate treatment of Notes under any applicable risk-based capital or similar rules. Neither the Issuer, the Dealer(s) nor any of their respective affiliates has or assumes responsibility for the lawfulness of the acquisition of the Notes by a prospective investor in the Notes, whether under the laws of the jurisdiction of its incorporation or the jurisdiction in which it operates (if different), or for compliance by that prospective investor with any law, regulation or regulatory policy applicable to it.

SUMMARY OF THE LEGISLATION AND REGULATIONS RELATING TO *SOCIÉTÉS DE FINANCEMENT DE L'HABITAT*

Legal framework

At the date of this Base Prospectus, the legal and regulatory regime applicable to *sociétés de financement de l'habitat* results from the following provisions:

- (a) articles L. 515-14, L. 515-16, L. 515-17 to L. 515-32-1 and L. 515-34 *et seq.* of the French Monetary and Financial Code;
- (b) article 74 of law n°2010-1249 of 22 October 2010 on banking and financial regulation;
- (c) articles R. 515-2, R. 515-4, R. 515-5, R. 515-7 to R. 515-11 and R. 515-12 to R. 515-17 of the French Monetary and Financial Code;
- (d) the Regulation n°99-10 of 9 July 1999 of the *Comité de la réglementation bancaire et financière* relating to the *sociétés de crédit foncier* and to the *sociétés de financement de l'habitat* as amended on 26 June 2001, 15 July 2002, 7 May 2007 and 23 February 2011 (the **CRBF Regulation**).

Entities entitled to issue *obligations de financement de l'habitat*

Sociétés de financement de l'habitat are credit institutions (*établissements de crédit*) licensed as financial institutions (*sociétés financières*) and authorised to act as *sociétés de financement de l'habitat* by the *Autorité de contrôle prudentiel*.

The exclusive legal purpose of the *sociétés de financement de l'habitat* is to grant or finance loans and hold securities under the conditions set out in the French Monetary and Financial Code.

Eligible assets

In accordance with the French current legal framework applicable to *sociétés de financement de l'habitat* on the date hereof, the eligible assets in respect of a *société de financement de l'habitat* may only be:

- (a) loans granted to any credit institution and guaranteed by the collateralisation (*remise*), the assignment or the pledge of home loans receivables (*créances de prêts à l'habitat*) (as defined in paragraph (d) below), pursuant to and in accordance with the provisions of articles L. 211-36 to L. 211-40 or articles L. 313-23 to L. 313-35 of the French Monetary and Financial Code, regardless of their nature, professional or otherwise;
- (b) in accordance with the provisions of article R. 515-2 *et seq.* of the French Monetary and Financial Code, units or notes issued by French securitisation vehicles (*organismes de titrisation*) or any other similar foreign entities governed by the laws of a Member State of the EC or EEA, the United States of America, Switzerland, Japan, Canada, Australia or New Zealand, if the following provisions of article L. 515-16 of the French Monetary and Financial Code are complied with:
 - (i) the assets of such securitisation vehicles consist of, except for sums temporarily available and pending allocation, guarantees, security interest or other privileges benefiting to those notes or units, as well as securities kept by these securitisation vehicles or similar entities as reserve or guarantee in accordance with the applicable legislation, at least 90% of receivables of the same kind as those complying with the criteria set out in article L. 515-14-I of the French Monetary and Financial Code or other receivables benefiting from the same level of guarantees;

- (ii) such units or notes are not specific units or specific notes issued to cover the risk of insolvency of debtors; and
 - (iii) such units or notes benefit from the highest level of credit assessment (*meilleur échelon de qualité de crédit*) assigned by an external rating agency recognised by the *Autorité de contrôle prudentiel* pursuant to article L. 511-44 of the French Monetary and Financial Code; and
 - (iv) the similar foreign entities mentioned above shall be subject to the law of a Member State of the European Community or a state which is a party to the agreement on the EEA as soon as its assets are composed in whole or part of loans or exposures mentioned in article L. 515-14 of the French Monetary and Financial Code.
- (c) promissory notes (*billets à ordre*) issued by any credit institution, pursuant to and in accordance with the provisions of articles L. 313-43 to L. 313-48 of the French Monetary and Financial Code and which, as an exception to article L. 313-42 of the said code, are issued in order to refinance home loans receivables (*créances de prêts à l'habitat*) (as defined below); and
- (d) loans which are defined as loans that:
- (i) aim at financing, in whole or in part, residential real property located in France or another European Union Member State or an European Economic Area Member State or a State benefiting from the highest level of credit assessment (*meilleur échelon de qualité de crédit*) assigned by an external rating agency recognised by the *Autorité de contrôle prudentiel* pursuant to article L. 511-44 of the French Monetary and Financial Code; and
 - (ii) are guaranteed by a first-ranking mortgage or a charge over real property which provides a guarantee at least equal thereto or a guarantee (*cautionnement*) granted by a credit institution or an insurance company.

In accordance with article R. 515-14, any *société de financement de l'habitat* must keep an up-to-date list (*état*) of the loans it has granted or acquired. Such list must also mention the nature and the value of the guarantees relating to these loans, together with the nature and the amount of the privileged debts.

In addition, according to articles L. 515-17, R. 515-7-2 and R. 515-16 of the French Monetary and Financial Code, a *société de financement de l'habitat* may also hold securities, instruments and deposits which are sufficiently secure and liquid, as replacement assets (*valeurs de remplacement*) defined as exposures on credit institutions or investment firms benefiting from the highest level of credit assessment (*meilleur échelon de qualité de crédit*) assigned by an external rating agency recognised by the *Autorité de contrôle prudentiel* pursuant to article L. 511-44 of the French Monetary and Financial Code or guaranteed by credit institutions or investment firms benefiting of the same level of credit assessment (*échelon de qualité de crédit*), as well as debt securities issued or fully guaranteed by public sector entities as referred to in paragraphs 1 to 5 of article L. 515-15 of the French Monetary and Financial Code.

In accordance with, and pursuant to, the provisions of article L. 515-32-1 of the French Monetary and Financial Code, a *société de financement de l'habitat* may also, notwithstanding the provisions of articles 1300 of the *Code civil* (the **French Civil Code**) and L. 228-44 to L. 228-74 of the French Commercial Code, subscribe for its own *obligations de financement de l'habitat*, for the purpose of pledging them (*affecter en garantie*) as collateral security in order to secure the credit transactions (*opérations de crédit*) of the *Banque de France* in accordance with the terms and conditions determined by the *Banque de France* for its monetary and intraday credit policy, if the Issuer is not able to meet its cash requirements with the other resources available to it, provided that:

- (a) the total amount of the Notes subscribed by the Issuer does not exceed ten (10) per cent. of the total outstanding amount (*encours total*) of the resources benefiting from the *Privilège* as at the date of their subscription;
- (b) the Notes are disentitled of their rights under articles L. 228-46 to L. 228-89 of the French Commercial Code as long as the Issuer holds them;
- (c) the Notes are pledged for the benefit of the *Banque de France* within an 8-day period starting from the date on which they are paid and delivered (otherwise, such Notes shall be cancelled by the Issuer at the end of such 8-day period); and
- (d) they can not be subscribed by third parties.

In any case, the Notes subscribed by the Issuer shall be cancelled within an 8-day period starting from the date on which they cease to be pledged for the benefit of the *Banque de France*.

Finally, a *société de financement de l'habitat* may acquire and own any movable or immovable property which is necessary for the accomplishment of its corporate purpose or which derives from recovery of the receivables it holds.

A *société de financement de l'habitat* is not entitled to hold any equity interest (*participations*) in any entity in accordance with article L. 515-35, IV of the French Monetary and Financial Code.

See also the section entitled “Description of the Issuer – Issuer’s exclusive purpose and business overview”.

Privilège and non-privileged debts

Privilège

The *obligations de financement de l'habitat* issued by *sociétés de financement de l'habitat*, together with the other resources raised pursuant to an agreement or a document designed to inform the public (within the meaning of article L. 412-1 of the French Monetary and Financial Code) or any equivalent document required for the admission to trading on foreign regulated markets which mentions the *Privilège*, and the liabilities resulting from derivative transactions relating to the hedging of *obligations de financement de l'habitat* and other privileged debts in accordance with article L. 515-18 of the French Monetary and Financial Code benefit from the *Privilège* set out under article L. 515-19 of the French Monetary and Financial Code.

Pursuant to article L. 515-19 of the French Monetary and Financial Code, notwithstanding any legal provisions to the contrary and in particular the provisions included in the French Commercial Code relating to the prevention and conciliation of business difficulties and to the judicial administration and liquidation of companies:

- (a) the sums resulting from the loans, assimilated receivables and securities as referred to in articles L. 515-14 to L. 515-17 of the French Monetary and Financial Code and from the financial instruments used for hedging as referred to in article L. 515-18 of the French Monetary and Financial Code (in each case after any applicable set-off), together with the claims in respect of deposits made by a *société de financement de l'habitat* (i.e. the issuer of *obligations de*

financement de l'habitat, such as the Issuer) with credit institutions, are allocated in priority to the payment of any sums due in relation to the *obligations de financement de l'habitat* such as the Notes, to other resources benefiting from the *Privilège* as mentioned in article L. 515-36-I of the French Monetary and Financial Code, to derivative transactions used for hedging, under the condition of article L. 515-18 of the French Monetary and Financial Code and to other ancillary expenses and sums expressly referred to in article L. 515-19 of the French Monetary and Financial Code;

- (b) when a *société de financement de l'habitat* such as the Issuer is subject to any safeguard procedure (*procédure de sauvegarde*), judicial reorganisation (*redressement judiciaire*) or liquidation (*liquidation judiciaire*) or to conciliation proceedings with its creditors (*procédure de conciliation*), the amounts due regularly from the operations referred to in article L. 515-36-I of the French Monetary and Financial Code are paid on their contractual due date, and in priority to all other debts, whether or not preferred or secured, including interest resulting from agreements whatever their duration. No other creditor of a *société de financement de l'habitat* such as the Issuer may exercise any right over the assets and rights of such *société de financement de l'habitat* until all creditors benefiting from the *Privilège* have been fully paid off; and
- (c) the judicial liquidation of a *société de financement de l'habitat* such as the Issuer, will not result in the acceleration of payment of *obligations de financement de l'habitat* such as the Notes and other debts benefiting from the *Privilège*.

Non-privileged debts

Sociétés de financement de l'habitat may also raise other resources which do not benefit from the *Privilège*. Such other resources include:

- (a) loans or resources raised pursuant to an agreement or a document designed to inform the public (within the meaning of article L. 412-1 of the French Monetary and Financial Code) or any equivalent document required for the admission to trading on foreign regulated markets that does not mention the *Privilège*;
- (b) promissory notes (*billets à ordre*) issued pursuant to and in accordance with the provisions of articles L. 313-43 to L. 313-48 of the French Monetary and Financial Code which, as an exception to article L. 313-42 of the said code, are issued in order to refinance home loans receivables (*créances de prêts à l'habitat*); and
- (c) temporary transfers of its securities as provided for in articles L. 211-22 to L. 211-34 of the French Monetary and Financial Code, pledge of a securities account as defined in article L. 211-20 of the French Monetary and Financial Code and transfer of all or part of its receivables in accordance with articles L. 211-36 to L. 211-40 or in accordance with articles L. 313-23 *et seq.* of the French Monetary and Financial Code, regardless of their nature, professional or otherwise. The receivables and securities so refinanced are not taken into account for the purpose of determining the cover ratio of the resources benefiting from the *Privilège*.

Cover ratio

Sociétés de financement de l'habitat must at all times maintain a cover ratio between their assets and their “privileged” liabilities. According to article R. 515-7-2 of the French Monetary and Financial Code, *sociétés de financement de l'habitat* must at all times maintain a ratio of at least 102 per cent. of their assets to the total amount of their liabilities which have the benefit of the *Privilège*, provided however that all assets which have been transferred to a *société de financement de l'habitat* following the enforcement of the guarantee securing the loans granted by it (as the case may be) shall be included among the assets shown in the balance sheet of the *société de financement de l'habitat* instead of its receivables.

Sociétés de financement de l'habitat must appoint a specific controller (*contrôleur spécifique*) with the approval of the *Autorité de contrôle prudentiel* whose task is to ensure that the cover ratio is complied

with at all times. In particular, the specific controller must certify that the cover ratio is satisfied in connection with (i) the *société de financement de l'habitat's* quarterly programme of issues benefiting from the *Privilège* and (ii) any specific issue also benefiting from the *Privilège* whose amount is greater than Euro 500 million. The specific controller must verify the quality of the assets, the process of yearly revaluation and the quality of the asset liability management. The specific controller (as further described in the paragraph entitled “Specific controller” below) has access to information that allows confirmation of each issue’s compliance with the cover ratio. This cover ratio is published twice a year and checked on a quarterly basis and for each issuance of *obligations de financement de l'habitat* for an amount greater than Euro 500 million by the specific controller. For this purpose, the Final Terms relating to each issuance of *obligations de financement de l'habitat* will attach certificates from the specific controller substantially in the form set out in the section entitled “Form of Final Terms”, as applicable.

Liquidity

In accordance with article R. 515-7-1 of the French Monetary and Financial Code, a *société de financement de l'habitat* must ensure at any time the funding of its liquidity needs over a period of 180 days, taking into account the provisional fund flows arising from the principal and interest amounts over its assets and the amounts relating to the forward financial instruments (*instruments financiers à terme*) referred to in article L. 515-18 of the French Monetary and Financial Code. The needs in cash are fulfilled with replacement assets (*valeurs de remplacement*), assets which are eligible for the credit operations of the *Banque de France* in accordance with the procedures and conditions set forth by the latter in the context of its monetary policy and intraday credit operations and refinancing agreements entered into with credit institutions benefiting from the highest level of credit assessment (*meilleur échelon de qualité de crédit*) assigned by an external rating agency recognised by the *Autorité de contrôle prudentiel* pursuant to article L. 511-44 of the French Monetary and Financial Code or guaranteed by other corporates benefiting from the same level of credit assessment (*échelon de qualité de crédit*).

Hedging

The Issuer may enter into forward financial instruments to hedge its interests and currency on the exposures set out in articles L. 515-15 to L. 515-17 of the French Monetary and Financial Code, on the *obligations de financement de l'habitat* and on other resources whether or not benefiting from the *Privilège*. Any amounts payable pursuant to these forward financial instruments, after the applicable set-off as the case may be, benefit from the *Privilège*, unless such forward financial instruments were not concluded by the Issuer to hedge items of its assets and/or privileged liabilities or the global risk on its assets, liabilities and off-balance sheet items in accordance with article L. 515-18 of the French Monetary and Financial Code.

Insolvency derogating regime

Article L. 515-27 of the French Monetary and Financial Code precludes the extension of any safeguard procedure (*procédure de sauvegarde*), judicial reorganisation (*redressement judiciaire*) or liquidation (*liquidation judiciaire*) in respect of the *société de financement de l'habitat's* shareholders to the *société de financement de l'habitat*.

The French Monetary and Financial Code provides for a regime which derogates in many ways from the French legal provisions relating to insolvency proceedings. In particular, in the event of safeguard procedure (*procédure de sauvegarde*), judicial reorganisation (*redressement judiciaire*) or liquidation (*liquidation judiciaire*) of a *société de financement de l'habitat*, all claims benefiting from the *Privilège*, including interest thereon, must be paid on their due dates and in preference to all other claims, whether or not secured or statutorily preferred and, until payment in full of all such preferred claims, no other creditors may take any action against the assets of the *société de financement de l'habitat*.

In addition, certain nullity of transactions entered into during the hardening period (*période suspecte*) are not applicable for transactions or acts entered into by a *société de financement de l'habitat*,

provided that such transactions and acts are made in accordance with the exclusive legal purpose of the *société de financement de l'habitat* and without fraud. Pursuant to article L. 515-28 of the French Monetary and Financial Code, in the case of an opening of any safeguard procedure (*procédure de sauvegarde*), judicial reorganisation (*redressement judiciaire*) or liquidation (*liquidation judiciaire*) against the credit institution which is acting as manager and servicer of the assets and liabilities of the *société de financement de l'habitat*, the recovery, management and servicing contract may be immediately terminated by the *société de financement de l'habitat* notwithstanding any legal provisions to the contrary.

Specific controller

In each *société de financement de l'habitat*, a specific controller (*contrôleur spécifique*) and a substitute specific controller (*contrôleur spécifique suppléant*) are in charge of ensuring the compliance of the *société de financement de l'habitat* with the legal framework described above. The specific controller and the substitute specific controller are selected from the official list of auditors and appointed by the officers of the *société de financement de l'habitat* with the approval of the *Autorité de contrôle prudentiel*.

Pursuant to article L. 515-38 of the French Monetary and Financial Code, the tasks of the specific controller are:

- (a) to ensure that the *société de financement de l'habitat* complies with articles L. 515-34 to L. 515-36 of the French Monetary and Financial Code;
- (b) to certify that the cover ratio is satisfied in connection with (i) the *société de financement de l'habitat's* quarterly programme of issues benefiting from the *Privilège* and (ii) any issue of resources benefiting from the *privilège* and whose amount is greater than Euro 500 million;
- (c) to ensure that the home loans (*prêts à l'habitat*) granted or refinanced by the *société de financement de l'habitat* comply with the purpose of article L. 515-34 of the French Monetary and Financial Code and with the requirements set out in articles L. 515-35 *et seq.* of the French Monetary and Financial Code;
- (d) to control, when the home loans (*prêts à l'habitat*) granted or financed by the *société de financement de l'habitat* are subject to a guarantee (*cautionnement*) from another credit institution or an insurance company included in the consolidation scope, as defined by article L. 233-16 of the French Commercial Code as applicable to the *société de financement de l'habitat*, the risks assessment methods established by such credit institution or insurance company are adequate, in accordance with article R. 515-17 of the French Monetary and Financial Code; and
- (e) to review, pursuant to article 12 of the CRBF Regulation, the level of rate and maturity matching between the assets and the liabilities. In case the specific controller believes that the level of rate and maturity matching would create excessive risks for the creditors benefiting from the *privilège*, the specific controller informs the officers of the relevant *société de financement de l'habitat* and the *Autorité de contrôle prudentiel*.

The specific controller attends all shareholders' meetings and, on his request, may be heard by the board of directors of the *société de financement de l'habitat* (article L. 515-30 of the French Monetary and Financial Code).

The specific controller is entitled to receive all the documents and information necessary to the fulfilment of its mission and to perform, under certain conditions, any audit and control in the premises of the *société de financement de l'habitat*. The specific controller prepares annual reports on the accomplishment of his missions to the management of the *société de financement de l'habitat*, a copy of which is delivered to the *Autorité de contrôle prudentiel*.

DESCRIPTION OF THE ISSUER

Incorporation, duration and registered office

The Issuer is a credit institution (*établissement de crédit*), licensed as a financial company (*société financière*) having opted for the status of *sociétés de financement de l'habitat*, incorporated under French law on 21 février 2003 for a period of 99 years as a *société anonyme à conseil d'administration*. The Issuer was initially named "Virix"; it changed its name into "Société Générale France Habitat Financement" (SG FHF) on 10 December 2010 and into "Société Générale SFH" on 18 April 2011. The Issuer is registered under the name of Société Générale SFH in the Commercial and Companies Registry (*Registre du Commerce et des Sociétés*) of Nanterre under number 445 345 507. The Issuer's office is at 17, cours Valmy, 92800 Puteaux, France, its telephone number: +33 (0)1 42 14 29 22. On 28 March 2011, the Issuer was authorised to act as a *société de financement de l'habitat* by the *Autorité de contrôle prudentiel*.

The Issuer is governed by the legal and regulatory provisions applicable to commercial companies (*sociétés commerciales*) (including, without limitation, articles L. 210-1 *et seq.* of the French Commercial Code), to credit institutions and to *sociétés de financement de l'habitat* (articles L. 515-14, L. 515-16, L. 515-17 to L. 515-32-1, L. 515-34 *et seq.* and R. 515-2, R. 515-4, R. 515-5, R. 515-7 to R. 515-11 and R. 515-12 to R. 515-17 of the French Monetary and Financial Code, article 74 of law n°2010-1249 of 22 October 2010 on banking and financial regulation and the CRBF Regulation) (see the section entitled "Summary of the legislation and regulations relating to *sociétés de financement de l'habitat*").

The Issuer is a member of the Société Générale group.

Share capital

The Issuer's share capital, as at the date of this Base Prospectus, amounts to EUR 375,000,000 divided into 37,500,000 fully paid-up ordinary shares of Euro 10. At the date of this Base Prospectus, 99.99 per cent of this share capital is owned by Société Générale and the remainder by the members of the board of directors (*conseil d'administration*) of the Issuer who each hold one share of the Issuer share capital.

There is no authorised and unissued share capital. There are no securities which grant rights to shares in the capital of the Issuer. All shares have equal voting rights.

On 4 August 2009, Société Générale formalised a declaration of financial support for its subsidiary Société Générale SFH (formerly known as Société Générale France Habitat Financement (FHF)). The text of the declaration of financial support is translated (for information purposes only) as follows:

"Paris, 4 August 2009

*Dear Madam,
Dear General Secretary,*

In order to allow Société Générale France Habitat Financement, a 99.9% subsidiary of Société Générale, which has been licensed as a credit institution (établissement de crédit), to benefit from the provisions of article 4.1 of regulation n° 2000-03 of the Comité de la réglementation bancaire et financière, we hereby undertake to the Commission bancaire to grant Société Générale France Habitat Financement our support so as to ensure its general solvability and liquidity. Additionally, we will ensure that it will be managed in a reasonable manner pursuant to the applicable financial law.

We will indeed inform you in advance of any change that would affect this representation if we wanted not to allow any more Société Générale France Habitat Financement to benefit from article 4.1. In such a case, this representation would terminate on the date on which the Commission bancaire considers that Société Générale France Habitat Financement complies with the supervision rules on an individual or sub-consolidated basis.

We hereby confirm to have the powers to make this representation and to have informed the board of directors of such representation during the meeting of 4 August 2009.

Issuer's exclusive purpose and business overview

In accordance with articles L. 515-34 *et seq.* of the French Monetary and Financial Code which defines the exclusive legal purpose of the *sociétés de financement de l'habitat* and with article 5 of its by-laws (*statuts*), the Issuer's exclusive purpose consists of carrying out the activities and operations below, whether in France or abroad:

Credit operations and assimilated operations

The Issuer may:

- (a) grant to Société Générale, or to any other company controlled by Société Générale within the meaning of article L. 233-3 of the French Commercial Code and licensed as a credit institution, loans guaranteed by the collateralisation (*remise*), the assignment or the pledge of home loans receivables (*créances de prêts à l'habitat*) (as defined in paragraph (d) below) granted by Société Générale or by any other company controlled by Société Générale within the meaning of article L. 233-3 of the French Commercial Code and licensed as a credit institution, benefiting from the provisions of articles L. 211-36 to L. 211-40 or articles L. 313-23 to L. 313-35 of the French Monetary and Financial Code, regardless of the nature of such receivables, professional or otherwise;
- (b) subscribe for or purchase on over-the-counter markets (*marchés de gré à gré*) or pursuant to any other way complying with the then applicable legislation, units or notes issued by French securitisation vehicles (*organismes de titrisation*), or by any similar foreign entities in

accordance with the provisions of article L. 515-16 of the French Monetary and Financial Code and which assets consist of, except for sums temporarily available and pending allocation, guarantees, security interest or other privileges benefiting to those notes or units, as well as securities kept by these securitisation vehicles or similar entities as reserve or guarantee in accordance with the applicable legislation, at least 90% of home loans receivables (*créances de prêts à l'habitat*) (as defined in paragraph (d) below) granted by Société Générale or by any other company controlled by Société Générale within the meaning of article L. 233-3 of the French Commercial Code and licensed as a credit institution and under the conditions set out in such article;

- (c) purchase or subscribe for promissory notes (*billets à ordre*) issued by any credit institution pursuant to and in accordance with the provisions of articles L. 313-43 to L. 313-48 of the French Monetary and Financial Code and which, as an exception to article L. 313-42 of the said code, are issued in order to refinance home loans receivables (*créances de prêts à l'habitat*) (as defined in paragraph (d) below) granted by Société Générale or by any other company controlled by Société Générale within the meaning of article L. 233-3 of the French Commercial Code and licensed as a credit institution;
- (d) grant loans which:
 - (i) aim at financing, in whole or in part, residential real property located in France or another European Union Member State or an European Economic Area Member State or a State benefiting from the highest level of credit assessment (*meilleur échelon de qualité de crédit*) assigned by an external rating agency recognised by the *Autorité de contrôle prudentiel* pursuant to article L. 511-44 of the French Monetary and Financial Code; and
 - (ii) are guaranteed by a first-ranking mortgage or a charge over real property which provides a guarantee at least equal thereto or a guarantee (*cautionnement*) granted by a credit institution or an insurance company.

Acquisition and ownership of assets

The Issuer may, in accordance with, and pursuant to, the provisions of article L. 515-35, III of the French Monetary and Financial Code, acquire and own any movable or immovable property which is necessary for the accomplishment of its corporate purpose or which derives from recovery of the receivables it holds and enter into with any third party any agreement relating to the acquisition, the holding, the management, the maintenance or the sale of the said property.

Subscription of its own obligations de financement de l'habitat

In accordance with, and pursuant to, the provisions of article L. 515-32-1 of the French Monetary and Financial Code, and notwithstanding the provisions of articles 1300 of the French Civil Code and L. 228-44 to L. 228-74 of the French Commercial Code, the Issuer may subscribe for its own *obligations de financement de l'habitat*, up to 10% of its total outstanding privileged resources, with the exclusive objective to collateralise them as security for the credit operations of the *Banque de France* in accordance with the procedures and conditions set forth by the latter in the context of its monetary policy and intraday credit operations.

Financing of the operations mentioned above

In order to finance the operations falling within its corporate purpose as mentioned above, the Issuer may:

- (a) issue *obligations de financement de l'habitat*, together with the other resources raised pursuant to an agreement or a document designed to inform the public (within the meaning of article L. 412-1 of the French Monetary and Financial Code) or any equivalent document required for the admission to trading on foreign regulated markets which mentions the *Privilège*, and the

liabilities resulting from derivative transactions relating to the hedging of *obligations de financement de l'habitat* and other privileged debts in accordance with article L. 515-18 of the French Monetary and Financial Code benefit from the *Privilège* set out under article L. 515-19 of the French Monetary and Financial Code; and

- (b) raise other resources which do not benefit from such *Privilège*, including:
 - (i) loans or resources raised pursuant to an agreement or a document designed to inform the public (within the meaning of article L. 412-1 of the French Monetary and Financial Code) or any equivalent document required for the admission to trading on foreign regulated markets that does not mention the *Privilège*;
 - (ii) promissory notes (*billets à ordre*) issued pursuant to and in accordance with the provisions of articles L. 313-43 to L. 313-48 of the French Monetary and Financial Code which, as an exception to article L. 313-42 of the said code, are issued in order to refinance home loans receivables (*créances de prêts à l'habitat*); and
 - (iii) temporary transfers of its securities as provided for in articles L. 211-22 to L. 211-34 of the French Monetary and Financial Code, pledge of a securities account as defined in article L. 211-20 of the French Monetary and Financial Code and transfer of all or part of its receivables in accordance with articles L. 211-36 to L. 211-40 or in accordance with articles L. 313-23 et seq. of the French Monetary and Financial Code, regardless of their nature, professional or otherwise. The receivables and securities so refinanced are not taken into account for the purpose of determining the cover ratio of the resources benefiting from the *Privilège*.

Hedging arrangements

The Issuer may also enter into forward financial instruments to hedge its interests and currency on the exposures, as set out in articles L. 515-15 to L. 515-17 of the French Monetary and Financial Code, on the *obligations de financement de l'habitat* and on other resources benefiting from the *Privilège*.

In this respect, it should be noted that the FCT Notes bear interest at a floating rate plus a margin, while the Notes may bear interest at a fixed rate or at a floating rate plus a margin with a floating rate based on an index different from the index on which the floating rate of the FCT Notes is based. In order to hedge the Issuer against this interest rate risk, the Issuer has entered into the Swap Agreement with Société Générale.

Activities and operations relating to its corporate purpose

In order to accomplish its corporate purpose, the Issuer may also enter with Société Générale into:

- (a) an outsourcing and assistance agreement (*convention d'externalisation et d'assistance*);
- (b) an agreement for the delegation of the tasks relating to the periodic supervision of the Issuer (*convention de délégation des tâches d'exécution du contrôle périodique*); and
- (c) a receivables management and servicing agreement (*convention-cadre de gestion et de recouvrement de créances*).

The Issuer may also enter into any agreement relating to the subscription for the securities mentioned above and any agreement the purpose of which is to ensure:

- (i) the management of the *obligations de financement de l'habitat* and its other resources;
- (ii) any services necessary for the management of the assets, liabilities and financial positions of the Issuer;

- (iii) the payment of the loans granted by the Issuer and their refinancing;
- (iv) the funding of its liquidity needs, in accordance with the laws and regulations applicable to *sociétés de financement de l'habitat* ; and
- (v) the hedging of the risks related to the borrowers, the risks related to the collateral granted as security to the loans and assets hold by the Issuer, or any other liability of the Issuer and its agents.

For further details regarding the agreements already entered into by the Issuer, see the section entitled “Relationship between Société Générale SFH and Société Générale”.

The Issuer may participate in any clearing system, interbank settlement system (*ystème de règlements interbancaires*), securities delivery and payment system (*ystème de règlement-livraison de titres*), as well as any activity within the context of the monetary policy of the European Central Bank.

More generally, the Issuer may perform any ancillary activities relating to its business or for the purpose of achieving its corporate purpose, as soon as these activities comply with the corporate purpose of *sociétés de financement de l'habitat* as it is defined in legal and mandatory legislation applying to their activities.

For a description of the legal framework applicable to *sociétés de financement de l'habitat*, see the section entitled “Summary of the legislation and regulations relating to *sociétés de financement de l'habitat*”.

At the date of this Base Prospectus, it is contemplated that the assets of the Issuer will mainly be constituted of FCT Notes subscribed by the Issuer pursuant to the Master Subscription Agreement.

See the section entitled “Relationship between Société Générale SFH and Société Générale”.

The formation of the Issuer takes place as part of the Société Générale refinancing and is intended to lower the overall cost of funding for the Société Générale group by refinancing eligible assets at a competitive cost.

The *obligations de financement de l'habitat* which will be issued by the Issuer are expected to be rated AAA by Fitch Ratings and Aaa by Moody's and listed on Euronext Paris. By offering the market AAA/Aaa rated *obligations de financement de l'habitat*, which are a reflection, among other factors, of the intrinsic quality of the assets of the Issuer, the Issuer aims to increase the competitiveness of the Société Générale group. By providing the market with a new counterparty (in addition to Société Générale), the Issuer should increase the Société Générale group's investor base.

Pursuant to article R. 515-7-2 of the French Monetary and Financial Code, the Issuer must at all times maintain a ratio of at least 102 per cent. of its assets to the total amount of its liabilities benefiting from the *Privilège*, as described in the section entitled “Summary of the legislation and regulations relating to *sociétés de financement de l'habitat*”.

Subsidiaries

The Issuer is not entitled to hold any equity interest (*participations*) in any entity in accordance with article L. 515-35, IV of the French Monetary and Financial Code.

Management of the Issuer

The Issuer is run by a board of directors (*conseil d'administration*).

The Issuer's board of directors, which at the date of this Base Prospectus comprises 11 members, including Société Générale, has full powers to act in all circumstances on behalf of the Issuer within the

limits set by its internal rules and the by-laws (*statuts*) of the Issuer and subject to the powers expressly conferred by the French Commercial Code on shareholders in general meetings.

The chairman of the board of directors (*président du conseil d'administration*), who is also Group Treasurer of Société Générale group, organises and directs the work of the board of directors, of which he shall give an account at the shareholders' meetings, ensures that the governing bodies of the Issuer operate properly, and that the directors are able to perform their duties.

The management of the Issuer consists of the chairman of the board of directors as chief executive officer (*directeur général*) and two deputy chief executive officers (*directeurs généraux délégués*). All of them are vested with the broadest powers to act in all circumstances on behalf of the Issuer within the limits of the corporate purpose, and subject to the powers expressly attributed by law to shareholders' meetings and the special powers of the board of directors. They represent the Issuer in its relationships with third parties.

The Issuer identified no potential conflicts of interest between the duties owed to it by the members of the board of directors (*membres du conseil d'administration*) and their private interests.

Control of the Issuer

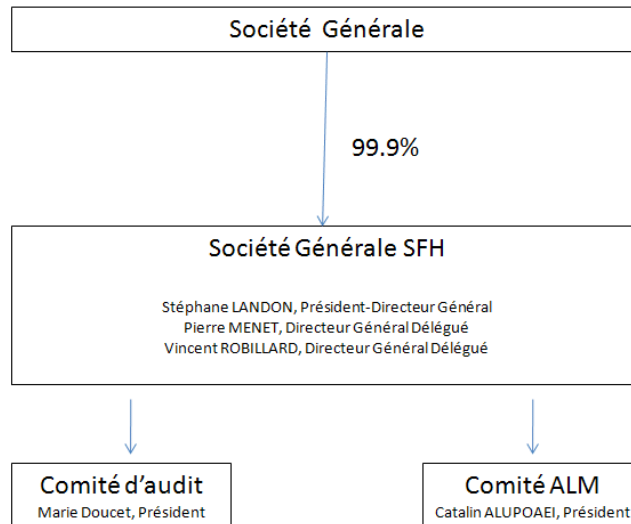
Argos was initially appointed as statutory auditor of the Issuer. Its appointment terminated on 31 December 2008. The Issuer has subsequently appointed Ernst & Young Audit as sole statutory auditor (*commissaire aux comptes*) in 2009 and Deloitte & Associés as co-statutory auditor (*commissaires aux comptes*) in 2010. The Issuer has also appointed Picarle et Associés as substitute statutory auditor (*commissaire aux comptes suppléant*) of Ernst & Young Audit and Béas as substitute statutory auditor (*commissaire aux comptes suppléant*) of Deloitte & Associés, in compliance with applicable laws and regulations (for further details, see the section entitled “General information – paragraph (9)”).

The Issuer has also appointed, in accordance with articles L. 515-30, L. 515-31 and L. 515-38 of the French Monetary and Financial Code, Cailliau Dedouit et Associés as specific controller (*contrôleur spécifique*) and Didier Cardon as substitute specific controller (*contrôleur spécifique suppléant*).

Under Regulation n° 97-02 of 21 February 1997, as amended from time to time, of the *Comité de la réglementation bancaire et financière* relating to the internal control of the credit institutions and the financial companies, the board of directors of the Issuer set up an audit committee. The audit committee is responsible in particular, under the supervision of the board of directors, for (i) reviewing the accounts of the Issuer before their presentation to the board of directors, (ii) ensuring that the accounting methods used to prepare the individual accounts are relevant and consistent, and (iii) advising on the organisation of the internal audit.

At the date of this Base Prospectus, the Issuer has also set-up an asset and liabilities management (*ALM*) committee. The ALM committee examines the ALM policy of the Issuer, ensures that checks and procedures relating to the Issuer’s ALM policy are effective and attends to the effective application of principles in force within Société Générale with respect to risk management in connection with entering into forward financial instruments in order to give the Issuer complete protection from rate and currency risks.

The management of the Issuer can thus be summarised by the following chart:



Staff

The Issuer has no human resources. Its technical administration has been subcontracted to its parent, Société Générale, which acts in accordance with the instructions of the Issuer’s board of directors, pursuant to the Outsourcing and Assistance Agreement and any document entered into between the Issuer and Société Générale in relation thereto (see the section entitled “Relationship between Société Générale SFH and Société Générale”).

Compliance with the corporate governance regulations

The Issuer complies with the corporate governance regulations applicable to French companies.

Membership of professional organisation

The Issuer is member of the Association Française des Sociétés Financières, 24, avenue de la Grande Armée, 75584 Paris CEDEX 17.

USE OF PROCEEDS

The net proceeds of the issues of the Notes will be used for financing:

- (a) the subscription by the Issuer of the FCT Notes issued from time to time by the FCT pursuant to the Master Subscription Agreement; and
- (b) from time to time, the creation or acquisition of the other assets of the Issuer, in accordance with its by-laws (*statuts*) and articles L. 515-34 *et seq.* of the French Monetary and Financial Code.

RELATIONSHIP BETWEEN SOCIÉTÉ GÉNÉRALE SFH AND SOCIÉTÉ GÉNÉRALE

Société Générale SFH entered into, *inter alia*, the following contracts:

- the Management and Servicing Agreement, pursuant to which Société Générale shall carry out, in accordance with article L. 515-22 of the French Monetary and Financial Code, the administration and recovery of the receivables of Société Générale SFH (in particular those which would be purchased by Société Générale SFH from subsidiaries of Société Générale), and any document entered into between the Issuer and Société Générale in relation thereto (see the section entitled “General description of the Programme – Programme Documents”);
- the Outsourcing and Assistance Agreement, pursuant to which Société Générale shall fulfil regulatory obligations of permanent supervision, periodic supervision and compliance supervision on behalf of Société Générale SFH and shall provide Société Générale SFH with certain services required by the operations of Société Générale SFH, in particular for financial (financial management) and legal purposes, and any document entered into between the Issuer and Société Générale in relation thereto (see the section entitled “General description of the Programme – Programme Documents”);
- the Master Subscription Agreement, pursuant to which the Issuer shall subscribe the FCT Notes issued on each FCT Issue Date by the FCT, subject to and in accordance with the terms set out therein;
- the Programme Guarantee, pursuant to which Société Générale has granted the Guarantee in favour of the Issuer and has undertaken to cash collateralize its obligations up to the amount of the Guarantee Limit in the event that it ceases to comply with the Rating Condition; and
- the Swap Agreement, pursuant to which Société Générale has agreed to act as Swap Counterparty in relation to the Programme and to hedge any interest rate risk over the Notes.

DESCRIPTION OF THE FCT AND THE FCT PROGRAMME

The description below does not purport to be complete and should be read in conjunction with, and is qualified in its entirety by reference to, the more detailed information which appears in the FCT Base Prospectus, as amended or supplemented from time to time.

General description of the FCT Programme

On 28 January 2009 (the **FCT Establishment Date**), Paris Titrisation as the FCT Management Company and Société Générale, as the FCT Custodian, acting severally (*conjointement*) as co-founders, established the FCT, a French securitisation fund (*fonds commun de titrisation*) governed by the provisions of articles L. 214-5, L. 214-42-1 to L. 214-48, L. 214-49-4 to L. 214-49-13, L. 231-7, R. 214-92, R. 214-93, D. 214-94, R. 214-95 to R. 214-101, D. 214-102 to D. 214-104 and R. 214-105 of the French Monetary and Financial Code and the regulations (*règlement*) entered into on or before the FCT Establishment Date between the FCT Management Company and the FCT Custodian (the **FCT Regulations**).

The FCT, subject to compliance with all relevant laws, regulations and directives, may issue from time to time thereafter, the FCT Notes and issued on the FCT Establishment Date two (2) residual units (the **FCT Residual Units**), such issuance constituting an asset-backed debt issuance programme (the **FCT Programme**).

The aggregate nominal amount of the FCT Notes outstanding under the FCT Programme shall not at any time exceed €25,000,000,000. The principal outstanding amount of the FCT Notes, as at the date of this Base Prospectus, is €21,000,000,000.

The FCT Notes shall only be offered and sold (i) in France to qualified investors (*investisseurs qualifiés*) provided that such investors are acting for their own account and/or to persons providing portfolio management financial services (*personnes fournissant le service d'investissement de gestion de portefeuille pour compte de tiers*), as defined in, and in accordance with, article L. 411-2, II of the French Monetary and Financial Code and/or (ii) to non-resident investors (*investisseurs non-résidents*).

The FCT Notes will be privately placed through Société Générale (the **Lead Manager**) or subscribed by the Issuer or any other entity within the consolidation perimeter of the Lead Manager on each issue date.

Application was made to the AMF for approval of the base prospectus relating to the FCT Programme (the **FCT Base Prospectus**) in its capacity as competent authority under French law securities and for the purpose of listing the FCT Notes issued under the FCT Programme on Euronext Paris.

Pursuant to articles L. 412-1 and L. 621-8 of the French Monetary and Financial Code and of the AMF General Regulations, and in particular of articles 211-1 to 216-1 and 421-1 thereof, the FCT Base Prospectus and the final terms corresponding to the first four series of FCT Notes issued by the FCT on the FCT Establishment Date were granted by the AMF a visa n°09-01 on 27 January 2009.

In the context of the issue by the FCT of the fifth, sixth and seventh series of FCT Notes on 28 June 2010, 25 October 2010 and 28 January 2011, respectively, the FCT Base Prospectus was updated and was granted by the AMF a visa n°10-02 on 25 June 2010, a visa n°10-06 on 21 October 2010 and a visa n°11-01 on 25 January 2011. The FCT Base Prospectus was lastly updated and amended and was granted by the AMF a visa n°11-04 on 20 April 2011.

The FCT Base Prospectus was published on the website of Euronext Paris (www.euronext.com). The final terms related to the FCT Notes were published on the website of Euronext Paris (www.euronext.com). Copies of the FCT Base Prospectus and various other relating documents are available free of charge during normal business hours at the registered office of the FCT and at the specified office of Société Générale acting in its capacity as paying agent under the FCT Programme.

For further details, see the section entitled “General description of the Programme” of the FCT Base Prospectus.

Legal framework applicable to the FCT

The FCT is a French *fonds commun de titrisation* governed by the provisions of articles L. 214-5, L. 214-42-1 to L. 214-48, L. 214-49-4 to L. 214-49-13, L. 231-7, R. 214-92, R. 214-93, D. 214-94, R. 214-95 to R. 214-101, D. 214-102 to D. 214-104 and R. 214-105 of the French Monetary and Financial Code and the FCT Regulations.

Pursuant to article L. 214-49-4 of the French Monetary and Financial Code, the FCT is a co-ownership (*copropriété*) established by the FCT Management Company and the FCT Custodian, acting severally (*conjointement*) as co-founders, whose purpose is, in accordance with and subject to the provisions of the FCT Regulations:

- (a) to purchase receivables (as more fully described below); and
- (b) to issue from time to time FCT Notes in order to finance the purchase price of such receivables.

The FCT does not have separate legal personality (*personnalité morale*). The legal provisions relating to joint ownership (*indivision*) together with articles 1871 to 1873 of the French Civil Code do not apply to the FCT. The FCT will be validly substituted for the co-owners with respect to any transaction made in the name and on behalf of the co-owners of the Issuer.

The FCT is not allowed to enter into repurchase transactions or any other transaction involving the temporary sale or acquisition of securities in the conditions set out in article R. 214-100 of the French Monetary and Financial Code.

The FCT is also entitled to enter into interest rate hedging swaps in accordance with article R. 214-99 of the French Monetary and Financial Code).

The FCT does not have any compartment.

For further description, see the sections entitled “General information relating to the Issuer” of the FCT Base Prospectus and “Operation of the Issuer” of the FCT Base Prospectus.

FCT’s assets

Pursuant to the FCT Regulations, the assets of the FCT will include:

- (a) receivables (the ***Loan Receivables***) arising from the rights of Société Anonyme de Crédit à l’Industrie Française-CALIF (***CALIF***) to receive payments of interest and repayments of principal together with all ancillary rights relating thereto under each advance made by CALIF to Société Générale (the ***Borrower Loans***) to finance loans granted by Société Générale to individuals for the purpose of financing properties located in France (the ***Underlying Home Loans***) and purchased by the FCT from CALIF from time to time;
- (b) all available moneys pending allocation and standing from time to time to the credit of the accounts of the FCT (the ***FCT Available Cash***);
- (c) certain assets complying with eligibility criteria (including the Underlying Home Loans) which have been transferred by way of security as collateral (*remis en pleine propriété à titre de garantie*), pursuant to article L. 211-38 *et seq.* of the French Monetary and Financial Code, by Société Générale to CALIF in order to secure the full and timely payment of the Borrower Loans to CALIF (the ***Collateral Security***) and which, further to the purchase of the Loan Receivables by the FCT, have been transferred to the FCT;

- (d) where applicable, assets transferred to the FCT further to its commitments under any hedging arrangements (as the case may be); and
- (e) any other sums or other assets from which the FCT might benefit in any way whatsoever, in accordance with the FCT Regulations and the other FCT Programme Documents.

For further description, see the sections entitled “Origination of the Home Loans” of the FCT Base Prospectus and “Description of the assets of the Issuer” of the FCT Base Prospectus.

Until a Loan Event of Default (as defined in the section entitled “Description of the Facility Agreement – Loan Events of Default” of the FCT Base Prospectus, a ***Loan Event of Default***) occurs and been enforced, Société Générale, as calculation agent of the FCT (the ***FCT Calculation Agent***), will carry out a test to ensure that the amount of Collateral Security is at all time in place. Following the enforcement of a Loan Event of Default, the FCT Calculation Agent will carry out another test regarding the FCT’s assets (see the section entitled “Asset monitoring” of the FCT Base Prospectus).

Liquidation of the FCT

FCT Liquidation Events

The FCT Management Company will be entitled, in accordance with article R. 214-101 of the French Monetary and Financial Code, to liquidate the FCT upon the occurrence of certain circumstances affecting the FCT which are described in the section entitled “Liquidation of the Issuer – Issuer Liquidation Events” of the FCT Base Prospectus.

Clean-Up Offer

If the FCT Management Company has declared the liquidation of the FCT upon the occurrence of any of the liquidation events referred to in the paragraph “FCT Liquidation Events” above, the FCT Management Company will offer to CALIF the option to repurchase the outstanding Loan Receivables transferred to the FCT in whole, but not in part, within a single transaction, for a retransfer price sufficient so as to allow the FCT Management Company to pay all principal and interest amounts due and payable in respect of the outstanding FCT Notes and the FCT Residual Units after the payment of all liabilities of the FCT ranking higher in the relevant priority of payment order under the FCT Regulations (except if, and only if, it is in the interest of the holders of the FCT Notes and the FCT Residual Units).

In any event, CALIF will have the discretionary right to refuse such proposal. If CALIF refuses the FCT Management Company’s offer, the FCT Management Company will use its best endeavours to assign the remaining outstanding Loan Receivables to a credit institution (*établissement de crédit*) or such other entity authorised by French law and regulations to acquire the Loan Receivables under similar terms and conditions, or different terms and conditions if it is in the interest of the holders of FCT Notes and the FCT Residual Units.

Liquidation of the FCT

Description of the FCT Notes

Statuts

The FCT Notes are:

- (a) financial instruments (*instruments financiers*) within the meaning of article L. 211-1 of the French Monetary and Financial Code;
- (b) transferable securities (*valeurs mobilières*) within the meaning of article L. 211-2 of the French Monetary and Financial Code; and
- (c) bonds (*obligations*) within the meaning of article R. 214-99 of the French Monetary and Financial Code.

In accordance with the provisions of article L. 211-4 of the French Monetary and Financial Code, the FCT Notes are issued in dematerialised and bearer form (*au porteur*). No physical documents of title shall be issued in respect of the FCT Notes. The FCT Notes constitute direct and unconditional obligations of the FCT.

Series

The FCT Notes issued on any given issue date will constitute a series.

Terms and conditions

In accordance with the FCT Regulations, the terms and conditions applicable to each series of FCT Notes (the ***FCT Terms and Conditions***) will be:

- (a) the general terms and conditions set out in the section entitled “General Terms and Conditions of the Notes” of the FCT Base Prospectus, as completed and detailed by
- (b) the final terms and conditions to be set separately for that series of FCT Notes, in accordance with the procedure set out in the section entitled “Description of the Notes – Issue of the Notes” of the FCT Base Prospectus and based on the template set out in the section entitled “Form of Final Terms” of the FCT Base Prospectus (the ***FCT Final Terms***).

Currency

At the date of this Base Prospectus, all FCT Notes shall be issued in Euro.

Denomination

All FCT Notes shall have a denomination of €100,000.

Use of Proceeds

The net proceeds of the FCT Notes issued on a given issue date will be applied by the FCT Management Company mainly to finance the purchase of the Loan Receivable from Société Générale on such date (see the section entitled “Use of Proceeds” of the FCT Base Prospectus).

Relationship between the FCT Notes of a given series and of several series and relationship between the FCT Notes and the FCT Residual Units:

Payments of principal and interest under the FCT Notes will, on any date, be made subject to the FCT having sufficient FCT Available Funds on that date, and always subject to the applicable priority of payment order under the FCT Regulations on that date.

Payments of principal and interest in respect of the FCT Notes of a given series shall be made on a *pari passu* basis to each holder of an FCT Note of that series, *pro rata* to the number of FCT Notes owned by each holder.

On any date on which payments of interest and/or principal have to be made in respect of the FCT Notes of several series, such payments shall be made on a *pari passu* basis to each holder of an FCT Note of these series, *pro rata* to the number of FCT Notes owned by each holder.

Payments of principal and interest in respect of the FCT Residual Units are subordinated to payments of principal and interest in respect of the FCT Notes of any series.

For further description, see the section entitled “Operation of the Issuer – Priority of Payment Order” of the FCT Base Prospectus.

Rating of the FCT Notes

The FCT Notes issued under the FCT Programme are rated AAA by Fitch Ratings and Aaa by Moody’s (see the section entitled “Description of the Notes – Rating” of the FCT Base Prospectus).

Title and transfer of ownership

Ownership title to the FCT Notes is established by book entry to the register of the relevant FCT Noteholder, in accordance with article L. 211-4 of the French Monetary and Financial Code and the rules of Euronext Paris, together with those applicable to Euroclear France.

The FCT Notes are, upon issue, registered in the books of Euroclear France, which shall credit the accounts of account holders affiliated with Euroclear France.

The FCT Notes are transferred from the transferor’s account to the transferee’s account in accordance with the rules of Euronext Paris, together with those applicable to Euroclear France.

FCT Notes Payment Date

Payment dates of any series of FCT Notes (an ***FCT Notes Payment Date***) will be set out in the final terms of the FCT Notes in respect of each series (except that the FCT Notes Payment Dates will be the same for all series in the case of an FCT Enforcement Notice, as described in the section entitled “FCT Enforcement Notice” below and the section entitled “General Terms and Conditions of the Notes – Issuer Enforcement Notice and acceleration” of the FCT Base Prospectus).

FCT Notes Interest Periods

Interest period in respect of the FCT Notes means each period starting from (and including) an FCT Notes Payment Date and ending on (but excluding) the next following FCT Notes Payment Date (an ***FCT Notes Interest Period***), provided that the first FCT Notes Interest Period in respect of each series of FCT Notes shall start from (and including) the issue date of that series and end on (but excluding) the immediately following FCT Notes Payment Date.

Rate of interest of the FCT Notes

The interest rate payable in respect of the FCT Notes of a given series in respect of each FCT Notes Interest Period relating thereto will be the rate per annum equal to the aggregate of (i) EURIBOR for 3 month Euro deposits (or, if the length of the first FCT Notes Interest Period (the ***Length***) is not equal to 3 months, the EURIBOR applicable on a period of that Length; provided in addition that if that Length does not correspond to an exact number of months or to 1 week, the EURIBOR for such period will be determined through the use of straight-line interpolation by reference to two EURIBOR rates for EUR, one of which shall be determined as if the Length were the period of time for which rates are available next shorter than the Length and the other of which shall be determined as if the Length were the period of time for which rates are available next longer than the Length) and (ii) the margin indicated in the relevant FCT Final Terms (the ***Relevant Margin***).

There shall be no minimum or maximum interest rate for the FCT Notes.

Interest in respect of the FCT Notes is payable in Euro quarterly in arrears on each FCT Notes Payment Date in respect of the FCT Notes Interest Period ending immediately prior thereto.

Interest in respect of any FCT Notes Interest Period or any other period will be calculated on the basis of the actual number of days elapsed and a 360 day year.

Maturities

The date on which the FCT Notes of a given series are scheduled to be redeemed (the ***FCT Final Maturity Date***) shall be set out in the relevant FCT Final Terms.

Redemption at FCT Final Maturity Date:

FCT Notes will be redeemable in full on the FCT Final Maturity Date stated in the relevant FCT Final Terms, subject to any extension of that FCT Final Maturity Date as set out below. No payment of principal will occur under any FCT Note prior to the FCT Final Maturity Date applicable thereto, except in case of the issuance of an FCT Enforcement Notice or the occurrence of an FCT Notes Partial Amortisation Event or an FCT Notes Full Amortisation Event (as each of these events is more fully described below).

Extension of FCT Final Maturity Date:

All FCT Notes will have soft bullet maturities; it being noted that, if, on the initially scheduled FCT Final Maturity Date of a given series, the FCT does not have sufficient FCT Available Funds to redeem in full such FCT Notes or for any other reasons whatsoever, that FCT Final Maturity Date will be extended once, for a period of twelve (12) months provided that:

- (a) the new FCT Final Maturity Date (the ***FCT Extended Final Maturity Date***) of the relevant FCT Notes following that extension may not be extended;
- (b) the relevant FCT Notes can be redeemed in full or in part on any FCT Notes Payment Date falling between their initial FCT Final Maturity Date and that FCT Extended Final Maturity Date; and

- (c) the relevant FCT Notes shall be redeemed in full at the latest on that FCT Extended Final Maturity Date.

FCT Enforcement Notice

The terms and conditions of the FCT Notes will contain certain events of default, upon the occurrence of which the FCT representative may, at its discretion, and shall, if so directed by the majority of the FCT Noteholders, upon written notice (an ***FCT Enforcement Notice***) to the FCT (with copy to the Rating Agencies) given before all defaults shall have been cured, cause the principal amount of all FCT Notes of such series to become due and payable (but always subject to the relevant priority of payment order under the FCT Regulations) under the circumstances described in the section entitled “General Terms and Conditions of the Notes – Issuer Enforcement Notice and acceleration” of the FCT Base prospectus.

FCT Notes Partial Amortisation Event

FCT Notes of a given series issued in respect of any Borrower Loan will be redeemable in part by the FCT prior to their stated FCT Final Maturity Date, in case a voluntary redemption event occurs in respect of that Borrower Loan (as defined in the section entitled “Description of the Facility Agreement – Borrower Loan Voluntary Redemption Event” of the FCT Base Prospectus, a ***Borrower Loan Voluntary Redemption Event***) and Société Générale (as borrower under that Borrower Loan) decides to redeem the relevant Borrower Loan in part only (an ***FCT Notes Partial Amortisation Event***).

In such case all FCT Notes of the series issued in respect of such Borrower Loan will be redeemable up to the amount of principal repayable by Société Générale under the relevant Borrower Loan (but always subject to the relevant priority of payment order under the FCT Regulations) (see the section entitled “General Terms and Conditions of the Notes – Notes Partial Amortisation Event” of the FCT Base prospectus).

FCT Notes Full Amortisation Event

FCT Notes will be redeemable in full by the FCT prior to their stated FCT Final Maturity Date:

- (a) in case a Facility Mandatory Redemption Event (as defined in the section entitled “Description of the Facility Agreement – Facility Mandatory Redemption Events” of the FCT Base Prospectus) occurs, in which case all FCT Notes of all series will be redeemable;
- (b) in case a Borrower Loan Mandatory Redemption Event (as defined in the section entitled “Description of the Facility Agreement – Borrower Loan Mandatory Redemption Events” of the FCT Base Prospectus) and occurs, in which case all FCT Notes of the series issued in respect of the relevant Borrower Loan, and no other FCT Notes, will be redeemable;
- (c) in case a Borrower Loan Voluntary Redemption Event occurs in respect of a Borrower Loan and Société Générale (as borrower under that Borrower Loan) decides to redeem the relevant Borrower Loan in full, in which case all FCT Notes of the series issued in respect of the relevant Borrower Loan, and no other FCT Notes, will be redeemable; or
- (d) in case of liquidation of the FCT (as set out in the section entitled “Liquidation of the FCT” above),

(each, an ***FCT Notes Full Amortisation Event***).

In such case, the relevant FCT Notes will be redeemable in full (but always subject to the relevant priority of payment order under the FCT Regulations) (see the section entitled “General Terms and Conditions of the Notes – Notes Full Amortisation Event” of the FCT Base prospectus and the sections referred to therein).

FCT Available Funds and priority of payment

Payments of principal and interest under the FCT Notes will, on any date, be made subject to the FCT having sufficient FCT Available Funds on that date, and always subject to the applicable priority of payment order under the FCT Regulations as applicable on that date (as defined in the section entitled “Operation of the FCT – Priority of Payment Order” of the FCT Base Prospectus).

Rights and obligations of the FCT Noteholders

The holders of the FCT Notes are bondholders (*obligataires*) (an ***FCT Noteholder***).

By subscribing or purchasing any FCT Notes, an FCT Noteholder will automatically and without any formalities be bound by the provisions of the FCT Regulations.

The FCT Noteholders will have the right to receive the information relating to the FCT. They may not participate in the management of the FCT and, accordingly, will incur no liability therefor.

An investment in the FCT Notes involves certain risks (see the section entitled “Risk Factors – Risks related to Notes generally” of the FCT Base Prospectus).

Without limiting the scope of the obligations and the possibility of recourse of the FCT (represented by the FCT Management Company), by subscribing or purchasing any FCT Notes, the FCT Noteholders irrevocably waive all rights of contractual recourse (*responsabilité contractuelle*), of any form, nature, and on any ground whatsoever, which they may have against the FCT (see the section entitled “No recourse against the Issuer” of the FCT Base Prospectus).

Hedging Strategy of the FCT

The Loan Receivables are secured by the Collateral Security, a part of which bears interest at a fixed rate, while the FCT Notes bear interest at a floating rate plus a margin. In addition, part of the Collateral Security bears interest at a floating rate that can be based on an index different from the index on which the floating rate of the FCT Notes is based. In order to hedge the FCT against these two interest rate risks that would arise in case of enforcement of the Collateral Security, the FCT has entered into hedging arrangements which are described in the section entitled “Hedging Strategy” of the FCT Base Prospectus.

Taxation

The Savings Directive requires each Member State as from 1 July 2005 to provide to the tax authorities of another Member State details of payments of interest and other similar income within the meaning of the Savings Directive made by a paying agent within its jurisdiction to (or under circumstances to the benefit of) an individual resident in that other Member State, except that Luxembourg and Austria will instead impose a withholding system for a transitional period unless the beneficiary of interest payment elects for the exchange of information.

If a payment were to be made or collected through a Member State which has opted for a withholding system and an amount of, or in respect of, tax were to be withheld from that payment, neither the FCT nor any paying agent nor any other person would be obliged to pay additional amounts with respect to any FCT Note as a result of the imposition of such withholding tax.

Governing law and jurisdiction

The FCT Base Prospectus, the FCT Programme Documents, the FCT Notes and the FCT Residual Units are governed by, and construed and enforced in accordance with the laws of France.

All claims and dispute arising from the establishment, the operations or the liquidation of the FCT, between the FCT Noteholders, the holder of the FCT Residual Units, the FCT Management Company

and/or the FCT Custodian, are subject to the exclusive jurisdiction of the *Tribunal de Commerce de Paris* (Paris Commercial Court).

TERMS AND CONDITIONS OF THE NOTES

*The following is the text of the terms and conditions that, subject to completion and amendment and as supplemented or varied in accordance with the provisions of the relevant Final Terms, shall be applicable to the Notes (the **Terms and Conditions**). In the case of Dematerialised Notes, the text of the terms and conditions will not be endorsed on physical documents of title but will be constituted by the following text as completed by the relevant Final Terms. In the case of Materialised Notes, either (i) the full text of these Terms and Conditions together with the relevant provisions of the Final Terms or (ii) these Terms and Conditions as so completed (in each case subject to simplification by the deletion of non-applicable provisions) shall be endorsed on Definitive Materialised Notes. All capitalised terms that are not defined in these Terms and Conditions will have the meanings given to them in the relevant Final Terms. References below to **Conditions** are, unless the context requires otherwise, to the numbered paragraphs below. References in the Conditions to **Notes** are to the Notes of one Series only, not to all Notes that may be issued under the Programme.*

The Notes are issued by Société Générale SFH (the **Issuer**) in series (each a **Series**) having one or more issue dates and on terms otherwise identical (or identical save as to the first payment of interest), the Notes of each Series being intended to be interchangeable with all other Notes of that Series. Each Series may be issued in tranches (each a **Tranche**) on the same or different issue dates. The specific terms of each Tranche (including, without limitation, the aggregate nominal amount, issue price, redemption price thereof, and interest, if any, payable thereunder and supplemented, where necessary, with supplemental terms and conditions which, save in respect of the issue date, issue price, first payment of interest and nominal amount of the Tranche, will be identical to the terms of other Tranches of the same Series) will be determined by the Issuer and the relevant Dealer(s) at the time of the issue and will be set out in the final terms of such Tranche (the **Final Terms**).

The Notes are issued with the benefit of a paying agency agreement dated 29 April 2011 (the **Paying Agency Agreement**) between the Issuer, Société Générale as fiscal agent and principal paying agent and Société Générale Bank & Trust as paying agent in Luxembourg. The fiscal agent, the paying agents and the calculation agent for the time being (if any) are referred to below respectively as the **Fiscal Agent**, the **Paying Agents** (which expression shall include the Fiscal Agent) and the **Calculation Agent(s)**. The holders of the interest coupons (the **Coupons**) relating to interest bearing Materialised Notes and, where applicable in the case of such Notes, talons (the **Talons**) for further Coupons and the holders of the receipts for the payment of instalments of principal (the **Receipts**) relating to Materialised Notes of which the principal is redeemable in instalments, are respectively referred to below as the **Couponholders** and the **Receiptholders**.

For the purposes of these Terms and Conditions, **Regulated Market** means any regulated market situated in a member state of the European Economic Area (the **EEA**), as defined in Directive 2004/39/EC of the European Parliament and of the Council dated 21 April 2004 on markets in financial instruments.

1. Form, Denomination, Title and Redenomination

(a) Form

Notes may be issued either in dematerialised form (**Dematerialised Notes**) or in materialised form (**Materialised Notes**), as specified in the relevant Final Terms.

- (i) Title to Dematerialised Notes will be evidenced in accordance with articles L. 211-3 *et seq.* of the French Monetary and Financial Code by book entries (*inscriptions en compte*). No physical document of title (including *certificats représentatifs* pursuant to article R. 211-7 of the French Monetary and Financial Code) will be issued in respect of the Dematerialised Notes.

Dematerialised Notes are issued, at the option of the Issuer, either in bearer form (*au porteur*), which will be inscribed in the books of Euroclear France (acting as central depository) which shall credit the accounts of the Account Holders, or in registered

form (*au nominatif*) and, in such latter case, at the option of the relevant holder either in administered registered form (*au nominatif administré*) inscribed in the books of an Account Holder designated by the relevant holder of Notes or in fully registered form (*au nominatif pur*) inscribed in an account maintained by the Issuer or a registration agent (designated in the relevant Final Terms) acting on behalf of the Issuer (the **Registration Agent**).

For the purpose of these Conditions, **Account Holder** means any authorised intermediary institution entitled to hold accounts, directly or indirectly, with Euroclear France, and includes Euroclear Bank S.A./N.V. (**Euroclear**) and the depositary bank for Clearstream Banking, *société anonyme* (**Clearstream, Luxembourg**).

- (ii) Materialised Notes are issued in bearer form only. Materialised Notes in definitive form (**Definitive Materialised Notes**) are numbered serially and are issued with Coupons (and, where appropriate, a Talon) attached, save in the case of Zero Coupon Notes, in which case references to interest (other than in relation to interest due after the Maturity Date), Coupons and Talons in these Conditions are not applicable. **Instalment Notes** are issued with one or more Receipts attached.

In accordance with articles L. 211-3 *et seq.* of the French Monetary and Financial Code, securities (such as Notes constituting obligations under French law) in materialised form and governed by French law must be issued outside the French territory.

Materialised Notes and Dematerialised Notes may also be cleared through one or more clearing system(s) other than, or in addition to, Euroclear France, Euroclear and/or Clearstream Luxembourg, as may be specified in the relevant Final Terms.

The Notes may be **Fixed Rate Notes**, **Floating Rate Notes**, **Zero Coupon Notes**, **Index Linked Notes** (including both **Index Linked Interest Notes**, in respect of which amounts of interest due under the Notes shall be calculated by reference to an index and/or formula, and **Index Linked Redemption Notes** in respect of which amounts of principal due under the Notes shall be calculated by reference to an index and/or formula), **Inflation Linked Notes**, **Dual Currency Notes**, **Partly Paid Notes** or a combination of any of the foregoing, depending on the Interest Basis and the redemption method specified in the relevant Final Terms.

- (b) Denomination

Notes shall be issued in the specified denomination(s) as set out in the relevant Final Terms (the **Specified Denomination(s)**), save that the minimum denomination of each Note admitted to trading on a Regulated Market in circumstances which require the publication of a prospectus under Directive 2003/71/EC of the European Parliament and of the Council dated 4 November 2003, as amended pursuant to Directive 2010/73/EC of 24 November 2010 will be €100,000 (or its equivalent in any other currency) or such higher amount as may be allowed or required from time to time by the relevant monetary authority or any laws or regulations applicable to the relevant Specified Currency.

Notes having a maturity of less than one year in respect of which the issue proceeds are to be accepted in the United Kingdom will constitute deposits for the purposes of the prohibition on accepting deposits contained in section 19 of the Financial Services and Markets Act 2000 (the **FSMA**), unless they are issued to a limited class of professional investors and have a denomination of at least £100,000 or its equivalent.

Dematerialised Notes shall be issued in one Specified Denomination only.

- (c) Title

- (i) Title to Dematerialised Notes in bearer form (*au porteur*) and in administered registered form (*au nominatif administré*) shall pass upon, and transfer of such Notes may only be effected through, registration of the transfer in the accounts of the Account Holders. Title to Dematerialised Notes in fully registered form (*au nominatif pur*) shall pass upon, and transfer of such Notes may only be effected through, registration of the transfer in the accounts maintained by the Issuer or by the Registration Agent.
- (ii) Title to Definitive Materialised Notes, including, where appropriate, Receipt(s), Coupons and/or a Talon attached, shall pass by delivery.
- (iii) Except as ordered by a court of competent jurisdiction or as required by law, the holder of any Note (as defined below), Coupon, Receipt or Talon shall be deemed to be, and may be treated as, its absolute owner for all purposes, whether or not it is overdue and regardless of any notice of ownership, or an interest in it, any writing on it or its theft or loss and no person shall be liable for so treating the holder.
- (iv) In these Conditions,

Noteholder or, as the case may be, **holder of any Note** means (a) in the case of Dematerialised Notes, the individual or entity whose name appears in the account of the relevant Account Holder, the Issuer or the Registration Agent (as the case may be) as being entitled to such Notes, and (b) in the case of Definitive Materialised Notes, the bearer of any Definitive Materialised Note and the Coupons, Receipts or Talons relating to it.

(d) Redenomination

- (i) The Issuer may (if so specified in the relevant Final Terms), on any date, without the consent of the holder of any Note, Coupon, Receipt or Talon, by giving at least thirty (30) days' notice in accordance with Condition 14 and on or after the date on which the European Member State in whose national currency the Notes are denominated has become a participating Member State in the single currency of the European Economic and Monetary Union (as provided in the Treaty establishing the European Community (the *EC*, as amended from time to time (the *Treaty*)) or events have occurred which have substantially the same effects (in either case, *EMU*), redenominate all, but not some only, of the Notes of any Series into Euro and adjust the aggregate principal amount and the Specified Denomination(s) set out in the relevant Final Terms accordingly, as described below. The date on which such redenomination becomes effective shall be referred to in these Conditions as the **Redenomination Date**.
- (ii) Unless otherwise specified in the relevant Final Terms, the redenomination of the Notes pursuant to Condition 1(d)(i) shall be made by converting the principal amount of each Note from the relevant national currency into Euro using the fixed relevant national currency Euro conversion rate established by the Council of the European Union pursuant to article 123(4) of the Treaty and rounding the resulting figure to the nearest Euro 0.01 (with Euro 0.005 being rounded upwards). If the Issuer so elects, the figure resulting from conversion of the principal amount of each Note using the fixed relevant national currency Euro conversion rate shall be rounded down to the nearest Euro. The Euro denominations of the Notes so determined shall be notified to holders of Notes in accordance with Condition 14. Any balance remaining from the redenomination with a denomination higher than Euro 0.01 shall be paid by way of cash adjustment rounded to the nearest Euro 0.01 (with Euro 0.005 being rounded upwards). Such cash adjustment will be payable in Euro on the Redenomination Date in the manner notified by the Issuer to holders of Notes.

- (iii) Upon redenomination of the Notes, any reference herein to the relevant national currency shall be construed as a reference to Euro.
- (iv) Unless otherwise specified in the relevant Final Terms, the Issuer may, with the prior approval of the Fiscal Agent, in connection with any redenomination pursuant to this Condition or any consolidation pursuant to Condition 13, without the consent of the holder of any Note, Receipt, Coupon or Talon, make any changes or additions to these Conditions or Condition 13 (including, without limitation, any change to any applicable business day definition, business day convention, principal financial centre of the country of the Specified Currency, interest accrual basis or benchmark), taking into account market practice in respect of redenominated Euromarket debt obligations and which it believes are not prejudicial to the interests of such holders. Any such changes or additions shall, in the absence of manifest error, be binding on the holders of Notes, Receipts, Coupons and Talons and shall be notified to holders of Notes in accordance with Condition 14 as soon as practicable thereafter.
- (v) Neither the Issuer nor any Paying Agent shall be liable to the holder of any Note, Receipt, Coupon or Talon or any other person for any commissions, costs, losses or expenses in relation to or resulting from, the credit or transfer of Euro or any currency conversion or rounding effected in connection therewith.

2. Conversions and Exchanges of Notes

(a) Dematerialised Notes

- (i) Dematerialised Notes issued in bearer form (*au porteur*) may not be converted for Dematerialised Notes in registered form, whether in fully registered form (*au nominatif pur*) or in administered registered form (*au nominatif administré*).
- (ii) Dematerialised Notes issued in registered form (*au nominatif*) may not be converted for Dematerialised Notes in bearer form (*au porteur*).
- (iii) Dematerialised Notes issued in fully registered form (*au nominatif pur*) may, at the option of the holder of such Notes, be converted into Notes in administered registered form (*au nominatif administré*), and *vice versa*. The exercise of any such option by such holder shall be made in accordance with article R. 211-4 of the French Monetary and Financial Code. Any such conversion shall be effected at the cost of such holder.

(b) Materialised Notes

Materialised Notes of one Specified Denomination may not be exchanged for Materialised Notes of another Specified Denomination (as defined in the relevant Final Terms).

In accordance with article L. 211-3 and R. 211-1 of the French Monetary and Financial Code, securities (including the Notes) in materialised form and governed by French law must be issued outside the French territory.

3. Status

The principal and interest of the Notes and, where applicable, any Receipts and Coupons relating to them, constitute direct, unconditional, unsubordinated and, pursuant to the provisions of Condition 4, privileged obligations of the Issuer and rank, and will rank, *pari passu* and without any preference among themselves and equally and rateably with all other present or future notes (including the Notes of all other Series) and other resources raised by the Issuer benefiting from the *privilège* (priority right of payment) (the ***Privilège***) created by article L. 515-19 of the French Monetary and Financial Code as described in Condition 4.

4. *Privilège*

- (a) The Notes benefit from the *Privilège* created by article L. 515-19 of the French Monetary and Financial Code.
- (b) Accordingly, notwithstanding any legal provisions to the contrary (including *Livre VI* of the French Commercial Code), pursuant to article L. 515-19 of the French Monetary and Financial Code:
 - (i) all amounts payable to the Issuer in respect of loans or assimilated receivables and securities referred to in articles L. 515-14, L. 515-16 and L. 515-17 of the French Monetary and Financial Code and forward financial instruments referred to in article L. 515-18 of the French Monetary and Financial Code (in each case after any applicable set-off), together with the claims in respect of deposits made by the Issuer with credit institutions, are allocated in priority to the payment of any sums due in respect of *obligations de financement de l'habitat* such as the Notes, and any other resources raised by the Issuer and benefiting from the *Privilège*. It should be noted that it is not solely Notes that benefit from the *Privilège*; other resources (such as loans) and forward financial instruments (i.e. derivative transactions) for hedging Notes and such other resources as well as the sums, if any, due under the contract provided for in article L. 515-22 of the French Monetary and Financial Code may also benefit from the *Privilège*;
 - (ii) in case of conciliation (*conciliation*), safeguard (*sauvegarde*), judicial reorganisation (*redressement judiciaire*) or judicial liquidation (*liquidation judiciaire*) of the Issuer, all amounts due regularly under *obligations de financement de l'habitat* such as the Notes, and any other resources benefiting from the *Privilège*, are paid on their contractual due date, and in priority to all other debts, whether or not preferred, including interest resulting from agreements whatever their duration. Accordingly, until all creditors (including the Noteholders) benefiting from the *Privilège* have been fully paid, no other creditor of the Issuer may exercise any right over the assets and rights of the Issuer; and
 - (iii) the judicial liquidation of the Issuer will not result in the redemption of *obligations de financement de l'habitat* such as the Notes.

5. Interest and other Calculations

- (a) Definitions

In these Conditions, unless the context otherwise requires, the following defined terms shall have the meanings set out below:

Business Day means:

- (i) in the case of Euro, a day on which the Trans European Automated Real Time Gross Settlement Express Transfer or any successor thereto (the ***TARGET 2 System***) is operating (a ***TARGET 2 Business Day***), and/or

- (ii) in the case of a Specified Currency other than Euro, a day (other than a Saturday or Sunday) on which commercial banks and foreign exchange markets settle payments in the principal financial centre for that currency, and/or
- (iii) in the case of a Specified Currency and/or one or more additional business centre(s) specified in the relevant Final Terms (the **Business Centre(s)**), a day (other than a Saturday or a Sunday) on which commercial banks and foreign exchange markets settle payments in such currency in the Business Centre(s) or, if no currency is indicated, generally in each of the Business Centres so specified.

Day Count Fraction means, in respect of the calculation of an amount of interest on any Note for any period of time (from and including the first day of such period to but excluding the last) (whether or not constituting an Interest Period, the **Calculation Period**):

- (i) if **Actual/Actual**, **Actual/Actual-ISDA**, **Act/Act**, **Act/Act-ISDA** or **Actual/365-FBF** is specified in the relevant Final Terms, the actual number of days in the Calculation Period divided by 365 (or, if any portion of that Calculation Period falls in a leap year, the sum of (A) the actual number of days in that portion of the Calculation Period falling in a leap year divided by 366 and (B) the actual number of days in that portion of the Calculation Period falling in a non-leap year divided by 365);
- (ii) if **Actual/Actual-FBF** is specified in the relevant Final Terms, the fraction whose numerator is the actual number of days elapsed during such period and whose denominator is 365 (or 366 if 29 February falls within the Calculation Period). If the Calculation Period is of a duration of more than one (1) year, the basis shall be calculated as follows:
 - (x) the number of complete years shall be counted back from the last day of the Calculation Period; and
 - (y) this number shall be increased by the fraction for the relevant period calculated as set out in the first paragraph of this definition;
- (iii) if **Actual/Actual-ICMA** or **Act/Act-ICMA** is specified in the relevant Final Terms:
 - (A) if the Calculation Period is equal to or shorter than the Determination Period during which it falls, the number of days in the Calculation Period divided by the product of (x) the number of days in such Determination Period and (y) the number of Determination Periods normally ending in any year; and
 - (B) if the Calculation Period is longer than one (1) Determination Period, the sum of:
 - (x) the number of days in such Calculation Period falling in the Determination Period in which it begins, divided by the product of (1) the number of days in such Determination Period and (2) the number of Determination Periods normally ending in any year; and
 - (y) the number of days in such Calculation Period falling in the next Determination Period divided by the product of (1) the number of days in such Determination Period and (2) the number of Determination Periods normally ending in any year,

in each case where

Determination Period means the period from and including a Determination Date in any year to but excluding the next Determination Date, and

Determination Date means the date specified in the relevant Final Terms or, if none is so specified, the Interest Payment Date;

- (iv) if **Actual/365 (Fixed)**, **Act/365 (Fixed)**, **A/365 (Fixed)** or **A/365 F** is specified in the relevant Final Terms, the actual number of days in the Calculation Period divided by 365;
- (v) if **Actual/360**, **Act/360** or **A/360** is specified in the relevant Final Terms, the actual number of days in the Calculation Period divided by 360;
- (vi) if **30/360**, **360/360** or **Bond Basis** is specified in the relevant Final Terms, the number of days in the Calculation Period divided by 360 calculated on a formula basis as follows:

$$\text{Day Count Fraction} = \frac{1}{360} \times [[360 \times (Y2 - Y1)] + [30 \times (M2 - M1)] + (D2 - D1)]$$

where:

Y1 is the year, expressed as a number, in which the first day of the Calculation Period falls;

M1 is the calendar month, expressed as a number, in which the first day of the Calculation Period falls;

M2 is the calendar month, expressed as a number, in which the day immediately following the last day included in the Calculation Period falls;

D1 is the first calendar day, expressed as a number, of the Calculation Period, unless such number would be 31, in which case D1 will be 30; and

D2 is the calendar day, expressed as a number, immediately following the last day included in the Calculation Period, unless such number would be 31 and D1 greater than 29, in which case D2 will be 30;

- (vii) if **30/360-FBF** or **Actual 30A/360 (American Bond Basis)** is specified in the relevant Final Terms, in respect of each Calculation Period, the fraction whose denominator is 360 and whose numerator is the number of days calculated as for 30E/360-FBF, subject to the following exception:

where the last day of the Calculation Period is the 31st and the first day is neither the 30th nor the 31st, the last month of the Calculation Period shall be deemed to be a month of thirty-one (31) days,

using the same abbreviations as for 30E/360-FBF, the fraction is:

then:

- (viii) if **30E/360** or **Eurobond Basis** is specified in the relevant Final Terms, the number of days in the Calculation Period divided by 360 calculated on a formula basis as follows:

where:

Y1 is the year, expressed as a number, in which the first day of the Calculation Period falls;

Y2 is the year, expressed as a number, in which the day immediately following the last day included in the Calculation Period falls;

M1 is the calendar month, expressed as a number, in which the first day of the Calculation Period falls;

M2 is the calendar month, expressed as a number, in which the day immediately following the last day included in the Calculation Period falls;

D1 is the first calendar day, expressed as a number, of the Calculation Period, unless such number would be 31, in which case D1 will be 30; and

D2 is the calendar day, expressed as a number, immediately following the last day included in the Calculation Period, unless such number would be 31, in which case D2 will be 30.

- (ix) if **30E/360-FBF** is specified in the relevant Final Terms, in respect of each Calculation Period, the fraction whose denominator is 360 and whose numerator is the number of days elapsed during such period, calculated on the basis of a year comprising twelve (12) months of thirty (30) days, subject to the following the exception:

if the last day of the Calculation Period is the last day of the month of February, the number of days elapsed during such month shall be the actual number of days,

where:

D1 (dd1, mm1, yy1) is the date of the beginning of the period

D2 (dd2, mm2, yy2) is the date of the end of the period

the fraction is:

$$\frac{1}{360} \times [(yy2 - yy1) \times 360 + (mm2 - mm1) \times 30 + \text{Min}(dd2, 30) - \text{Min}(dd1, 30)].$$

- (x) if **30E/360-ISDA** is specified in the relevant Final Terms, the number of days in the Calculation Period divided by 360 calculated on a formula basis as follows:

$$\text{Day Count Fraction} = \frac{1}{360} \times [[360 \times (Y2 - Y1)] + [30 \times (M2 - M1)] + (D2 - D1)]$$

where:

Y1 is the year, expressed as a number, in which the first day of the Calculation Period falls;

Y2 is the year, expressed as a number, in which the day immediately following the last day included in the Calculation Period falls;

M1 is the calendar month, expressed as a number, in which the first day of the Calculation Period falls;

M2 is the calendar month, expressed as a number, in which the day immediately following the last day included in the Calculation Period falls;

D1 is the first calendar day, expressed as a number, of the Calculation Period, unless (i) that day is the last day of February or (ii) such number would be 31, in which case D1 will be 30; and

D2 is the calendar day, expressed as a number, immediately following the last day included in the Calculation Period, unless (i) that day is the last day of February but not the Maturity Date or (ii) such number would be 31, in which case D2 will be 30.

Effective Date means, with respect to any Floating Rate to be determined on an Interest Determination Date, the date specified as such in the relevant Final Terms or, if none is so specified, the first day of the Interest Accrual Period to which such Interest Determination Date relates.

Euro Zone means the region comprised of member states of the European Union that have adopted or will adopt the single currency in accordance with the Treaty.

FBF Definitions means the definitions set out in the 2007 FBF Master Agreement relating to transactions on forward financial instruments as supplemented by the Technical Schedules (*Additifs Techniques*) as published by the *Fédération Bancaire Française* (together the **FBF Master Agreement**), unless otherwise specified in the relevant Final Terms.

Interest Accrual Period means the period beginning on (and including) the Interest Commencement Date and ending on (but excluding) the first Interest Period Date and each successive period beginning on (and including) an Interest Period Date and ending on (but excluding) the next succeeding Interest Period Date.

Interest Amount means the amount of interest payable, and in the case of Fixed Rate Notes, means the Fixed Coupon Amount or Broken Amount, as specified in the relevant Final Terms, as the case may be.

Interest Commencement Date means the Issue Date (as defined in the relevant Final Terms) or such other date as may be specified in the relevant Final Terms.

Interest Determination Date means, with respect to a Rate of Interest and Interest Accrual Period, the date specified as such in the relevant Final Terms or, if none is so specified, (i) the day falling two (2) TARGET 2 Business Days prior to the first day of such Interest Accrual Period if the Specified Currency is Euro or (ii) the first day of such Interest Accrual Period if the Specified Currency is Sterling or (iii) the day falling two (2) Business Days in the city specified in the Final Terms for the Specified Currency prior to the first day of such Interest Accrual Period if the Specified Currency is neither Sterling nor Euro.

Interest Payment Date means the date(s) specified in the relevant Final Terms.

Interest Period means the period beginning on (and including) the Interest Commencement Date and ending on (but excluding) the first Interest Payment Date and each successive period beginning on (and including) an Interest Payment Date and ending on (but excluding) the next succeeding Interest Payment Date.

Interest Period Date means each Interest Payment Date unless otherwise specified in the relevant Final Terms.

ISDA Definitions means the 2006 ISDA Definitions, as published by the International Swaps and Derivatives Association, Inc., unless otherwise specified in the relevant Final Terms.

Page means such page, section, caption, column or other part of a particular information service (including, but not limited to, Reuters Markets 3000) as may be specified for the purpose of providing a Relevant Rate, or such other page, section, caption, column or other part as may replace it on that information service or on such other information service, in each case as may be nominated by the person or organisation providing or sponsoring the information appearing there for the purpose of displaying rates or prices comparable to that Relevant Rate.

Rate of Interest means the rate of interest payable from time to time in respect of the Notes and that is either specified or calculated in accordance with the provisions in the relevant Final Terms.

Reference Banks means the institutions specified as such in the relevant Final Terms or, if none, four major banks selected by the Calculation Agent in the interbank market (or, if appropriate, money, swap or over-the-counter index options market) that is most closely connected with the Benchmark (which, if EURIBOR or EONIA is the relevant Benchmark, shall be the Euro-zone, and, if LIBOR is the relevant Benchmark, shall be London).

Relevant Financial Centre means, with respect to any Floating Rate to be determined in accordance with a Screen Rate Determination on an Interest Determination Date, the financial centre as may be specified as such in the relevant Final Terms or, if none is so specified, the financial centre with which the relevant Benchmark is most closely connected (which, in the case of EURIBOR or EONIA, shall be the Euro-zone and, in the case of LIBOR, shall be London) or, if none is so connected, Paris.

Relevant Date means, in respect of any Note, Receipt or Coupon, the date on which payment in respect of it first became due or (if any amount of the money payable is improperly withheld or refused) the date on which payment in full of the amount outstanding is made or (in the case of Materialised Notes if earlier) the date seven (7) days after that on which notice is duly given to the holders of such Materialised Notes when, upon further presentation of the Materialised Note, Receipt or Coupon being made in accordance with the Conditions, such payment will be made, provided that payment is in fact made upon such presentation.

Relevant Rate means the Benchmark for a Representative Amount of the Specified Currency for a period (if applicable or appropriate to the Benchmark) equal to the Specified Duration commencing on the Effective Date.

Relevant Time means, with respect to any Interest Determination Date, the local time in the Relevant Financial Centre specified in the relevant Final Terms or, if no time is specified, the local time in the Relevant Financial Centre at which it is customary to determine bid and offered rates in respect of deposits in the Specified Currency in the interbank market in the Relevant Financial Centre and for this purpose **local time** means, with respect to Europe and the Euro-zone as a Relevant Financial Centre, 11:00 a.m. (Brussels time).

Representative Amount means, with respect to any Floating Rate to be determined in accordance with a Screen Rate Determination on an Interest Determination Date, the amount specified as such in the relevant Final Terms or, if none is specified, an amount that is representative for a single transaction in the relevant market at the time.

Specified Currency means the currency specified as such in the relevant Final Terms or, if none is specified, the currency in which the Notes are denominated.

Specified Duration means, with respect to any Floating Rate to be determined in accordance with a Screen Rate Determination on an Interest Determination Date, the duration specified in the relevant Final Terms or, if none is specified, a period of time equal to the relative Interest Accrual Period, ignoring any adjustment pursuant to Condition 5(c)(ii).

(b) Interest on Fixed Rate Notes

Each Fixed Rate Note bears interest on its outstanding nominal amount from the Interest Commencement Date at the rate per annum (expressed as a percentage) equal to the Rate of Interest, such interest being payable in arrears on each Interest Payment Date except as otherwise provided in the relevant Final Terms.

If a fixed amount of interest (**Fixed Coupon Amount**) or a broken amount of interest (**Broken Amount**) is specified in the relevant Final Terms, the amount of interest payable on each

Interest Payment Date will amount to the Fixed Coupon Amount or, if applicable, the Broken Amount so specified and in the case of the Broken Amount will be payable on the particular Interest Payment Date(s) specified in the relevant Final Terms.

(c) Interest on Floating Rate Notes and Index Linked Notes

- (i) *Interest Payment Dates:* Each Floating Rate Note and Index Linked Interest Note bears interest on its outstanding nominal amount from the Interest Commencement Date at the rate per annum (expressed as a percentage) equal to the Rate of Interest, such interest being payable in arrears (except as otherwise provided in the relevant Final Terms) on each Interest Payment Date. Such Interest Payment Date(s) is/are either shown in the relevant Final Terms as Specified Interest Payment Dates or, if no Specified Interest Payment Date(s) is/are shown in the relevant Final Terms, Interest Payment Date shall mean each date which falls the number of months or other period shown in the relevant Final Terms as the Interest Period after the preceding Interest Payment Date or, in the case of the first Interest Payment Date, after the Interest Commencement Date.
- (ii) *Business Day Convention:* If any date referred to in these Conditions that is specified to be subject to adjustment in accordance with a Business Day Convention would otherwise fall on a day that is not a Business Day, then, if the Business Day Convention specified is (A) the ***Floating Rate Business Day Convention***, such date shall be postponed to the next day that is a Business Day unless it would thereby fall into the next calendar month, in which event (x) such date shall be brought forward to the immediately preceding Business Day and (y) each subsequent such date shall be the last Business Day of the month in which such date would have fallen had it not been subject to adjustment, (B) the ***Following Business Day Convention***, such date shall be postponed to the next day that is a Business Day, (C) the ***Modified Following Business Day Convention***, such date shall be postponed to the next day that is a Business Day unless it would thereby fall into the next calendar month, in which event such date shall be brought forward to the immediately preceding Business Day, or (D) the ***Preceding Business Day Convention***, such date shall be brought forward to the immediately preceding Business Day. Notwithstanding the foregoing, where the applicable Final Terms specify that the relevant Business Day Convention is to be applied on an "unadjusted" basis, the Interest Amount payable on any date shall not be affected by the application of that Business Day Convention.
- (iii) *Rate of Interest for Floating Rate Notes:* The Rate of Interest in respect of Floating Rate Notes for each Interest Accrual Period shall be determined in the manner specified in (i) the relevant Final Terms and/or (ii) the provisions below relating to either FBF Determination, ISDA Determination or Screen Rate Determination, depending upon which is specified in the relevant Final Terms.

(A) FBF Determination for Floating Rate Notes

Where FBF Determination is specified in the relevant Final Terms as the manner in which the Rate of Interest is to be determined, the Rate of Interest for each Interest Accrual Period shall be determined by the Agent as a rate equal to the relevant FBF Rate plus or minus (as indicated in the relevant Final Terms) the Margin (if any). For the purposes of this sub-paragraph (A), ***FBF Rate*** for an Interest Accrual Period means a rate equal to the Floating Rate that would be determined by the Agent under a notional interest rate swap transaction (*Echange*) in the relevant Specified Currency incorporating the FBF Definitions and under which:

- (a) the Floating Rate is as specified in the relevant Final Terms; and

- (b) the Floating Rate Determination Date is as specified in the relevant Final Terms.

For the purposes of this sub-paragraph (A), **Floating Rate**, **Agent** and **Floating Rate Determination Date** are translations of the French terms "*Taux Variable*", "*Agent*" and "*Date de Détermination du Taux Variable*", respectively, which have the meanings given to those terms in the FBF Definitions.

(B) ISDA Determination for Floating Rate Notes

Where ISDA Determination is specified in the relevant Final Terms as the manner in which the Rate of Interest is to be determined, the Rate of Interest for each Interest Accrual Period shall be determined by the Calculation Agent as a rate equal to the relevant ISDA Rate plus or minus (as indicated in the relevant Final Terms) the Margin (if any). For the purposes of this sub-paragraph (B), **ISDA Rate** for an Interest Accrual Period means a rate equal to the Floating Rate that would be determined by the Calculation Agent under a Swap Transaction under the terms of an agreement incorporating the ISDA Definitions and under which:

- (a) the Floating Rate Option is as specified in the relevant Final Terms;
- (b) the Designated Maturity is a period specified in the relevant Final Terms; and
- (c) the relevant Reset Date is the first day of that Interest Accrual Period, unless otherwise specified in the relevant Final Terms.

For the purposes of this sub-paragraph (B), **Floating Rate**, **Calculation Agent**, **Floating Rate Option**, **Designated Maturity**, **Reset Date** and **Swap Transaction** have the meanings given to those terms in the ISDA Definitions.

(C) Screen Rate Determination for Floating Rate Notes

Where Screen Rate Determination is specified in the relevant Final Terms as the manner in which the Rate of Interest is to be determined, the Rate of Interest for each Interest Accrual Period shall be determined by the Calculation Agent at or about the Relevant Time on the Interest Determination Date in respect of such Interest Accrual Period in accordance with the following:

- (a) if the Primary Source for Floating Rate is a Page, subject as provided below, the Rate of Interest shall be:
 - (i) the Relevant Rate (where such Relevant Rate on such Page is a composite quotation or is customarily supplied by one entity); or
 - (ii) the arithmetic mean of the Relevant Rates of the persons whose Relevant Rates appear on that Page,

in each case appearing on such Page at the Relevant Time on the Interest Determination Date as disclosed in the relevant Final Terms, plus or minus (as indicated in the relevant Final Terms) the Margin (if any);

- (b) if the Primary Source for the Floating Rate is Reference Banks or if sub-paragraph (a)(i) applies and no Relevant Rate appears on the Page at the Relevant Time on the Interest Determination Date or if sub-paragraph (a)(ii) applies and fewer than two Relevant Rates appear on the Page at the Relevant Time on the Interest Determination Date, subject as provided below, the Rate of Interest shall be the arithmetic mean of the Relevant Rates that each of the Reference Banks is quoting to leading banks in the Relevant Financial Centre at the Relevant Time on the Interest Determination Date, as determined by the Calculation Agent, plus or minus (as indicated in the relevant Final Terms) the Margin (if any); and
- (c) if paragraph (b) above applies and the Calculation Agent determines that fewer than two Reference Banks are so quoting Relevant Rates, subject as provided below, the Rate of Interest shall be the arithmetic mean of the rates per annum (expressed as a percentage) that the Calculation Agent determines to be the rates (being the nearest equivalent to the Benchmark) in respect of a Representative Amount of the Specified Currency that at least two out of five leading banks selected by the Calculation Agent in the principal financial centre of the country of the Specified Currency or, if the Specified Currency is Euro, in the Euro-zone as selected by the Calculation Agent (the ***Principal Financial Centre***) are quoting at or about the Relevant Time on the date on which such banks would customarily quote such rates for a period commencing on the Effective Date for a period equivalent to the Specified Duration (I) to leading banks carrying on business in Europe, or (if the Calculation Agent determines that fewer than two of such banks are so quoting to leading banks in Europe) (II) to leading banks carrying on business in the Principal Financial Centre; except that, if fewer than two of such banks are so quoting to leading banks in the Principal Financial Centre, the Rate of Interest shall be the Rate of Interest determined on the previous Interest Determination Date (after readjustment for any difference between any Margin, Rate Multiplier or Maximum or Minimum Rate of Interest applicable to the preceding Interest Accrual Period and to the relevant Interest Accrual Period).

(iv) *Rate of Interest for Index Linked Notes:* The Rate of Interest in respect of Index Linked Notes for each Interest Accrual Period shall be determined in the manner specified in the relevant Final Terms and interest will accrue by reference to an Index or Formula as specified in the relevant Final Terms.

(d) Zero Coupon Notes

Where a Note, the Interest Basis of which is specified to be Zero Coupon, is repayable prior to the Maturity Date pursuant to an Issuer's Option or, if so specified in the relevant Final Terms, pursuant to Condition 6(d) or otherwise and is not paid when due, the amount due and payable prior to the Maturity Date shall, unless otherwise provided in the relevant Final Terms, be the Early Redemption Amount. As from the Maturity Date, the Rate of Interest for any overdue principal of such a Note shall be a rate per annum (expressed as a percentage) equal to the Amortisation Yield (as described in Condition 6(d)(i)).

(e) Dual Currency Notes

In the case of Dual Currency Notes, if the rate or amount of interest falls to be determined by reference to a Rate of Exchange or a method of calculating a Rate of Exchange, the rate or amount of interest payable shall be determined in the manner specified in the relevant Final Terms.

(f) Partly Paid Notes

In the case of Partly Paid Notes (other than Partly Paid Notes which are Zero Coupon Notes), interest will accrue as aforesaid on the paid-up nominal amount of such Notes and otherwise as specified in the relevant Final Terms.

(g) Accrual of interest

Interest shall cease to accrue on each Note on the due date for redemption unless (i) in the case of Dematerialised Notes, on such due date or (ii) in the case of Materialised Notes, upon due presentation, payment is improperly withheld or refused, in which event interest shall continue to accrue (as well after as before judgement) at the Rate of Interest in the manner provided in this Condition 5 to the Relevant Date.

(h) Margin, Maximum/Minimum Rates of Interest, Instalment Amounts and Redemption Amounts and Rounding:

(i) If any Margin is specified in the relevant Final Terms, either (x) generally or (y) in relation to one or more Interest Accrual Periods, an adjustment shall be made to all Rates of Interest in the case of (x), or to the Rates of Interest for the specified Interest Accrual Periods in the case of (y), calculated in accordance with Condition 5(c) above by adding (if a positive number) or subtracting (if a negative number) the absolute value of such Margin, subject always to the next paragraph.

(ii) If any Maximum or Minimum Rate of Interest, Instalment Amount or Redemption Amount is specified in the relevant Final Terms, then any Rate of Interest, Instalment Amount or Redemption Amount shall be subject to such maximum or minimum, as the case may be.

(iii) For the purposes of any calculations required pursuant to these Conditions (unless otherwise specified), (w) if FBF Determination is specified in the relevant Final Terms, all percentages resulting from such calculations shall be rounded, if necessary, to the nearest ten-thousandth of a percentage point (with halves being rounded up), (x) otherwise all percentages resulting from such calculations shall be rounded, if necessary, to the nearest fifth decimal (with halves being rounded up), (y) all figures shall be rounded to seven figures (with halves being rounded up) and (z) all currency amounts that fall due and payable shall be rounded to the nearest unit of such currency (with halves being rounded up), save in the case of yen, which shall be rounded down to the nearest yen. For these purposes, *unit* means the lowest amount of such currency that is available as legal tender in the country of such currency.

(i) Calculations

The amount of interest payable in respect of any Note for any period shall be calculated by multiplying the product of the Rate of Interest and the outstanding nominal amount of such Note by the Day Count Fraction, unless an Interest Amount (or a formula for its calculation) is specified in respect of such period, in which case the amount of interest payable in respect of such Note for such period shall equal such Interest Amount (or be calculated in accordance with such formula). Where any Interest Period comprises two or more Interest Accrual Periods, the amount of interest payable in respect of such Interest Period shall be the sum of the amounts of interest payable in respect of each of those Interest Accrual Periods.

- (j) Determination and Publication of Rates of Interest, Interest Amounts, Final Redemption Amounts, Early Redemption Amounts, Optional Redemption Amounts and Instalment Amounts

The Calculation Agent, as soon as practicable on such date as it may be required to calculate any rate or amount, obtain any quotation or make any determination or calculation, determine such rate and calculate the Interest Amounts in respect of each Specified Denomination (as defined in the relevant Final Terms) of the Notes for the relevant Interest Accrual Period, shall calculate the Final Redemption Amount, Early Redemption Amount, Optional Redemption Amount or Instalment Amount, obtain such quotation or make such determination or calculation, as the case may be, and cause the Rate of Interest and the Interest Amounts for each Interest Period and the relevant Interest Payment Date and, if required to be calculated, the Final Redemption Amount, Early Redemption Amount, Optional Redemption Amount or any Instalment Amount to be notified to the Fiscal Agent, the Issuer, the Paying Agents, the holders of Notes, any other Calculation Agent appointed in respect of the Notes that is to make a further calculation upon receipt of such information and, if the Notes are admitted to trading on a Regulated Market and the rules of such Regulated Market so require, such Regulated Market as soon as possible after their determination but in no event later than (i) the commencement of the relevant Interest Period, if determined prior to such time, in the case of notification to such Regulated Market of a Rate of Interest and Interest Amount, or (ii) in all other cases, the fourth Business Day after such determination. Where any Interest Payment Date or Interest Period Date is subject to adjustment pursuant to Condition 5(c)(ii), the Interest Amounts and the Interest Payment Date so published may subsequently be amended (or appropriate alternative arrangements made by way of adjustment) without notice in the event of an extension or shortening of the Interest Period. The determination of any rate or amount, the obtaining of each quotation and the making of each determination or calculation by the Calculation Agent(s) shall (in the absence of manifest error) be final and binding upon all parties.

- (k) Calculation Agent and Reference Banks

The Issuer shall procure that there shall at all times be four Reference Banks (or such other number as may be required) with offices in the Relevant Financial Centre and one or more Calculation Agents if provision is made for them in the relevant Final Terms and for so long as any Note is outstanding (as defined above). If any Reference Bank (acting through its relevant office) is unable or unwilling to continue to act as a Reference Bank, then the Issuer shall appoint another Reference Bank with an office in the Relevant Financial Centre to act as such in its place. Where more than one Calculation Agent is appointed in respect of the Notes, references in these Conditions to the Calculation Agent shall be construed as each Calculation Agent performing its respective duties under the Conditions. If the Calculation Agent is unable or unwilling to act as such or if the Calculation Agent fails duly to establish the Rate of Interest for an Interest Period or Interest Accrual Period or to calculate any Interest Amount, Instalment Amount, Final Redemption Amount, Early Redemption Amount or Optional Redemption Amount, as the case may be, or to comply with any other requirement, the Issuer shall appoint a leading bank or investment banking firm engaged in the interbank market (or, if appropriate, money, swap or over-the-counter index options market) that is most closely connected with the calculation or determination to be made by the Calculation Agent (acting through its principal Paris office or any other office actively involved in such market) to act as such in its place. The Calculation Agent may not resign its duties without a successor having been appointed as aforesaid. So long as the Notes are admitted to trading on a Regulated Market and the rules of, or applicable to, that Regulated Market so require, notice of any change of Calculation Agent shall be given in accordance with Condition 14.

6. Redemption, Purchase and Options

(a) Final Redemption

Unless previously redeemed, purchased and cancelled as provided below or its maturity is extended pursuant to any option provided by the relevant Final Terms including the Issuer's option in accordance with Condition 6(c), each Note shall be finally redeemed on the Maturity Date specified in the relevant Final Terms at its Final Redemption Amount (which, unless otherwise provided, is its nominal amount) or, in the case of a Note falling within Condition 6(b) below, its final Instalment Amount.

(b) Redemption by Instalments and Final Redemption

Unless previously redeemed, purchased and cancelled as provided in this Condition 6 or the relevant Instalment Date (being one of the dates so specified in the relevant Final Terms) is extended pursuant to the Issuer's option in accordance with Condition 6(c), each Note that provides for Instalment Dates and Instalment Amounts shall be partially redeemed on each Instalment Date at the related Instalment Amount specified in the relevant Final Terms. The outstanding nominal amount of each such Note shall be reduced by the Instalment Amount (or, if such Instalment Amount is calculated by reference to a proportion of the nominal amount of such Note, such proportion) for all purposes with effect from the related Instalment Date, unless payment of the Instalment Amount is improperly withheld or refused (i) in the case of Dematerialised Notes, on the due date for such payment or (ii) in the case of Materialised Notes, on presentation of the related Receipt, in which case, such amount shall remain outstanding until the Relevant Date relating to such Instalment Amount.

(c) Redemption at the Option of the Issuer, Exercise of Issuer's Options and Partial Redemption

If a Call Option is specified in the relevant Final Terms, the Issuer may, subject to compliance by the Issuer with all the relevant laws, regulations and directives and on giving not less than fifteen (15) nor more than thirty (30) days' irrevocable notice in accordance with Condition 14 to the holders of Notes (or such other notice period as may be specified in the relevant Final Terms) redeem or exercise any Issuer's option (as the case may be) in relation to all or, if so provided, some of the Notes on any Optional Redemption Date or Option Exercise Date, as the case may be. Any such redemption of Notes shall be at their Optional Redemption Amount together with interest accrued to the date fixed for redemption, if any. Any such redemption must relate to Notes of a nominal amount at least equal to the Minimum Redemption Amount to be redeemed as specified in the relevant Final Terms and no greater than the Maximum Redemption Amount to be redeemed as specified in the relevant Final Terms.

All Notes in respect of which any such notice is given shall be redeemed on the date specified in such notice in accordance with this Condition.

In the case of a partial redemption or a partial exercise of an Issuer's option in respect of Materialised Notes, the notice to holders of such Materialised Notes shall also contain the numbers of the Definitive Materialised Notes to be redeemed or in respect of which such option has been exercised, which shall have been drawn in such place and in such manner as may be fair and reasonable in the circumstances, taking account of prevailing market practices and subject to compliance with any applicable laws and Regulated Market requirements.

In the case of a partial redemption of or a partial exercise of an Issuer's option in respect of Dematerialised Notes, the redemption may be effected, at the option of the Issuer, either (i) by reducing the nominal amount of all such Dematerialised Notes in a Series in proportion to the aggregate nominal amount redeemed or (ii) by redeeming in full only some of such Dematerialised Notes and, in such latter case, the choice between those Dematerialised Notes that will be fully redeemed and those Dematerialised Notes of any Series that will not be redeemed shall be made in accordance with article R. 213-16 of the French Monetary and

Financial Code and the provisions of the relevant Final Terms, subject to compliance with any other applicable laws and Regulated Market requirements.

So long as the Notes are admitted to trading on a Regulated Market and the rules of, or applicable to, such Regulated Market require, the Issuer shall, each time there has been a partial redemption of the Notes, cause to be published (i) as long as such Notes are admitted to trading on Euronext Paris and the rules applicable to such Regulated Market so permit, on the website of the AMF (www.amf-france.org) or (ii) in a leading financial newspaper with general circulation in the city where the Regulated Market on which such Notes are admitted to trading is located, which in the case of Euronext Paris is expected to be *La Tribune* or *Les Echos*, a notice specifying the aggregate nominal amount of Notes outstanding and, in the case of Materialised Notes, a list of any Definitive Materialised Notes drawn for redemption but not surrendered.

(d) Early Redemption

(i) Zero Coupon Notes

(A) The Early Redemption Amount payable in respect of any Zero Coupon Note, the amount of which is not linked to an index and/or a formula, upon redemption of such Note pursuant to Condition 6(f) or 6(i) shall be the Amortised Nominal Amount (calculated as provided below) of such Note unless otherwise specified in the relevant Final Terms.

(B) Subject to the provisions of sub-paragraph (C) below, the Amortised Nominal Amount of any such Note shall be the scheduled Final Redemption Amount of such Note on the Maturity Date discounted at a rate per annum (expressed as a percentage) equal to the Amortisation Yield (which, if none is shown in the relevant Final Terms, shall be such rate as would produce an Amortised Nominal Amount equal to the issue price of the Notes if they were discounted back to their issue price on the Issue Date) compounded annually.

(C) If the Amortised Nominal Amount payable in respect of any such Note upon its redemption pursuant to Condition 6(f) or 6(i) is not paid when due, the Early Redemption Amount due and payable in respect of such Note shall be the Amortised Nominal Amount of such Note as defined in sub-paragraph (B) above, except that such sub-paragraph shall have effect as though the date on which the Note becomes due and payable was the Relevant Date. The calculation of the Amortised Nominal Amount in accordance with this sub-paragraph shall continue to be made (both before and after judgement) until the Relevant Date, unless the Relevant Date falls on or after the Maturity Date, in which case the amount due and payable shall be the scheduled Final Redemption Amount of such Note on the Maturity Date together with any interest that may accrue in accordance with Condition 5(d).

Where such calculation is to be made for a period of less than one (1) year, it shall be made on the basis of the Day Count Fraction as provided in the relevant Final Terms.

(ii) Other Notes

The Early Redemption Amount payable in respect of any Note (other than Notes described in (i) above), upon redemption of such Note pursuant to Condition 6(f) or 6(i) shall be the Final Redemption Amount together with interest accrued to the date fixed for redemption unless otherwise specified in the relevant Final Terms.

(e) No Redemption for Taxation Reasons

Unless otherwise specified in the relevant Final Terms, if French law should require that payments of principal or interest in respect of any Note be subject to deduction or withholding in respect of any present or future taxes or duties whatsoever, such Notes may not be redeemed early.

(f) Partly Paid Notes

Partly Paid Notes will be redeemed, whether at maturity, early redemption or otherwise, in accordance with the provisions of this Condition 6 and the provisions specified in the relevant Final Terms.

(g) Purchases

The Issuer may, subject to Condition 6(i), at any time purchase Notes (provided that, in the case of Materialised Notes, all unmatured Receipts and Coupons and unexchanged Talons relating thereto are attached thereto or surrendered therewith) in the open market or otherwise (including by tender offer) at any price, subject to the applicable laws and/or regulations.

(h) Subscriptions

The Issuer shall have the right at all times to subscribe for Notes for the purpose of pledging them (*affecter en garantie*) as collateral security in order to secure the credit transactions (*opérations de crédit*) of the *Banque de France* in accordance with the terms and conditions determined by the *Banque de France* for its monetary and intraday credit policy, if the Issuer is not able to meet its cash requirements with the other resources available to it, provided that:

- (i) the total amount of the Notes subscribed by the Issuer does not exceed ten (10) per cent. of the total outstanding amount (*encours total*) of the resources benefiting from the *Privilège* as at the date of their subscription;
- (ii) the Notes are disentitled of their rights under articles L. 228-46 to L. 228-89 of the French Commercial Code as long as the Issuer holds them;
- (iii) the Notes are pledged for the benefit of the *Banque de France* within an 8-day period starting from the date on which they are paid and delivered (otherwise, such Notes shall be cancelled by the Issuer at the end of such 8-day period); and
- (iv) they can not be subscribed by third parties.

In any case, the Notes subscribed by the Issuer shall be cancelled within an 8-day period starting from the date on which they cease to be pledged for the benefit of the *Banque de France*.

(i) Cancellation

All Notes purchased or subscribed by the Issuer must, in the circumstances of Condition 6(h), or may, at the sole discretion of the Issuer, be cancelled, in the case of Dematerialised Notes, by transfer to an account in accordance with the rules and procedures of Euroclear France and, in the case of Materialised Notes, by surrendering the relevant Temporary Global Certificate or the Definitive Materialised Notes in question, together with all unmatured Receipts and Coupons and all unexchanged Talons, if applicable, to the Fiscal Agent and, in each case, if so transferred or surrendered, shall, together with all Notes redeemed by the Issuer, be cancelled forthwith (together with, in the case of Dematerialised Notes, all rights relating to payment of interest and other amounts relating to such Dematerialised Notes and, in the case of Definitive Materialised Notes, all unmatured Receipts and Coupons and unexchanged Talons attached thereto or surrendered therewith). Any Notes so cancelled or, where applicable, transferred or surrendered for cancellation may not be reissued or resold and the obligations of the Issuer in respect of any such Notes shall be discharged.

(j) **Illegality**

If, by reason of any change in French law, or any change in the official application or interpretation of such law, becoming effective after the Issue Date, it would become unlawful for the Issuer to perform or comply with one or more of its obligations under the Notes, the Issuer will, subject to having given not more than forty-five (45) nor less than thirty (30) days' notice to the Noteholders (which notice shall be irrevocable), in accordance with Condition 14, redeem all, but not some only, of the Notes at their Early Redemption Amount together with any interest accrued to the date set for redemption.

7. Payments and Talons

(a) **Dematerialised Notes**

Payments of principal and interest in respect of Dematerialised Notes shall (i) in the case of Dematerialised Notes in bearer dematerialised form or administered registered form, be made by transfer to the account denominated in the relevant currency of the relevant Account Holders for the benefit of the holders of Notes, and (ii) in the case of Dematerialised Notes in fully registered form, to an account denominated in the relevant currency with a Bank (as defined below) designated by the relevant holder of Notes. All payments validly made to such Account Holders or Bank will be an effective discharge of the Issuer in respect of such payments.

(b) **Definitive Materialised Notes**

(i) **Method of payment**

Subject as provided below, payments in a Specified Currency will be made by credit or transfer to an account denominated in the relevant Specified Currency, or to which the Specified Currency may be credited or transferred (which, in the case of a payment in Japanese yen to a non-resident of Japan, shall be a non-resident account) maintained by the payee with, or, at the option of the payee, by a cheque in such Specified Currency drawn on, a bank in the principal financial centre of the country of such Specified Currency (which, if the Specified Currency is euro, shall be any country in the Euro-zone, and, if the Specified Currency is Australian dollars or New Zealand dollars, shall be Sydney or Auckland, respectively).

(ii) **Presentation and surrender of Definitive Materialised Notes, Receipts and Coupons**

Payments of principal in respect of Definitive Materialised Notes will (subject as provided below) be made in the manner provided in paragraph (i) above only upon presentation and surrender (or, in the case of partial payment of any sum due, annotation) of such Notes, and payments of interest in respect of Definitive Materialised Notes will (subject as provided below) be made as aforesaid only upon presentation and surrender (or, in the case of part payment of any sum due, annotation) of Coupons, in each case at the specified office of any Paying Agent outside the United States (which expression, as used herein, means the United States of America (including the States and the District of Columbia, its territories, its possessions and other areas subject to its jurisdiction)).

Payments of instalments of principal (if any) in respect of Definitive Materialised Notes, other than the final instalment, will (subject as provided below) be made in the manner provided in paragraph (i) above only against presentation and surrender (or, in the case of part payment of any sum due, annotation) of the relevant Receipt in accordance with the preceding paragraph. Payment of the final instalment will be made in the manner provided in paragraph (i) above only against presentation and surrender (or, in the case of part payment of any sum due, annotation) of the relevant Note in accordance with the preceding paragraph. Each Receipt must be presented for

payment of the relevant instalment together with the Definitive Materialised Note to which it appertains. Receipts presented without the Definitive Materialised Note to which they appertain do not constitute valid obligations of the Issuer.

Upon the date upon which any Definitive Materialised Note becomes due and repayable, unmatured Receipts (if any) relating thereto (whether or not attached) shall become void and no payment will be made in respect thereof.

Fixed Rate Notes in definitive form (other than Dual Currency Notes or Index Linked Notes) should be presented for payment together with all unmatured Coupons appertaining thereto (which expression shall for this purpose include Coupons falling to be issued on the exchange of matured Talons), failing which the amount of any missing unmatured Coupon (or, in the case of payment not being made in full, the same proportion of the amount of such missing unmatured Coupon as the sum so paid bears to the sum due) will be deducted from the sum due for payment. Each amount of principal so deducted will be paid in the manner mentioned above against surrender of the relative missing Coupon at any time before the expiry of five (5) years from the date on which such Coupon would have become due, but in no event thereafter.

Upon any Fixed Rate Note in definitive form becoming due and repayable prior to its Maturity Date, all unmatured Talons (if any) appertaining thereto will become void and no further Coupons will be issued in respect thereof.

Upon the date on which any Floating Rate Note, Dual Currency Note or Index Linked Note in definitive form becomes due and repayable prior to its Maturity Date, unmatured Coupons and Talons (if any) relating thereto (whether or not attached) shall become void and no payment or, as the case may be, exchange for further Coupons shall be made in respect thereof.

If the due date for redemption of any Definitive Materialised Note is not an Interest Payment Date, interest (if any) accrued in respect of such Note from (and including) the preceding Interest Payment Date or, as the case may be, the Interest Commencement Date shall be payable only upon presentation and surrender (if appropriate) of the relevant Definitive Materialised Note.

(c) Payments in the United States

Notwithstanding the foregoing, if any Materialised Notes are denominated in U.S. dollars, payments in respect thereof may be made at the specified office of any Paying Agent in New York City in the same manner as aforesaid if (i) the Issuer shall have appointed Paying Agent(s) with specified offices outside the United States with the reasonable expectation that such Paying Agent(s) would be able to make payment of the amounts on the Notes in the manner provided above when due, (ii) payment in full of such amounts at all such offices is illegal or effectively precluded by exchange controls or other similar restrictions on payment or receipt of such amounts, and (iii) such payment is then permitted by United States law, without involving, in the opinion of the Issuer, any adverse tax consequence for the Issuer.

(d) Payments subject to Fiscal Laws

All payments are subject in all cases to any applicable fiscal or other laws, regulations and directives but without prejudice to Condition 8. No commission or expenses shall be charged to the holders of Notes or Couponholders in respect of such payments.

(e) Appointment of Agents

The Fiscal Agent, the Paying Agents and the Calculation Agent initially appointed by the Issuer and their respective specified offices are listed at the end of this Base Prospectus

relating to the Programme of the Notes of the Issuer. The Fiscal Agent, the Paying Agents and the Registration Agent act solely as agents of the Issuer and the Calculation Agent(s) act(s) as independent experts(s) and, in each case, does not assume any obligation or relationship of agency for any Noteholder or Couponholder. The Issuer reserves the right at any time to vary or terminate the appointment of the Fiscal Agent, the Paying Agents, the Registration Agent or the Calculation Agent and to appoint another Fiscal Agent, Paying Agent(s), Registration Agent(s) or Calculation Agent(s) or additional Paying Agent(s), Registration Agent(s) or Calculation Agent(s), provided that the Issuer shall at all times maintain (i) a Fiscal Agent, (ii) one or more Calculation Agent(s) where the Conditions so require, (iii) a Paying Agent having specified offices in at least two major European cities and ensuring the financial servicing of the Notes free of charge to the Noteholders, so long as the Notes are listed and admitted to trading on Euronext Paris and, so long as the Notes are admitted to trading on any other Regulated Market, in such other city where the Notes are admitted to trading, (iv) in the case of Materialised Notes, a Paying Agent having its specified office in a Member State of the EU that will not be obliged to withhold or deduct tax pursuant to European Council Directive 2003/48/EC regarding the taxation of savings income in the form of interest payments or any other EU Directive implementing the conclusions of the ECOFIN Council meeting of 26-27 November 2000 on the taxation of savings income or any law implementing or complying with, or introduced in compliance with, such Directive (which may be the Paying Agent referred to in (iii) above), (v) in the case of Dematerialised Notes in fully registered form, a Registration Agent, and (vi) such other agents as may be required by the rules of any other Regulated Market on which the Notes may be admitted to trading.

In addition, the Issuer shall forthwith appoint a Paying Agent in New York City in respect of any Materialised Notes denominated in U.S. dollars in the circumstances described in paragraph (c) above.

Notice of any such change or any change of any specified office shall promptly be given to the holders of Notes in accordance with Condition 14.

(f) Talons

On or after the Interest Payment Date for the final Coupon forming part of a Coupon sheet issued in respect of any Materialised Note, the Talon forming part of such Coupon sheet may be surrendered at the specified office of the Fiscal Agent in exchange for a further Coupon sheet (and if necessary another Talon for a further Coupon sheet) (but excluding any Coupons that may have become void pursuant to Condition 9).

(g) Business Days for Payment

If any date for payment in respect of any Note, Receipt or Coupon is not a business day, the holder shall not be entitled to payment until the next following business day, unless otherwise specified in the relevant Final Terms (the *Adjusted Payment Date*), nor to any interest or other sum in respect of such postponed payment. In this paragraph, *business day* means a day (other than a Saturday or a Sunday) (A) (i) in the case of Dematerialised Notes, on which Euroclear France is open for business or (ii) in the case of Materialised Notes, on which banks and foreign exchange markets are open for business in the relevant place of presentation, (B) in such jurisdictions as shall be specified as *Financial Centre(s)* in the relevant Final Terms, and (C) (i) in the case of a payment in a currency other than Euro, where payment is to be made by transfer to an account maintained with a bank in the relevant currency, on which foreign exchange transactions may be carried on in the relevant currency in the principal financial centre of the country of such currency or (ii) in the case of a payment in Euro, which is a TARGET 2 Business Day.

(h) Bank

For the purpose of this Condition 7, **Bank** means a bank in the principal financial centre of the relevant currency or, in the case of Euro, in a city in which banks have access to the TARGET 2 System.

8. Taxation

(a) Withholding Tax

All payments of principal, interest and other revenues by or on behalf of the Issuer in respect of the Notes shall be made free and clear of, and without withholding or deduction for, any taxes, duties, assessments or governmental charges of whatever nature imposed, levied, collected, withheld or assessed by or within France or any authority therein or thereof having the power to tax, unless such withholding or deduction is required by law.

(b) No Additional Amounts

If French law or Luxembourg law should require that payments of principal or interest in respect of any Note or any Receipt or Coupon relating thereto, be subject to deduction or withholding in respect of any present or future taxes or duties whatsoever, the Issuer will not be required to pay any additional amounts in respect of any such withholding or deduction.

9. Prescription

Claims against the Issuer for payment in respect of the Notes, Receipts and Coupons (which for this purpose shall not include Talons) shall be prescribed and become void unless made within a period of five (5) years (in the case of principal and interest) from the appropriate Relevant Date in respect of them.

10. Representation of Noteholders

Except as otherwise provided by the relevant Final Terms, holders of Notes will, in respect of all Tranches in any Series, be grouped automatically for the defence of their common interests in a *masse* (in each case, the *Masse*).

The Masse will be governed by the provisions of the French Commercial Code with the exception of articles L. 228-48, L. 228-59, L. 228-71, R. 228-63, R. 228-65, R. 228-67 and R. 228-69, subject to the following provisions:

(a) Legal Personality

The Masse will be a separate legal entity and will act in part through a representative (the **Representative**) and in part through a general meeting of the holders of Notes (the **General Meeting**).

The Masse alone, to the exclusion of all individual holders of Notes, shall exercise the common rights, actions and benefits which now or in the future may accrue respectively with respect to the Notes.

(b) Representatives

The office of Representative may be conferred on a person of any nationality. However, the following persons may not be chosen as Representatives:

- (i) the Issuer, the members of its board of directors (*conseil d'administration*), its executive board (*directoire*), its supervisory board (*conseil de surveillance*), its general managers (*directeurs généraux*), its statutory auditors, its employees and their ascendants, descendants and spouse; or

- (ii) companies guaranteeing all or part of the obligations of the Issuer, their respective managers (*gérants*), general managers (*directeurs généraux*), members of their board of directors (*conseil d'administration*), executive board (*directoire*) or supervisory board (*conseil de surveillance*), their statutory auditors, employees and their ascendants, descendants and spouse; or
- (iii) companies holding ten (10) per cent. or more of the share capital of the Issuer or companies having ten (10) per cent. or more of their share capital held by the Issuer; or
- (iv) persons to whom the practice of banker is forbidden or who have been deprived of the right of directing, administering or managing an enterprise in whatever capacity.

The name and address of the initial Representative will be set out in the Final Terms.

The Representative will be entitled to such remuneration in connection with its function or duties as set out in the relevant Final Terms.

The Representative appointed in respect of the first Tranche of any Series of Notes will be the Representative of the single Masse of all Tranches in such Series. The Representative appointed in respect of each Series of Notes will be the Representative in respect of the first Tranche of the first Series of Notes.

In the event of death, retirement or revocation of appointment of the Representative, an other Representative will be elected by the General Meeting.

All interested parties will at all times have the right to obtain the name and address of the Representative at the head office of the Issuer and the specified office of the Paying Agent(s).

(c) Powers of Representative

The Representative shall (in the absence of any decision to the contrary of the General Meeting and except as provided by paragraph 1 of article L. 515-31 of the French Monetary and Financial Code) have the power to take all acts of management necessary in order to defend the common interests of the holders of Notes.

All legal proceedings against the Noteholders or initiated by them, must be brought by or against the Representative, except that, should safeguard procedure (*procédure de sauvegarde*), judicial reorganisation (*redressement judiciaire*) or judicial liquidation (*liquidation judiciaire*) proceedings be commenced against the Issuer, the specific controller would file the proof of debt of all creditors (including the Noteholders) of the Issuer benefiting from the *Privilège*.

The Representative may not be involved in the management of the affairs of the Issuer.

(d) General Meeting

A General Meeting may be held at any time, upon convocation either by the Issuer or by the Representative. One or more Noteholders, holding together at least one-thirtieth of the principal amount of the Notes outstanding, may address to the Issuer and the Representative a demand for the convening of a General Meeting. If such General Meeting has not been convened within two (2) months after such demand, the Noteholders may commission one of their members to petition a competent court in Paris to appoint an agent (*mandataire*) who will call the General Meeting.

Notice of the date, hour, place and agenda of any General Meeting will be published as provided under Condition 14.

Each Noteholder has the right to participate in a General Meeting either in person or by proxy. Each Note carries the right to one vote or, in the case of Notes issued with more than one Specified Denomination (as defined in the relevant Final Terms), one vote in respect of each multiple of the lowest Specified Denomination comprised in the principal amount of the Specified Denomination of such Note.

In accordance with article R. 228-71 of the French Commercial Code, the rights of each Noteholder to participate in General Meetings will be evidenced by the entries in the books of the relevant Account Holder of the name of such Noteholder on the third business day in Paris preceding the date set for the meeting of the relevant General Meeting at zero hours, Paris time.

(e) Powers of the General Meetings

The General Meeting is empowered to deliberate on the dismissal and replacement of the Representative and may also act with respect to any other matter that relates to the common rights, actions and benefits which now or in the future may accrue with respect to the Notes, including authorising the Representative to act at law as plaintiff or defendant.

The General Meeting may further deliberate on any proposal relating to the modification of the Conditions including any proposal, whether for arbitration or settlement, relating to rights in dispute or which were the subject of judicial decisions, it being specified, however, that the General Meeting may not increase amounts payable by Noteholders, nor establish any unequal treatment between the Noteholders.

General Meetings may only validly deliberate on first convocation if the Noteholders present or represented hold at least one fifth of the principal amount of the Notes then outstanding. On second convocation, no quorum shall be required. Decisions at meetings shall be taken by a two-third majority of votes cast by Noteholders attending such General Meetings or represented thereat.

Decisions of General Meetings must be published in accordance with the provisions set forth in Condition 14.

(f) Information to Noteholders

Each Noteholder or Representative thereof will have the right, during the 15-day period preceding the holding of each General Meeting, to consult or make a copy of the text of the resolutions which will be proposed and of the reports which will be presented at the General Meeting, all of which will be available for inspection by the relevant Noteholders at the registered office of the Issuer, at the specified office of the Paying Agent(s) and at any other place specified in the notice of the General Meeting.

(g) Expenses

The Issuer will pay all expenses relating to the operation of the Masse, including expenses relating to the calling and holding of General Meetings and, more generally, all administrative expenses resolved upon by the General Meeting, it being expressly stipulated that no expenses may be imputed against interest payable under the Notes.

(h) Single Masse

The Noteholders of the same Series, and the Noteholders of any other Series which has been assimilated with the Notes of such first mentioned Series in accordance with Condition 13, shall, for the defence of their respective common interests, be grouped in a single Masse. The Representative appointed in respect of the first Tranche or Series of Notes will be the Representative of the single Masse of all such Series.

In respect of any Tranche of Notes issued or deemed to be issued outside France, this Condition 10 may, if so specified in the relevant Final Terms, be waived, amended or supplemented, and in respect of any Tranche issued inside France, this Condition 10 shall be waived in its entirety and replaced by the full provisions of the French Commercial Code.

11. Modifications

These Conditions may be amended, modified or varied in relation to any Series of Notes by the terms of the relevant Final Terms in relation to such Series.

12. Replacement of Definitive Materialised Notes, Receipts, Coupons and Talons

If, in the case of any Materialised Notes, a Definitive Materialised Note, Receipt, Coupon or Talon is lost, stolen, mutilated, defaced or destroyed, it may be replaced, subject to applicable laws, regulations and Regulated Market regulations, at the specified office of the Fiscal Agent or any Paying Agent as may from time to time be designated by the Issuer for this purpose and notice of whose designation is given to Noteholders, in each case on payment by the claimant of the fees and costs incurred in connection therewith and on such terms as to evidence, security and indemnity (which may provide, *inter alia*, that if the allegedly lost, stolen or destroyed Definitive Materialised Note, Receipt, Coupon or Talon is subsequently presented for payment or, as the case may be, for exchange for further Coupons, there shall be paid to the Issuer on demand the amount payable by the Issuer in respect of such Definitive Materialised Notes, Receipts, Coupons or further Coupons) and otherwise as the Issuer may require. Mutilated or defaced Materialised Notes, Receipts, Coupons or Talons must be surrendered before replacements will be issued.

13. Further Issues and Consolidation

(a) Further Issues

Unless otherwise provided in the relevant Final Terms, the Issuer may, from time to time, without the consent of the Noteholders, Receiptholders or Couponholders create and issue further notes to be assimilated (*assimilées*) with the Notes, provided such Notes and the further notes carry rights identical in all respects (or identical in all respects save for the principal amount thereof and the first payment of interest) and that the terms of such notes provide for such assimilation, and references in these Conditions to **Notes** shall be construed accordingly.

(b) Consolidation

Unless otherwise provided in the relevant Final Terms, the Issuer, with the prior approval of the Fiscal Agent (which shall not be unreasonably withheld), may, from time to time, on any Interest Payment Date occurring on or after the Redenomination Date on giving not less than thirty (30) days' prior notice to the Noteholders in accordance with Condition 14, without the consent of the Noteholders, Receiptholders or Couponholders, consolidate the Notes of one Series denominated in Euro with the Notes of one or more other Series issued by it, whether or not originally issued in one of the European national currencies or in Euro, provided such other Notes have been redenominated in Euro (if not originally denominated in Euro) and which otherwise have, in respect of all periods subsequent to such consolidation, the same terms and conditions as the Notes.

14. Notices

- (a) Notices to the holders of Dematerialised Notes in registered form (*au nominatif*) shall be valid if either (i) they are mailed to them at their respective addresses, in which case they will be deemed to have been given on the fourth (4th) weekday (being a day other than a Saturday or a Sunday) after the mailing, or, at the option of the Issuer, (ii) they are published in a leading daily financial newspaper of general circulation within Europe (which is expected to be the *Financial Times*), provided that, so long as such Notes are admitted to trading on any

Regulated Market and the rules applicable to such Regulated Market so require, notices shall be valid if published in a daily financial newspaper with general circulation in the city/ies where the Regulated Market on which such Notes are admitted to trading is located which, in the case of Euronext Paris, is expected to be *La Tribune* or *Les Echos*, or as otherwise required by the rules applicable to that Regulated Market, as the case may be.

- (b) Notices to the holders of Materialised Notes and Dematerialised Notes in bearer form (*au porteur*) shall be valid if published in a daily leading financial newspaper of general circulation within Europe (which is expected to be the *Financial Times*) and so long as such Notes are admitted to trading on any Regulated Market and the applicable rules of that Regulated Market so require, in a leading daily financial newspaper with general circulation in the city/ies where the Regulated Market on which such Notes are admitted to trading is located which, in the case of Euronext Paris, is expected to be *La Tribune* or *Les Echos*, or as otherwise required by the rules applicable to that Regulated Market, as the case may be.
- (c) Notices required to be given to the holders of Dematerialised Notes (whether in registered or in bearer form) (*au nominatif* or *au porteur*) pursuant to these Conditions may be given by delivery of the relevant notice to Euroclear France, Euroclear, Clearstream, Luxembourg and any other clearing system through which the Notes are for the time being cleared in substitution for the mailing and publication as required by Conditions 14(a), (b) and (d); provided that so long as such Notes are admitted to trading on any Regulated Market(s) and the rules applicable to that Regulated Market so require, notices shall also be published in a daily financial newspaper with general circulation in the city/ies where the Regulated Market(s) on which such Notes are admitted to trading is/are located, which, in the case of Euronext Paris, is expected to be *La Tribune* or *Les Echos*, and as otherwise required by the rules applicable to that Regulated Market, as the case may be.
- (d) If any such publication is not practicable, notice shall be validly given if published in a leading daily financial newspaper with general circulation within Europe, provided that, so long as such Notes are admitted to trading on any Regulated Market, notice shall be published as otherwise required by the rules applicable to that Regulated Market, as the case may be. Any such notice shall be deemed to have been given on the date of such publication or, if published more than once or on different dates, on the date of the first publication as provided above. Couponholders shall be deemed for all purposes to have notice of the contents of any notice given to the holders of Materialised Notes in accordance with this Condition.

15. Governing Law and Jurisdiction

(a) Governing Law

The Notes (and, where applicable, the Receipts, Coupons and Talons) are governed by, and shall be construed in accordance with, French law.

(b) Jurisdiction

Any claim against the Issuer in connection with any Notes, Receipts, Coupons or Talons may be brought before any competent court in Paris.

TEMPORARY GLOBAL CERTIFICATES IN RESPECT OF MATERIALISED NOTES

Temporary Global Certificates

A Temporary Global Certificate without interest coupons (a *Temporary Global Certificate*) will initially be issued in connection with each Tranche of Materialised Notes, and will be delivered on or prior to the issue date of the Tranche to a common depository (the *Common Depository*) for Euroclear Bank S.A./N.V. (*Euroclear*) and to Clearstream Banking, *société anonyme* (*Clearstream, Luxembourg*). Upon the delivery of such Temporary Global Certificate to a Common Depository, Euroclear and Clearstream, Luxembourg will credit each subscriber with a nominal amount of Notes equal to the nominal amount thereof for which it has subscribed and paid.

The Common Depository may also credit with a nominal amount of Notes the accounts of subscribers with (if indicated in the relevant Final Terms) other clearing systems through direct or indirect accounts with Euroclear and Clearstream, Luxembourg held by such other clearing systems. Compliance with these rules, in view of the aforementioned issue programme, was verified on the basis of estimated financial data, in respect of the period elapsed, and forecasted financial data, in respect of the future period, drawn up under the responsibility of your Board of Directors. The forecasted financial data were drawn up on the basis of assumptions which reflect the future position that you deemed to be most probable as of the date that they were drawn up. This information is presented in an appendix to this report.

We performed our review in accordance with the standards procedures issued in the professional rules and practices of the *Compagnie Nationale des Commissaires aux Comptes* (National Association of Statutory Auditors) that are applicable to this type of assessment. These procedures, based on such financial information, were carried out in order to verify compliance with the rules laid down by articles L. 515-20 and R. 515-7-2 of the French Monetary and Financial Code and with the methods of calculating the hedge ratio provided for in Regulation no. 99-10 of the French Banking and Financial Regulations Committee and Instruction no. 2008-05 of the Autorité de Contrôle Prudentiel.

We have also examined the process of presenting the estimated and the forecasted financial data, with regard to its consistency, plausibility and relevance, with a view to checking compliance with the rule provided for in article L. 515-20 of the French Monetary and Financial Code. In our capacity as the specific controller of your company and pursuant to the provisions set forth in articles L. 515-30 and R. 515-13, IV of the French Monetary and Financial Code, we hereby set out our certification regarding compliance with the rules provided for in articles L. 515-20 and R. 515-7-2 of the French Monetary and Financial Code in the context of any issue of debts benefiting from the privileged right of payment mentioned in article L. 515-19 of the French Monetary and Financial Code with a unit value of at least Euro 500 million.

In a decision dated [●], the Board of Directors of Société Générale SFH set the maximum amount for the programme for issuing funding that benefit from the privileged right of payment mentioned in article L. 515-19 of the French Monetary and Financial Code to Euro [●], for the period from [●] to [●].

In respect of this quarterly issue programme, in a decision dated [●], [●], acting as the [chairman of the board of directors and chief executive officer (*président directeur général*)]/[deputy chief executing officer (*directeur général délégué*)] of Société Générale SFH approved a new issue of [*obligations de financement de l'habitat*]/[debts benefiting from the privileged right of payment mentioned in article L. 515-19 of the French Monetary and Financial Code], for an amount of [●].

Article L. 515-20 of the French Monetary and Financial Code states that the total amount of assets held by *sociétés de financement de l'habitat* must be greater than the amount of liabilities which benefit from the privileged right of payment mentioned in article L. 515-19 of such code. Furthermore, article R. 515-7-2 of such code provides that *sociétés de financement de l'habitat* must at all times maintain a ratio of at least 102 per cent. of their assets to the total amount of their liabilities which have the benefit of the *Privilège*. It is our responsibility to certify the compliance of the current transaction with these rules.

Compliance with these rules, after taking into account the aforementioned debenture issue, was verified on the basis of estimated and forecasted financial data, drawn up under the responsibility of your Board of Directors. The forecasted financial data were drawn up on the basis of assumptions which reflect the position that you deemed to be most probable as of the date of the present issue. This information is presented in an appendix to this report.

We performed our review in accordance with the standards procedures issued in the professional rules and practises of the *Compagnie Nationale des Commissaires aux Comptes* (National Association of Statutory Auditors) that are applicable to this type of assessment. These procedures, based on such financial information, were carried out in order to verify compliance with the rules laid down by articles L. 515-20 and R. 515-7-2 of the French Monetary and Financial Code and with the methods of calculating the hedge ratio provided for in Regulation no. 99-10 of the French Banking and Financial Regulations Committee and Instruction no. 2008-05 of the Autorité de Contrôle Prudentiel.

We have also examined the process of presenting the estimated and the forecasted financial data, drawn up as of the closest date of the present issue, with regard to its consistency, plausibility and relevance, with a view to checking compliance with the rules provided for in articles L. 515-20 and R. 515-7-2 of the French Monetary and Financial Code. Regarding the forecasted financial data, we have assessed the assumptions used and their statement in figures, bearing in mind that, as the forecasts are, by their nature, uncertain, the actual results could differ significantly from the forecasted data presented.

Based on our work, we have no comments to make as regards compliance by Société Générale SFH with articles L. 515-20 and R. 515-7-2 of the French Monetary and Financial Code, after taking into account the aforementioned issue.

TAXATION

The following is a summary limited to certain tax considerations in France relating to the Notes that may be issued under the Programme and specifically contains information on taxes on the income from the securities withheld at source. This summary is based on the laws in force in France as of the date of this Base Prospectus and is subject to any changes in law. It does not purport to be a comprehensive description of all the tax considerations which may be relevant to a decision to purchase, own or dispose of the Notes. Each prospective holder or beneficial owner of Notes should consult its tax advisor as to the tax consequences of any investment in or ownership and disposition of the Notes.

EU Savings Directive

On 3 June 2003, the European Union adopted Directive 2003/48/EC regarding the taxation of savings income in the form of interest payments (the *Savings Directive*). The Savings Directive requires Member States, as of 1 July 2005, to provide the tax authorities of other Member States with details of payments of interest and other similar income within the meaning of the Savings Directive made by a paying agent within its jurisdiction to (or under circumstances to the benefit of) an individual resident in another Member State, except that Luxembourg and Austria will instead impose a withholding system for a transitional period unless the beneficiary of interest payment elects for the exchange of information.

If a payment were to be made or collected through a Member State which has opted for a withholding system and an amount in respect of tax was to be withheld from that payment, neither the Issuer nor any Paying Agent nor any other person would be obliged to pay additional amounts with respect to any Note as a result of the imposition of such withholding tax. If a withholding tax is imposed on payment made by a Paying Agent, the Issuer will be required to maintain a Paying Agent in a Member State that will not be obliged to withhold or deduct tax pursuant to the Savings Directive.

On 15 September 2008, the European Commission issued a report to the Council of the European Union on the operation of the Savings Directive, which included the Commission's advice on the need for changes to the Savings Directive. On 13 November 2008 the European Commission published a detailed proposal for amendments to the Savings Directive, which included a number of suggested changes. The European Parliament approved an amended version of this proposal on 24 April 2009. If any of those proposed changes are made in relation to the Savings Directive they may amend or broaden the scope of the requirements described above.

French Taxation

Savings Directive

The Directive has been implemented in French law by article 242 *ter* of the French General Tax Code and articles 49 I *ter* to 49 I *sexies* of the Schedule III to French General Tax Code. article 242 *ter* of the French General Tax Code, which imposes on paying agents based in France an obligation to report to the French tax authorities certain information with respect to interest payments made to beneficial owners domiciled in other Member States, including, among other things, the identity and address of the beneficial owner and a detailed list of the different categories of interest paid to that beneficial owner.

French Withholding Tax

Following the introduction of the Amended Finance Act for 2009, payments of interest and other income made by the Issuer with respect to Notes will not be subject to the withholding tax set out under article 125 A III of the French General Tax Code unless such payments are made outside France in a Non-Cooperative State. If such payments under the Notes are made in a Non-Cooperative State, a 50 % withholding tax will be applicable (subject to certain exceptions and to the more favourable provisions of any applicable double tax treaty) by virtue of article 125 A III of the French General Tax Code.

Furthermore, interest and other income on such Notes will no longer be deductible from the Issuer's taxable income, as from the fiscal years starting on or after 1 January 2011, if they are paid or accrued to persons domiciled or established in a Non-Cooperative State or paid in such a Non-Cooperative State. Under certain conditions, any such non-deductible interest and other income may be recharacterised as constructive dividends pursuant to article 109 of the French General Tax Code, in which case such non-deductible interest and other income may be subject to the withholding tax set out under article 119 *bis* of the French General Tax Code, at a rate of 25% or 50%.

Notwithstanding the foregoing, the Amended Finance Act for 2009 provides that neither the 50% withholding tax nor the non-deductibility rule referred to above will apply in respect of a particular issue of Notes if the Issuer can prove that the principal purpose and effect of such issue of Notes was not that of allowing the payments of interest or other income to be made in a Non-Cooperative State (the **Exception**). Pursuant to the ruling (*rescrit*) no. 2010/11 (FP and FE) of the French tax authorities dated 22 February 2010, an issue of Notes will benefit from the Exception without the Issuer having to provide any proof of the purpose and effect of such issue of Notes, if such Notes are:

- (a) offered by means of a public offer within the meaning of article L. 411.1 of the French Monetary and Financial Code or pursuant to an equivalent offer in a state other than a Non-Cooperative State. For this purpose, an **equivalent offer** means any offer requiring the registration or submission of an offer document by or with a foreign securities market authority; or
- (b) admitted to trading on a regulated market or on a French or foreign multilateral securities trading system provided that such market or system is not located in a Non-Cooperative State, and the operation of such market is carried out by a market operator or an investment services provider, or by such other similar foreign entity, provided further that such market operator, investment services provider or entity is not located in a Non-Cooperative State; or
- (c) admitted, at the time of their issue, to the clearing operations of a central depository or of a securities clearing and delivery and payments systems operator within the meaning of article L. 561-2 of the French Monetary and Financial Code, or of one or more similar foreign depositories or operators provided that such depository or operator is not located in a Non-Cooperative State.

The tax regime applicable to Notes which do not satisfy the conditions mentioned hereinabove will be set out in the relevant Final Terms.

Luxembourg Taxation

The Savings Directive has been implemented in Luxembourg law by a law of 21 June 2005 (the **Luxembourg Law**). Payments of interest may be subject to a withholding tax in Luxembourg in the circumstances set out below.

Individuals

- (a) Luxembourg residents

A 10% withholding tax has been introduced, as from 1 January 2006, on interest payments made by Luxembourg paying agents (defined in the same way as in the Savings Directive) to Luxembourg individual residents.

This withholding tax represents the final tax liability for Luxembourg individual resident taxpayers receiving the interest payment in relation with the management of their private wealth. Luxembourg individual resident taxpayers receiving the interest as business income must include this interest in their taxable income. The 10% withholding tax levied will be credited against their final income tax liability.

(b) Luxembourg non-residents

Subject to the application of the Savings Directive and the Luxembourg Law, there is no withholding tax on payments of interest (including accrued but unpaid interest) made to Luxembourg non-resident Noteholders.

Under the Savings Directive as implemented by the Luxembourg Law a Luxembourg based paying agent (within the meaning of the Directive and the Law) is required since 1 July 2005 to withhold tax on interest and other similar income paid by it to (or under certain circumstances, to the benefit of) an individual or a “residual entity” (within the meaning of the Directive and the Luxembourg Law) resident in another Member State unless the beneficiary of the interest payments opts for the exchange of information in accordance with the Directive and the Luxembourg Law. The same regime applies to interest payments to individuals or residual entities resident in certain associated or dependent territories.

The withholding tax rate is set at 20% as from 1 July 2008 and will increase to 35% as from 1 July 2011. The withholding tax system will only apply during a transitional period, the ending of which depends on the conclusion of certain agreements relating to information exchange with certain other countries.

Corporations

There is no withholding tax for Luxembourg resident and non-resident corporations Noteholders on payments of interest (including accrued but unpaid interest).

SUBSCRIPTION AND SALE

Subject to the terms and on the conditions contained in a dealer agreement dated 29 April 2011 between the Issuer, the Arranger, the Fiscal Agent and the Permanent Dealer (the **Dealer Agreement**), the Notes will be offered by the Issuer to the Permanent Dealer. However, the Issuer will have the right to sell Notes directly on its own behalf to Dealers that are not Permanent Dealers. The Notes may be resold at prevailing market prices, or at prices related thereto, at the time of such resale, as determined by the relevant Dealer. The Notes may also be sold by the Issuer through the Dealers, acting as agents of the Issuer. The Dealer Agreement also provides for Notes to be issued in syndicated Tranches that are jointly and severally underwritten by two or more Dealers.

The Issuer will pay each relevant Dealer a commission as agreed between them in respect of Notes subscribed by such Dealer. The Issuer has agreed to reimburse the Arranger for its expenses incurred in connection with the Programme and the Dealers for certain of their activities in connection with the Programme.

The Issuer has agreed to indemnify the Dealers against certain liabilities in connection with the offer and sale of the Notes. The Dealer Agreement entitles the Dealers to terminate any agreement that they make to subscribe for Notes in certain circumstances prior to payment for such Notes being made to the Issuer.

General

The selling restrictions below may be modified by the Dealer Agreement in particular following a change in a relevant law, regulation or directive. Any such modification will be set out in the Final Terms issued in respect of the issue of Notes to which it relates or in a supplement to this Base Prospectus.

Pursuant to the Dealer Agreement, each Dealer has represented and agreed that it will, to the best of its knowledge, comply with all relevant laws, regulations and directives in each jurisdiction in which it purchases, offers, sells or delivers Notes, or has in its possession or distributes the Base Prospectus, any other offering material or any Final Terms, and neither the Issuer nor any other Dealer shall have responsibility therefore.

European Economic Area

In relation to each Member State of the European Economic Area which has implemented the Prospectus Directive (each, a **Relevant Member State**), each Dealer has represented and agreed, and each further Dealer appointed under the Programme will be required to represent and agree, that with effect from and including the date on which the Prospectus Directive is implemented in that Relevant Member State (the **Relevant Implementation Date**) it has not made and will not make an offer of Notes which are the subject of the offering contemplated by this Base Prospectus as completed by the final terms in relation thereto to the public in that Relevant Member State except that it may, with effect from and including the Relevant Implementation Date, make an offer of such Notes to the public in that Relevant Member State at any time:

- (a) to any legal entity which is a qualified investor as defined under the Prospectus Directive;
- (b) to fewer than 100 or, if the Relevant Member State has implemented the relevant provision of the 2010 PD Amending Directive, 150, natural or legal persons (other than qualified investors as defined in the Prospectus Directive), subject to obtaining the prior consent of the relevant Dealer or Dealers nominated by the Issuer for any such offer;
- (c) if the denomination per Note being offered amounts to at least €100,000; or
- (d) in any other circumstances falling within article 3(2) of the Prospectus Directive,

provided that no such offer of Notes referred to in (a) to (d) above shall require the Issuer or any Dealer to publish a prospectus pursuant to article 3 of the Prospectus Directive, or supplement a prospectus pursuant to article 16 of the Prospectus Directive.

For the purposes of this provision, the expressions:

an offer of Notes to the public in relation to any Notes in any Relevant Member State means the communication in any form and by any means of sufficient information on the terms of the offer and the Notes to be offered so as to enable an investor to decide to purchase or subscribe the Notes, as the same may be varied in that Member State by any measure implementing the Prospectus Directive in that Member State;

Prospectus Directive means Directive 2003/71/EC (and the amendments thereto, including the 2010 PD Amending Directive, to the extent implemented in the Relevant Member State), and includes any relevant implementing measure in the Relevant Member State; and

2010 PD Amending Directive means Directive 2010/73/EC of 24 November 2010.

United States of America

The Notes have not been and will not be registered under the Securities Act may not be offered or sold within the United States or to, or for the account or benefit of US persons except in certain transactions exempt from the registration requirements of the Securities Act. Terms used in this paragraph have the meanings given to them by Regulation S under the Securities Act.

Both (x) Materialised Notes having a maturity of more than one year and (y) Dematerialised Notes in registered form (*au nominatif*) and having a maturity of more than one year are subject to US tax law requirements and may not be offered, sold or delivered within the United States or its possessions or to a United States person, except in certain transactions permitted by US tax regulations. Terms used in this paragraph have the meanings given to them by the US Internal Revenue Code and regulations thereunder.

The Permanent Dealer has agreed that, except as permitted by the Dealer Agreement, it will not offer, sell or deliver the Notes, (i) as part of their distribution at any time and (ii) otherwise until 40 days after the later of the commencement of the offering or the closing date, within the United States or to, or for the account or benefit of, US persons, and it will have sent to each dealer to which it sells the Notes a confirmation or other notice setting forth the restrictions on offers and sales of Notes during the distribution compliance period, as defined in Regulation S under the Securities Act, within the United States or to, or for the account or benefit of, US persons.

In addition, until 40 days after the commencement of the offering of any identifiable Tranche, an offer or sale of Notes within the United States by a dealer that is not participating in the offering) may violate the registration requirements of the Securities Act.

This Base Prospectus has been prepared by the Issuer for use in connection with the offer and sale of the Notes outside the United States. The Issuer and the Permanent Dealer reserve the right to reject any offer to purchase the Notes, in whole or in part, for any reason. This Base Prospectus does not constitute an offer to any person in the United States. Distribution of this Base Prospectus by any non-U.S. person outside the United States to any U.S. person or to any other person within the United States is unauthorised and any disclosure without the prior written consent of the Issuer of any of its contents to any such U.S. person or other person within the United States is prohibited.

United Kingdom

Pursuant to the Dealer Agreement, the Permanent Dealer has represented and agreed that:

- (a) in relation to any Notes which have a maturity of less than one (1) year (i) it is a person whose ordinary activities involve it in acquiring, holding, managing or disposing of investments (as principal or agent) for the purposes of its business, and (ii) it has not offered or sold and will not offer or sell any Notes other than to persons whose ordinary activities involve them in acquiring, holding, managing or disposing of investments (as principal or agent) for the purposes of their businesses or who it is reasonable to expect will acquire, hold, manage or dispose of investments (as principal or agent) for the purposes of their businesses where the issue of the Notes would otherwise constitute a contravention of section 19 of the FSMA) by the Issuer;
- (b) it has only communicated or caused to be communicated and will only communicate or cause to be communicated an invitation or inducement to engage in investment activity (within the meaning of section 21 of the FSMA) received by it in connection with the issue or sale of any Notes in circumstances in which section 21(1) of the FSMA does not apply to the Issuer; and

As used in this paragraph, resident of Japan means any person resident in Japan, including any corporation or other entity organised under the laws of Japan.

France

Pursuant to the Dealer Agreement, the Permanent Dealer has represented and agreed that (i) it has not offered or sold and will not offer or sell, directly or indirectly, Notes to the public in the Republic of France (*offre au public*), and (ii) has not distributed or caused to be distributed and will not distribute or cause to be distributed to the public in the Republic of France, this Base Prospectus or any other offering material relating to the Notes.

Italy

- (a) to qualified investors (*investitori qualificati*), including individuals and small and medium size enterprises, as defined by CONSOB Regulation no. 11971 of 14 May 1999, as amended from time to time and recently supplemented by resolution n. 17326 of 13 May 2010, on the basis of the relevant criteria set out by the Prospectus Directive, pursuant to art. 100, paragraph 1, lett. a) of D.Lgs. no. 58 of 24 February 1998, as amended (the **Consolidated Financial Act**); or
