The return on the Certificates also factors in a net financing cost which may be positive or negative and which is made up of the proceeds that the Issuer may receive through its hedge in depositing in the Reference Currency for the Certificates, minus (i) any associated borrowing costs in the Base Currency, and (ii) a variable charge for arranging the Certificates.
