The value of the Certificates should rise if the Base Currency appreciates relative to the Reference Currency. An investor's exposure to the Reference Asset will be amplified (leveraged) because part of the exposure to the Reference Asset will effectively be financed by the Issuer itself. The Certificates will redeem automatically if the spot price of the Reference Asset falls to, or below a specified price. Otherwise, the Certificates are redeemable annually by investors and daily from the Issue Date by the Issuer.
