The value of the Certificates should rise if the Base Currency appreciates relative to the Reference Currency. An investor's exposure to the Reference Asset will be amplified (leveraged) because part of the exposure to the Reference Asset will effectively be financed by the Issuer itself. The return on the Certificates also factors in a net financing cost which may be positive or negative and which is made up of the proceeds that the Issuer may receive through its hedge in depositing in the Base Currency and (ii) a variable charge for arranging the Certificates.
