This inverse exposure to the Reference Asset (typically referred to as short exposure) may be amplified (leveraged) in certain circumstances. The Certificates will redeem automatically if the spot price of the Reference Asset rises to, or above a specified price. Otherwise, the Certificates are redeemable annually by investors and daily from the Issue Date by the Issuer.
