This inverse exposure to the Reference Asset (typically referred to as short exposure) may be amplified (leveraged) in certain circumstances. The return on the Certificates also factors in a net financing cost which may be positive or negative and which is made up of the proceeds that the Issuer may receive through its hedge in depositing in the Reference Currency for the Certificates, minus (i) any associated borrowing costs in the Base Currency, and (ii) a variable charge for arranging the Certificates. This net financing cost will accrue daily and be added to, or deducted from, as the case may be, the amount payable to investors on redemption of the Certificates.

The Certificates will redeem automatically if the spot price of the Reference Asset rises to, or above a specified price. Otherwise, the Certificates are redeemable annually by investors and daily from the Issue Date by the Issuer.

The amount payable on redemption of the Certificates will be determined by reference to the spot price of the Reference Asset, the outstanding financed amount, the Security Ratio and the prevailing Settlement Conversion Rate (such terms are defined above).

The maximum loss for an investor in respect of each Certificate is limited to the purchase price of the Certificate.
