The value of the Certificates should rise if the Base Currency appreciates relative to the Reference Currency. The amount payable on redemption of the Certificates will be determined by reference to the spot price of the Reference Asset, the outstanding financed amount, the Security Ratio and the prevailing Settlement Conversion Rate (such terms are defined above).

The maximum loss for an investor in respect of each Certificate is limited to the purchase price of the Certificate.
