An investor's exposure to the Reference Asset will be amplified (leveraged) because part of the investment in the Reference Asset will effectively be financed by the Issuer itself. Another effect of this Issuer financing is that the purchase price of the Securities will always be less than a corresponding direct investment in the Reference Asset. The Issuer will charge a variable financing cost for providing the financing. This financing cost will accrue daily and be deducted from the amount payable to investors on redemption of the Securities .

The Securities will redeem automatically if the value of the Reference Asset falls to, or below, a specified price. Otherwise, the Securities are redeemable annually by investors and daily by the Issuer in accordance with the terms set out above.
