This document constitutes the final terms of the Securities (the "**Final Terms**") described herein for the purposes of Article 5.4 of Directive 2003/71/EC (the "**Prospectus Directive**") and is prepared in connection with the Global Structured Securities Programme established by Barclays Bank PLC (the "**Bank**") and Barclays Capital (Cayman) Limited ("**BCCL**") and is supplemental to and should be read in conjunction with the Base Prospectus dated 5 August 2011, as supplemented and amended from time to time, which constitutes a base prospectus (the "**Base Prospectus**") for the purpose of the Prospectus Directive. An investor's exposure to the Reference Asset will be amplified (leveraged) because part of the exposure to the Reference Asset will effectively be financed by the Issuer itself. The return on the Certificates also factors in a net financing cost which may be positive or negative and which is made up of the proceeds that the Issuer may receive through its hedge in depositing in the Base Currency for the Certificates, minus (i) any associated borrowing costs in the Reference Currency, and (ii) a variable charge for arranging the Certificates. This net financing cost will accrue daily and be added to, or deducted from, as the case may be, the amount payable to investors on redemption of the Certificates.
