Another effect of this Issuer financing is that the purchase price of the Securities will always be less than a corresponding direct investment in the Reference Asset. The Issuer will charge a variable financing cost for providing the financing. This financing cost will accrue daily and be deducted from the amount payable to investors on redemption of the Securities .

The Securities will redeem automatically if the value of the Reference Asset falls to, or below, a specified price. Otherwise, the Securities are redeemable annually by investors and daily by the Issuer in accordance with the terms set out above.
