1) ADDITIONAL INFORMATION ABOUT NISSAN

This amendment expands on the information about the remuneration of the Chairman and CEO of Renault SA contained in the Registration Document of Renault SA for the year ending December 31, 2010, which was filed with the Autorité des Marchés Financiers on March 29, 2011 under No. D.11-0190. In particular, it adds a new section detailing the remuneration of the President and Chief Executive Officer of Nissan.

In consequence, the Chapter 3.3.2.2 of the Registration Document, “Remuneration of the Senior Executive Director”, has been amended as follows :
