There has been no significant change in the trading or financial position of the Group taken as a whole since 30 June 2011 (the end of the last financial period for which either audited financial information or interim financial information has been published).

Save in relation to matters referred to on pages 42 to 43 of the 2011 RBS Holdings Interim Results, relating to the Group's exposure to Greek sovereign debt, which the Group has made provision for therein, there has been no material adverse change in the prospects of the Group taken as a whole since 31 December 2010 (the last date to which the latest audited published financial information of the Group was prepared).

APPENDIX

INDEX DESCRIPTION - RBS Vastgoed PR Index

1. Definitions:

“**Business Day**” means a day on which commercial banks in London and New York are usually open for business to the public and settle payments;

“**Exchange**” means Eurolist by Euronext Amsterdam;

“**Index Calculator**” means, Standard & Poor’s, 55 Water Street, New York, NY 10041 or its successor;

“**Index Launch Date**” means 26 October 2005;

“**Market Disruption Event**” means

- General moratorium in respect of banking activities in the country in which the Exchange is located; or
- Governmental Default with respect to any security or indebtedness for money borrowed or guaranteed by any Governmental Authority, there occurs a default, event of default or other similar condition or event (howsoever described) including, but not limited to, (A) the failure of timely payment in full of principal, interest or other amounts due (without giving effect to any applicable grace periods) in respect of any such security indebtedness for money borrowed or guarantee, (B) a declared moratorium, standstill, waiver, deferral, repudiation or rescheduling of any principal, interest or other amounts due in respect of any such security, indebtedness for money borrowed or guarantee or (C) the amendment or modification of the terms and conditions of payment of any principal, interest or other amounts due in respect of any such security, indebtedness for money borrowed or guarantee without the consent of all holders of such obligation. The determination of the existence or occurrence of any default, event of default or other similar condition or event shall be made without regard to any lack or alleged lack of authority or capacity of such Governmental Authority to issue or enter into such security, indebtedness for money borrowed or guarantee; or
- Nationalisation. “**Price**” means the last traded price on the Exchange on the respective Trading Day;

“**Re-weighting Date**” means the date of the re-weighting of the RBS Vastgoed PR Index, subject to a Market Disruption Event;

“**Settlement Currency**” means EUR;

“**Share**” means each ordinary share of the Share Company;

“**Share Company**” means each company, which is included in the RBS Vastgoed PR Index;

“**Trading Day**” means any day that is a trading day on the Exchange for the RBS Vastgoed PR Index other than a day on which trading on the Exchange is scheduled to close prior to its regular weekday closing time.

2. General description

The index (“**RBS Vastgoed PR Index**”) is price weighted and tracks 4 companies that operate in the real estate sector (Euronext sector code 86) and that are listed on Eurolist by Euronext Amsterdam. The RBS Vastgoed PR Index is a price index, which entails that it will not reinvest any dividends.

3. RBS Vastgoed PR Index Composition

As of 6 June 2012 the RBS Vastgoed PR Index comprised the shares (the “**Shares**”) of the following 4 companies (each a “**Share Company**” and together “**Share Companies**”) as selected by the Index Calculator on the Index Launch Date.

The RBS Vastgoed PR Index was proportionally weighted based on the Price of the Shares on the Index Launch Date. The RBS Vastgoed PR Index shall comprise at any time of at least 3 Share Companies and ceases to exist if there are less than 3 Share Companies in the RBS Vastgoed PR Index.

4. RBS Vastgoed PR Index Method of Calculation

On the Index Launch Date the Initial RBS Vastgoed PR Index Value was EUR 275.08 (“**Initial Index Value**”). Thereafter, the value of the RBS Vastgoed PR Index (“**Index Value**”) will be calculated real-time and disseminated via Reuters in 15 second intervals, subject to a Market Disruption Event, according to the following formula:

$$\text{Index Value}_t = \sum_{i=1}^N (\text{Number of Shares})_{i,t} \times (\text{Price})_{i,t}$$

If, in the determination of the Index Calculator, a Market Disruption Event has occurred on any Business Day, the Index will be calculated and published by the Index Calculator on the first succeeding Business Day, on which the Calculation Agent determines that there is no Market Disruption Event, unless the Index Calculator determines that there is a Market Disruption Event occurring on each of the five Business Days immediately following the original Business Day on which (but for the Market Disruption Event) the Index would have been calculated and published by the Index Calculator. In that case (regardless of the Market Disruption Event) the Index Calculator shall determine the Price of the Share affected by the Market Disruption and the Index Value having regard to the then prevailing market conditions, the last reported trading price of the respective Shares and such other factors as the Index Calculator determines to be relevant.

5. Re-weighting of the RBS Vastgoed PR Index

The RBS Vastgoed PR Index shall be re-weighted in the event that, due to a corporate action like a merger, bankruptcy or acquisition, a Share Company no longer forms part of the RBS Vastgoed PR Index. The remaining Shares shall be proportionally based on their Price on such day.

$$(\text{Index Value})_{\text{before rebalance}} = (\text{Index Value})_{\text{after rebalance}}$$

If, in the determination of the Index Calculator, a Market Disruption Event has occurred on any Re-weighting Date, the Re-weighting shall be postponed to the first succeeding Trading Day on which the Calculation Agent determines that there is no Market Disruption Event, unless the Index Calculator determines that there is a Market Disruption Event occurring on each of the five Trading Days immediately following the original date which (but for the Market Disruption Event) would have been a Re-weighting Date. In that case (i) the fifth Trading Day shall be deemed to be the Re-weighting Date (regardless of the Market Disruption Event); and (ii) the Index Calculator shall determine the Price of the Share affected by the Market Disruption and the Index Value having regard to the then prevailing market conditions, the last reported trading price of the respective Shares and such other factors as the Index Calculator determines to be relevant.
