This document constitutes the final terms of the Securities (the "**Final Terms**") described herein for the purposes of Article 5.4 of Directive 2003/71/EC (the "**Prospectus Directive**") and is prepared in connection with the Global Structured Securities Programme established by Barclays Bank PLC (the "**Bank**") and Barclays Capital (Cayman) Limited ("**BCCL**") and is supplemental to and should be read in conjunction with the Base Prospectus dated 14 June 2012, as supplemented and amended from time to time, which constitutes a base prospectus (the "**Base Prospectus**") for the purpose of the Prospectus Directive. The product is issued as Certificates in EUR and aims to provide exposure to the performance of the Reference Asset. An investor's exposure to the Reference Asset will be amplified (leveraged). The return on the Securities factors in a variable charge for arranging the Securities which will accrue daily and will be deducted from the amount payable to investors on redemption of the Securities.

The Securities will redeem automatically if the value of the Reference Asset falls to, or below, a specified price. Otherwise, the Securities are redeemable annually by investors and daily by the Issuer in accordance with the terms set out above.
