The return on the Securities factors in a variable charge for arranging the Securities which will accrue daily and will be deducted from the amount payable to investors on redemption of the Securities.

The Securities will redeem automatically if the value of the Reference Asset rises to, or above, a specified price. Otherwise, the Securities are redeemable annually by investors and daily by the Issuer in accordance with the terms set out above.
