This document constitutes the final terms of the Securities (the "**Final Terms**") described herein for the purposes of Article 5.4 of Directive 2003/71/EC (the "**Prospectus Directive**") and is prepared in connection with the Global Structured Securities Programme established by Barclays Bank PLC (the "**Bank**") and Barclays Capital (Cayman) Limited ("**BCCL**") and is supplemental to and should be read in conjunction with the Base Prospectus dated 14 June 2012, as supplemented and amended from time to time, which constitutes a base prospectus (the "**Base Prospectus**") for the purpose of the Prospectus Directive. The description below represents a summary only of some of the features of the investment product described in these Final Terms. It does not purport to be an exhaustive description.

The product is issued as Certificates in EUR and aims to provide a positive return if the price of the Reference Asset falls over the investment period and conversely, a negative return if the price of the Reference Asset rises over the investment period. This inverse exposure to the Reference Asset (typically referred to as “short exposure”) may be amplified (leveraged) in certain circumstances. The return on the Securities factors in a variable charge for arranging the Securities which will accrue daily and will be deducted from the amount payable to investors on redemption of the Securities.

The Securities will redeem automatically if the value of the Reference Asset rises to, or above, a specified price. Otherwise, the Securities are redeemable annually by investors and daily by the Issuer in accordance with the terms set out above.

The amount payable on redemption of the Securities will be determined by reference to the value of the Reference Asset, the outstanding financed amount, the Security Ratio and the prevailing Exchange Rate (such terms are defined above). As a result, an investor in these Securities is also exposed to fluctuations in the Exchange Rate.
