This document constitutes the final terms of the Securities (the "**Final Terms**") described herein for the purposes of Article 5.4 of Directive 2003/71/EC (the "**Prospectus Directive**") and is prepared in connection with the Global Structured Securities Programme established by Barclays Bank PLC (the "**Bank**") and Barclays Capital (Cayman) Limited ("**BCCL**") and is supplemental to and should be read in conjunction with the Base Prospectus dated 14 June 2012, as supplemented and amended from time to time, which constitutes a base prospectus (the "**Base Prospectus**") for the purpose of the Prospectus Directive. The product is issued as Certificates in EUR and aims to provide a positive return if the spot price of the Reference Asset (being the EUR/GBP exchange rate (the "**Exchange Rate**") expressed as the amount of GBP (the "**Reference Currency**") equivalent to 1 unit of EUR (the "**Base Currency**") falls over an investment period and conversely, a negative return if the spot price of the Reference Asset rises over an investment period. This inverse exposure to the Reference Asset (typically referred to as short exposure) may be amplified (leveraged) in certain circumstances. The return on the Certificates also factors in a net financing cost which may be positive or negative and which is made up of the proceeds that the Issuer may receive through its hedge in depositing in the Reference Currency for the Certificates, minus (i) any associated borrowing costs in the Base Currency, and (ii) a variable charge for arranging the Certificates. This net financing cost will accrue daily and be added to, or deducted from, as the case may be, the amount payable to investors on redemption of the Certificates.
