The product is issued as Certificates in EUR and aims to provide a positive return if the spot price of the Reference Asset (being the EUR/USD exchange rate (the "Exchange Rate") expressed as the amount of USD (the "Reference Currency") equivalent to 1 unit of EUR (the "Base Currency")) falls over an investment period and conversely, a negative return if the spot price of the Reference Asset rises over an investment period. This inverse exposure to the Reference Asset (typically referred to as short exposure) may be amplified (leveraged) in certain circumstances. The return on the Certificates also factors in a net financing cost which may be positive or negative and which is made up of the proceeds that the Issuer may receive through its hedge in depositing in the Reference Currency for the Certificates, minus (i) any associated borrowing costs in the Base Currency, and (ii) a variable charge for arranging the Certificates.
