The product is issued as Certificates in EUR and aims to provide a positive return if the spot price of the Reference Asset (being the EUR/JPY exchange rate (the "Exchange Rate") expressed as the amount of JPY (the "Reference Currency") equivalent to 1 unit of EUR (the "Base Currency")) falls over an investment period and conversely, a negative return if the spot price of the Reference Asset rises over an investment period.
