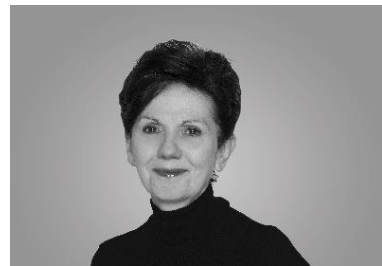
At today's Shareholders' Meeting, Françoise Leroy was re-elected as a member of the Supervisory Board for a term of four years.
