Euronext announces completion of share repurchase programme as part of its Long-Term Incentive plan

Amsterdam, Brussels, Dublin, Lisbon, Milan, Oslo and Paris - 7 July 2023 - Euronext, the leading pan-European market infrastructure, today announced that it has completed the repurchase of 330,000 of its own shares at an average price of €63.77.

This repurchase programme was carried out within the scope of the Euronext Long-Term Incentive plan by an independent agent from 12 June 2023 to 7 July 2023 and in accordance with the conditions of the authorisation granted by the General Meeting of Shareholders of Euronext on 17 May 2023.
