Medincell: Notice of the 2025 Annual General Meeting Published

Medincell's combined annual general meeting (ordinary and extraordinary) will be held on September 11, 2025, at 6pm at the Company's headquarters.

The resolutions proposed for voting at the General Assembly include:

- Approval of the parent company and consolidated financial statements for the 2024-2025 fiscal year and allocation of the result;
- Election of new independent board members, seasoned professionals in the pharmaceutical field: Ms. Sharon Mates, Mr. Charles Kunsch, and Mr. Pascal Touchon;
- Approval of existing related-party agreements;
- Approval of executive compensation elements, including the budget allocated to Board of Directors' remuneration, which has been revised this year to reflect:
 - The transition from a governance structure based on a Supervisory Board and Management Board to a Board of Directors, resulting in a significant increase in workload and responsibilities for its members,
 - The expansion of the Board (with the addition of two seats and one non-voting observer position),
 - The creation of new specialized committees requiring greater involvement from directors;
- Approval of executive compensation policies;
- Delegations granted to the Board of Directors to carry out, if necessary, capital increases or reductions, share cancellations, or issuance of securities granting access to capital.

The procedures for participating in the general meeting, as well as those for electronic or postal voting, are detailed in the notice brochure.

All documentation relating to the general meeting will be made available on the Company's website on August 21, 2025.

Our innovative treatments aim to guarantee compliance with medical prescriptions, to improve the effectiveness and accessibility of medicines, and to reduce their environmental footprint. They combine active pharmaceutical ingredients with our proprietary BEPO® technology which controls the delivery of a drug at a therapeutic level for several days, weeks or months from the subcutaneous or local injection of a simple deposit of a few millimeters, entirely bioresorbable. The first treatment based on BEPO® technology, intended for the treatment of schizophrenia, was approved by the FDA in April 2023, and is now distributed in the United States by Teva under the name UZEDY® (BEPO® technology is licensed to Teva under the name SteadyTeq™). We collaborate with leading pharmaceutical companies and foundations to improve global health through new treatment options. Based in Montpellier, Medincell currently employs more than 140 people representing more than 25 different nationalities.
